

Money Is Only Part of Retirement Formula

Quick, tell me the first thing that comes to mind when I say the words "retirement" and "anxiety: Take a second and jot it down. Done? Good.

Based on years of writing on the topic, and multiple surveys that have been carried out by professionals far more knowledgeable than myself, I'd be willing to bet most responses have something to do with money or how you'll be able to make ends meet in retirement.

That's what a survey by Merrill Lynch and AgeWave found. A full 38% of preretirees said that "what they would miss the most" in retirement was a "reliable income." That was more than twice the second-place response.

However, when those same surveys were given to those already in retirement, something different popped up as the top thing they missed about work: social connections. Here's what the Merrill Lynch/AgeWave numbers looked like:

• Social connections: 34% • Reliable income: 29%

Having purpose and work goals: 19%

• Mental stimulation: 12%

• *Employer health insurance:7%*

If you step back and think about it, this should come as no surprise. We humans are social creatures, and it is through social connections that we find meaning. Between them, social connections and "having purpose" account for what over half of retirees say they miss most.

So it's important that today's pre-retirees start taking the right steps now to ensure that they'll be able to afford and enjoy their retirement.

HOW TO PREPARE

Wes Moss, chief investment strategist for Capital Investment Advisors and host of the Money Matters radio show, has devoted his career to finding the answer to such questions. In his book You Can Retire Earlier Than You Think, he offers some guidance.

Moss highlights the importance of having what he calls "core pursuits" activities that actively engage you, are intrinsically rewarding (we're not talking about money here) and help give meaning to your life. You need not be a retiree to have core pursuits. In fact, our teenage years are largely defined by them.

What Moss has found is that those who are happiest in retirement have an average of 3.6 core pursuits when they enter retirement. On average, those who are unhappy have less than two.

And that last part - "when they enter retirement" - is key. It is a reminder that if we spend our 20s through our 60s with our heads buried in work and we neglect all that is around us - our relationships, our health, our spirituality, our interests, etc. - we are setting ourselves up to spend the last few decades of our lives unhappy.

Just as someone who starts saving for retirement at 60 is highly unlikely to reach their goals, if you wait until retirement to start exploring core pursuits, you'll have a much harder time finding what you're looking for.

AND FOR THOSE STILL WORRIED ABOUT FINANCES

Moss has also done research on how much money the typical "happy" retired household has saved up compared with the "unhappy" ones.

While it's possible to retire happily on very little income, those who have a nest egg of about \$450,000 or more tend to be the happiest. That's not an enormous sum, especially considering that many personal-finance experts say you need to amass at least \$1 million to retire in comfort. However, it seems that for many retirees, it's enough to grant some financial security and pursue the activities they love.





Motion #1: Director Jim Worley moved to post the following updates to the Rules & Regulations Section 9.1.3., to match the Standard Operating Procedures and what is currently happening at the main office. The Current Language: "Associate Members are required to pay their dues and fees for the entire year. The New language: "Associates dues and fees may be paid on an annual basis (by January 31st), or semi-annual basis (half by January 31st and half by July 31st)". Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion to post changes carried.

Motion #2: Director Jim Worley moved to post the following updates to the Rules & Regulations Section 13.8, to match what is the current rules at RV Park. The Current Language is: "RV units must be parked centered side to side in RV space and nothing may be stored within <u>two</u> feet of the fence". The New language: "RV units must be parked centered side to side in RV space and nothing may be stored within four feet of the fence". Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion to post changes carried.

Motion #3: Director Jim Worley moved to post deletions of the word "package" from Section 9.2.4, to take confusion away from Golf and the Golf Only package and to change the word "of" to "or" in the Rules & Regulations "a partial medical refund may be given upon written request by a member or associate under the rules of this Section for "Golf only package" if there is a written medical excuse from a qualified medical doctor posted 11/24/2015. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion to post changes carried.

Motion #4: Director Jim Worley moved that Standard Operating Procedures manual (SOP) be divided into two sections. The following statement would be on the forward page Section 1 being "Standard Operating Procedures for the Association" is not posted but is open to the Board Chairs and their Committees and the Public as needed, this Section ends after Section 5 "Business Solicitations and Advertising". Section 2 will remain as the "private side", being "operating procedures" known to the Board Officers, General Manager, Office Manager and Maintenance in their day-to-day operations, this section starts with Section 6 "Office Procedures". Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried.

Motion #5: Director Jim Worley moved to create a permanent standing committee called the "Technology Committee, which will include 5 voting members and up to 2 non-voting advisors for the Standard Operating Procedures. The 2 non-voting members of the Committee are the General Manager and the President of the Association. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried.

Motion #6: Director Jim Worley moved to post the following changes to the Bylaws: that all references to the "Initiation Fee" to the "Working Capital Fee". Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion to post changes carried.

Motion #7: Director Jim Worley moved to post the Bylaws addition of the "Reserve Fund" language, Section 5.9 of the Bylaws, "Limitations of Powers of Directors Special Requirements as attached, 5.9.6 "Reserve Fund". The Reserve Fund is a Board controlled Fund consistent with the ByLaws the Reserve Fund receives 100% of the "Working Capital Fee", is used solely for expenses for Common Area, Major Repairs, Budgeted Capital Expenditures or Emergencies. It will not be used for day-to-day operations or maintenance. The Board of Directors is responsible for preserving the physical plant and capital equipment by anticipating new or replacement equipment, major repairs or new construction and setting aside funds to protect the Corporation against "Unforeseen Catastrophic Losses". The Reserve Fund will be maintained at a minimum balance of \$250,000 to meet those needs. The effective balance of the Reserve Fund beyond the \$250,000 (lower limit), will be determined by updating annually. Reserve Study that includes for consideration those Capital Improvements, Replacement and repairs of \$1,000 or more, or for any single expenditure, the period of time to be considered in the Reserve Study will be from 2-30 years, consideration will be given to current replacement costs eliminating remaining useful life at the rate of inflation. The Reserve Study will be brought up to date each year concurrent with the annual budget process and prior to the first meeting of the Budget Committee. The Disbursement from the Reserve Fund including earned interest income are made by transferring the approved payment from the Reserve to the General Fund. All disbursements to vendors will be made through the General Fund. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion to post changes carried.

Motion #1: Director Larry Jones moved for acceptance of the bid selected from 3 bids to erect the Golf Equipment Building, which includes electrical, permits and prepping. Therefore I am asking the BOD to approve the budget of \$43,000 and it's our hope that we can bring it in for less. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried.

Motion #2: Director Larry Jones: Of the 5 bids received for the sound-proofing of the conference room, I move that we accept the bid from "Sly's Drywall for \$3,950, as well as an additional \$1,550 for a total budget of \$5,500, to cover electrical work and paint to complete. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried.

Motion #3: Director Larry Jones: There are 2 AC units on top of the Auditorium that need replacing, one unit is out and the other is limping as it was installed in 1982, we have \$7,000 in budget. Out of 3 bids, I make the motion that we accept the bid to replace both units from Wolfer's for \$19,010. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried.

Motion #1: Director Allan Lindberg moved to approve the following members to the Technology Committee: Manny Liitwak, Ron Ewing, Stan Hiller, Walt VanRheen as available, myself as Chairperson, and Madam President and the General Manager as advisors. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried.

Motion #2: Director Allan Lindberg moved to approve spending \$2,225 to cover the cost of a copyright for "Woodburn Estates & Golf "and "Woodburn Estates & Golf "logo. The \$225 being the cost of the registration fee for each and the \$2,000 covering the cost of legal fees. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried.

Motion #3: Director Allan Lindberg moved to approve the payment plans from Executive Session. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried.

BOARD COMMITTEE REPORTS

General Managers Report – GM Tom Staskiewicz: It's been a busy month at Woodburn Estates & Golf. We kicked off with the New Member Meeting conducted by Sharon Schaub on March 5th, which was well attended. The directors and club chairs provided the new members with a lot of information on the various activities and they had the opportunity to receive answers to several questions about their new home. I have been spending a lot of time going over our Reserve Study, Budget and Funding process to ensure your assets are being protected and properly maintained. The Reserve process attempts to project our repair and replacement costs for the next 30 years - a daunting process the further out we attempt to project. Did you know each household has over a \$3,500 in common building value alone as part of your ownership? That's just buildings, not the golf course, equipment or anything else. One of the things I learned was the concept of the Reserve process was legislated on October 23, 1999, for all new Planned Unit Developments (PUDs) and Home Owners Associations (HOAs) for condominium projects. As part of the legislation existing PUDs and HOAs were not required to have a reserve study or reserve budget. Fortunately your Boards, over the years, have recognized the importance and been meeting that requirement for a long time. As you will hear in a motion today, your current board has recognized we need to make this a more significant part of our documents and it is being added to the Bylaws. We will be posting the proposed change today and the board will vote to accept the change next month. This is an important addition to our documents so you, our members, know that a future board cannot bypass the requirement. I have also been working on our insurance to ensure we are adequately covered and have the proper liability coverage. We are a growing organization and as such we become a larger target. We need to have the proper coverage to protect our owners. Another step we will be taking is to put into our budget a reserve to set aside money for any insurance deductibles we could incur from our policies. This is precautionary but adding it to the budget and therefore planning accordingly reduces the potential of not having the money available when needed. This is just the tip of the iceberg, please read the articles in the News & Views and Facebook to stay current on what is happening. I have had many opportunities to sit in on committee meetings and watching your dedicated members make huge contributions to making Woodburn Estates & Golf a better place. I appreciate and applaud all of our volunteers for their efforts on your behalf.

Architectural – Director Jim Taylor: Since the Board of Directors meeting in February there have been 16 Architectural Requests and 13 Compliance Requests.

RV Lot – Director Jim Taylor: Recently, a couple was locked in the RV lot when they remained inside after the vehicle and personnel gates automatically locked at the winter hour's closure time of 8:00 pm. RV Lot gate operation times do not revert to summer hours until April 15.

Activities - Director Malena Turner: The Activities Committee met on March 3, 2016 in the Conference Room and the meeting was called to order by Malena Turner, Activities Director at 11:07 am. The following members were present: Rita Girard, Mary Danielson, Jan Robarge, and Nancy Reed. Arlene Langendoerfer was absent with notice. General Manager Tom and Diana Lindberg were also present. Diana talked about the car show she is working on and informed us we were welcome to attend the planning meeting March 7, 2016. Nancy Reed gave the Treasurer's report with the balance as of February 29, 2016 of \$14,512.64. The minutes of February 4th meeting were read by Rita Girard. The upcoming March 19th Potato Bash was discussed. Everything was in place for this event. A discussion was held regarding the April 23rd Pancake Breakfast. Mary Danielson had a poster created by the Marketing Committee and will talk to Stan Hiller regarding some changes she would like made. Mary expressed concerns that she would be unable to take charge of the volunteers plus her duties as Chairman and Rita assured her that she would be available for set up on the Friday before the Event. She would be there Saturday to give the volunteers their assignments.

Pro Shop Report by Chuck Siver: Getting ready for tournaments and researching different apparel options. GM Report by Tom Staskiewicz: Tom addressed getting sponsors for the tournaments. There was talk about having sponsors for some or all of the holes. He was also working with the Chamber to bring their annual tournament to WEG this May. Tom is still working out the details. Walt VanRheen wanted to know when the audio system would be needed in the gazebo. He will test the system for functionality and readiness prior to May 1st. New Business: Chuck brought up that some of the signs relating to no trespassing, etc., were blocked by cars in the parking lot. After some discussion, it was determined rather than to remove valuable parking spaces, the signs need to be moved back so that they are more visible. The drainage issues near the pro shop. Tim will look into possible broken drain tiles. More drainage issues around the left path on #1. Stop signs were also discussed for the golf carts at the crossings of Hayes, Rainier, and King Way. These signs should also note that the carts do not have right of way. Tim remembers that we once had Stop signs up and will look to see if he can find them to see how man we have. House – Director Larry Jones: We have had two house committee meetings this month. We have been working on moving our projects from the drawing board to the final product. The first job we tackled is the Storage Building for the Golf equipment. We compared the 3 bids received to try to arrive at what bid was going to serve us best. We looked at the other costs involved from the site work, the building permits and the electrical costs from PGE and electrical contractors to get power to the building and the installation of lights and electricity. It was also suggested that we check pricing to add translucent panels to the back wall for natural lighting. PGE surprised us with a cost of approximately \$10,000 to move a transformer from its present location to a new location. We are looking into this right now. I want to thank Walt VanRheen for his hard work on this project and I will present a motion to the Board of Directors to fund this job. The House Committee is also working on upgrading the Auditorium to be ADA compliant.

We are working at this time with the City of Woodburn and an Architect to find out what will be needed to comply with the various agencies to meet the requirements to do the job right. Dawn

Board Minutes (Cont.)

R. Cole has been contacting contractors to get bids to bring the windows in the Swimming Pool Building up to current codes with shatter-proof glass. We hope that we can have this on the next agenda. The Office Remodel is going to proceed per the suggestion of Tom Staskiewicz on a much smaller scale than previously planned. With this in mind we will be putting in a lot of work to complete the job and save the Association money. This can help us pay on some jobs that may cost us more than allotted. It is our hope that we can find savings to help us spend our money wisely. With the amount of work that we have it was suggested that we check with Energy Trust of Oregon to see if there are any rebates available for the work that we are planning to do. We will investigate and make sure that we do not miss any opportunity to capture any savings. The House Committee has been working with Tom Staskiewicz and Frank Jameson to replace the air conditioners on the Auditorium Roof. One unit is no longer working and the other unit was installed around 1981. We hope to have the pricing put together to put a motion before the Board in today's meeting. The House Committee is still working to get the soundproofing of the walls in the conference room finished. Just received our third bid to get this job finished up. I will be presenting this to the Board for funding.

Membership – Director Sharon Schaub: The committee held its first New Member Welcome & Orientation since August 2015 on Saturday, March 5, 2016. The Committee planned and organized the meeting by hand-delivering personal invitations to all new members. The event was attended by Board members and a few individual members wanting to welcome our new members. Each board member and the general manager was introduced and had the opportunity to explain their particular board position and the responsibilities of the position. The new members that were unable to attend will receive the Welcome & Orientation folders which will be hand-delivered by the committee. The Committee will be planning the next New Member Welcome & Orientation next month to welcome the approximate 25+ new members. Thank you to the Committee Members for all their many volunteer hours and commitment in making the first New Member Welcome & Orientation of 2016 a success.

Real Estate – Director Sharon Schaub: Twenty-Nine home sales have been reported by the office since the beginning of 2016. The dollar amount equals \$4,328,000 in sale prices. Averaging out to approximately \$149.2K per house. The office reports 13 sales are pending as of this date.

Marketing – Director Stan Hiller: We ran ads in Canby, Newberg, and NW 50 Something. The NW 50 Something was an insert in the most recent issue of the Woodburn Independent.

News & Views – Director Stan Hiller: Last month a member chastised the editor for not printing Coffee Hour articles in the News & Views. Because they did not submit reports, Coffee Hour missed 17 out of 30 newspapers and they missed having their monthly schedule printed 3 times since January of 2015 due to not supplying it to the paper. Kathy Hiller and Ken Leonard get credit for 25 papers with centerfold pages with articles to go with the pictures. As I reported last month, and I quote "be the reporter for your group and send in those articles and be sure to take pictures too". The Editor is not an event reporter. A suggestion would be to have the Activities Director assign a person or persons to write articles and take pictures of all events and that includes Coffee Hour.

Web – Director Stan Hiller: January's web users totaled 950 and February had 887 users. Last month we started a new web page titled "Golf Events". This page is slowly maturing as I get this year's registration forms on-line for the golfing community. These golf events are those that require a sign-up form to be filled out. We are still adding new items and photos on Facebook. We are evaluating where to put Facebook on our web page. The Voodoo Dance and Potato Bash are the recent items on our website.

Rules & Regulations/CC&R's – Director Jim Worley: Currently we have eight open complaints. Four are legal matters at this time which means we cannot do anything further until the issues are resolved. Unfortunately this often takes quite some time to accomplish. We do actively work the complaints within 2-3 days of receiving them.

The Reserve, Part IV

To recap: In recent issues of the *News & Views* I have discussed the Reserve, The Reserve Study and The Reserve Budget. In this article, I discuss the Reserve Fund.

What Is the Reserve Fund?

The Reserve Fund is a separate account; not to be confused with our operating account used for our day-to-day expenses.

Funding the Reserve Fund

There are three methods for funding the Reserve:

- 1. Annual assessments on home owners;
- 2. Special assessments; or
- 3. An assessment collected on home purchases or title transfers.

Several years ago, probably when The Reserve was first enacted for Woodburn Estates & Golf, the Board made the decision to fund the majority of The Reserve from fees collected from new owners when they purchase a home. As I listen to other HOA managers and learn of their problems with capital spending and their method of funding their reserves, we are fortunate to have had a Board with such wisdom and foresight.

Over the years the Working Capital Fee assessed on new home sales has increased as costs have increased. This fee is set forth in our By-laws; \$2000.00 is the current maximum and the amount we are assessing on a new owner.

Currently we are sitting in a relatively strong position with over \$1 million in the Reserve Fund. However, this doesn't mean we should become complacent or overly confident. Based upon our average spending level over the past four years; \$1 million is about three years of Reserve spending.

To avoid the need for special or reserve assessments, the Board must be vigilant in ensuring the Working Capital Fee collected on home sales is set properly to continue meeting the asset repair/replacement needs of Woodburn Estates & Golf.

Remember increasing the Working Capital Fee is not an assessment on current homeowners; it is an assessment on the new owners who will benefit from the improvements.




