Applying Our Documents

have had some questions recently on our Documents – CC&Rs, By-laws and Rules Regs – and how they apply relative to Local, State and Federal Regulations. I will use some examples in an attempt to clarify the issue.

Example 1: Woodburn has a building code which states no property can have more than 40% of the lot under cover. This means at least 60% of your property must be uncovered. At Woodburn Estates & Golf we could have a rule or regulation which states no more than 35% of the lot can be under cover. This is appropriate because we are within the Woodburn requirement; we just cannot allow more of the lot to be under cover.

Example 2: Another example is voting. The State Regulations say at least 75% of our members must vote on a change requiring a membership vote. Woodburn Estates & Golf could require a minimum of 80% but we could not set a minimum below 75%, because we would be violating the State regulation.

Example 3: The US Department of Housing and Urban Development has granted Woodburn Estates & Golf the designation of being a 55 and over community. As such, Woodburn Estates & Golf cannot declare the community to be a 50 and over community. If we were to change to 50 and older, we would lose our 55 and over designation and anyone could live within Woodburn Estates & Golf; we would have no control over who lives in our community. We could change our designation to a 60 and over community and still be legal with our 55 and over designation.

In summary, depending upon how the local, state and Federal laws are written – maximums and minimums – we have latitude to make changes with our documents as long as they do not violate the local, state or Federal laws and statutes. If you have any questions please don't hesitate to ask.



Greens Committee Report - submitted by Diana Lindberg for Janice **Aiken:** Marge Epling read the report. The Greens / Golf Committee met April 11, 2016 at 11:00 a.m. Allan Lindberg led the meeting. Representing the Women's club was Diana Lindberg. Guest was Don Conway. The other members of the committee were present except Tim O'Larey who was absent with notice. Tom Staskiewicz represented the administration. Fred Bourne said the signs for the bathroom locations are ready to go up. With Tim absent there was no update on when the rest of the signs will go up on the main streets that the golf cart paths cross. (Some signs are up.) Chuck Siver stated that everything is up and going well, including game posting. However, there was concern in the Greens Committee that we have quite a few players who are playing non-postable score games which would not reflect their actual handicap. Clint Hansen said that this compromises the validity of the handicap system. Allan brought up the drainage problems near the pro shop. Chuck stated that he believed that there were broken tiles and there is no map of where the drains run. Allan will mention this to the House Committee chair, Larry Jones. There is also poor drainage near hole one. USGA rule – Do not post if playing alone. This USGA rule was discussed, and if we can make a local rule that allows single player posting because most of our members do not play outside of Woodburn Estates. Allan said that he posed the question to the OGA and the answer was "no". Clint, Don and Tom had nothing to report. Allan gave a report about possible entries onto hole 10 and off of hole 18 so that there is less congestion between walkers, cars and carts, especially on Thursday. Allan will continue the path discussion between asphalt versus concrete paths at the next meeting. Walt VanRheen talked about possible gazebo changes. also be checked and the air hoses fixed or reconfigured outside. Diana asked when the course should be rated; the last time being in 2010. Under the USGA rules it is within 10 years, so a full rating is not necessary at this time, although an adjustment rating could be done if needed before the full rating. A review of the trees and paths should be considered first to see if there will be any changes before the rating is done again. Diana posed a question from the Women's Club. It is hard to see whether the lights are on at the end of the tunnels; could the lights be raised higher? Tom said that he would have Frank look at that. Tom will also check and see if safety meetings and walk arounds are being conducted with Tim's crews and around the maintenance buildings. Although Tim was absent, an email from Tim stated that aerification was starting on the back nine on April 11th. He will use the small tines which should help the recovery time. He recommended that the larger tines be used in the fall. Allan brought up the rose on hole 2, but with Tim absent there was no consensus. 

Transportation Issues

by Deb Marinos

Often I hear the lament - I don't know what I would do if I couldn't drive. I wish I could tell them what I know about getting around without driving my own car for the last 24 years. I was 35 years old when I learned of my progressive blindness, and I needed rides for work, activities, medical appointments, and social gathering – not only for myself, but also for my children who were ages 4, 7, 10 and involved in many activities.

The options developed over time included, friends, family, employees and public transit. At times I had to advocate for changing bus routes that were unusable for commuting or achieving trips without multiple transfers. Each transfer increased the chance of a miss, which decreases the reliability of being where you need to be. I learned about how to ask for rides and refusing some because they were poor drivers. Or there were strings attached that were uncomfortable. I learned about planning ahead and having last minute resources, those special people that said if you are in a jam, call me, if I am able I will come. At some points limited public transit was available through CARTS (Chemeketa Area Regional Transit) System buses. (*See article below on the public listening event for proposed CARTS bus route abandonment between Woodburn and Silverton on May 17 at 5:30-6:30 p.m. in Woodburn at Country Meadows Village)

Most of the time though I relied on paid drivers, and contrasted the cost with owning and maintaining a car, often far less. Now since I am living in



Woodburn Estates, I have many more affordable options through public transit. The best place to look at routes is on a website. Most have an information phone number. In Woodburn you can call 503-982-5233 to talk to the helpful transit Some resources I am aware of:

- Woodburn city loop Bus
- Canby Area Transit CAT goes from Bi Mart to Oregon City Transit via Canby/Hubbard (connects to SMART bus to Wilsonville and Tri Met system)
- CARTS #10 operates two routes morning and night to downtown Salem, via Chemeketa CC in Salem and continues on to Silverton – has a stop at Bi Mart, and downtown Woodburn transit.
- CARTS #25 door to door service to Silverton or Mt. Angel leaves at 11 comes back at 2:30p: call 503-315-5514 to make ride request. (This service used to have bus stops for last minute trips – no more. Just for fun, try booking a trip to the Oregon Gardens or a restaurant in Silverton.)
- Amtrak has a train/bus that stops in the new transit center by freeway once in each direction to train stations in Salem, Eugene or Portland, Seattle
- Hut Buses that go to PDX or Eugene airport from the Best Western in Woodburn
 - Casino bus that makes trips to both Grand Ronde and Lincoln City
- On Sunday, the Woodburn Presbyterian Church has an accessible bus that will pick people up about 10a for a 10:30 service and return about noon. Call 503-982-5127 by Saturday evening to get on the route.

In addition, for persons over 55 or who can't access the fixed route due to a disability:

- Dial a Ride in town, door to door to most any location within city
- Out of town Medical trips, to Portland, Salem, Silverton, etc. This service is accomplished primarily by volunteer drivers from RSVP. Please note if you enjoy people, and have a good safe driving history, please consider applying to be part of the network of people providing this service. The only compensation is the federally issued rate for reimbursement per mile. Currently about 50 cents per mile. As the drivers stay in the area with their rider until their medical appointment is over, some waiting is expected. This service is offered free to riders with donations gladly accepted.
 - And in Woodburn, various taxis exist.

*Transit changes – Listening Session May 17

Unfortunately, one resource for transportation is about to disappear if we don't act. The CARTS # 25 route is planning to be discontinued. This will have devastating impact on seniors and others, including families in our rural area between Woodburn, Mt. Angel or Silverton who need to get to work, shopping and medical appointments. The service is not planned to continue in some other manner. Some of the popular stops is Chemeketa Woodburn Campus, DHS and the factory outlets in Woodburn. In Silverton, is Roth's Grocery Store, excellent restaurants, Silverton Hospital, Oregon Garden, Mt. Angel Abbey. If you can, express concerns about the current schedule, no stops at bus shelters and the difficulty of making an appointment through the phone system – often long waits, etc. Help Woodburn and Silverton, and the rural area between, be served by this important service. Voice your suggestions for boosting efficiency and utility along with why the current service was not useful. There is a public meeting at Country Meadows Village on Tuesday, May 17, 5:30pm-7pm. 6:30 p.m. President Becky Butts called the meeting to order and requested that all in attendance please stand for the Pledge of Allegiance and silence their cellphones.

Establish a quorum: Board members present: Becky Butts, Malena Turner, Stan Hiller, Jim Worley, Larry Jones, Allan Lindberg, Nancy Dale, Don Conway and Jim Taylor. Per Secretary Malena Turner there was a quorum.

President Becky Butts then thanked everyone for coming out to the evening meeting, then thanked all the BOD and GM plus volunteers that came out to support the Pancake Breakfast on April 23rd. The Breakfast Fundraiser, which benefited the Woodburn Police Department, was a huge success and every Board member plus the GM were there to help. Thank you, Board! President Butts then said, "I have been asked how we select Board Members after a position has been vacated. Our Bylaws 5.4-3 tell us how to do this. When a Board position is vacated the President will, within 30 days, and with BOD approval, appoint a member in good standing to fill the vacated position for the remainder of the term, and that's just exactly what we did. Thank you."

Agenda: President Butts then asked if there were any additions or corrections to the agenda. Director Dale said she needed to make a motion of new committee members under New Business. Treasurer Lindberg said he would have 2 motions, 1 following the Treasurer's report and 1 under New Business following the Tech Committee report. President Butts then asked for a motion to approve the minutes from the April 11th meeting. Seconded. Discussion. Call for the vote: Directors voted aye unanimously.

Treasurers' Report: The balances reported today were reconciled with bank statements and Balance Sheet provided by Woodburn Estates & Golf bookkeeper as of March 31, 2016. Our Operating Account balance as of March 31, 2016 was \$956,709.30. Our Reserve Account balance as of March 31, 2016 was \$1,039,739.22. Our Accounts Receivable balance as of March 31, 2016 was \$252,692.58. Delinquent accounts: As of March 31, 2016 we have a total of 78 delinquent accounts totaling \$43,194.40. This is a reduction of 20 properties that totals \$12,914.39. As of March 31, 2016 we have the same total of eight (8) delinquent accounts that have been turned over to the attorney for collection. The total amount owed is \$19,657.30. As of March 31, 2016 we have 8 homes in Foreclosure or are Bank-owned that have unpaid assessments that total \$4,685.91. This a reduction of 2 properties that have been put back on the market for sale. The Balance Sheet and Profit and Loss Budget reports dated March 31, 2016 have been posted on the association bulletin board and are available for you to view if you would like to see more detail.

COMMITTEE REPORTS (see addendum for report content) UNFINISHED BUSINESS:

Motions-Rules and Regulations: Director Worley stated that at last months' meeting he made these motions and posted them for 1 month. Motion #1 for April 26th, 2016, to update the Rules and Regulations Section 9.1.3., to match the Standard Operating Procedures and what is currently happening at the main office. The Current Language: "Associate Members are required to pay their dues and fees for the entire year". The New language: "Associates dues and fees may be paid on an annual basis (by January 31st), or semi-annual basis (half by January 31st and half by July 31st)". Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried. Director Worley: This is to match the Standard Operating Procedures and what is currently happening at the Association and has been posted for one month. Motion #2: Director Jim Worley moved the following updates to the Rules and Regulations Section 13.8, to match the current rules at RV Park. The Current Language is: "RV units must be parked centered side to side in RV space and nothing may be stored within two feet of the fence". The New language: "RV units must be parked centered side to side in RV space and nothing may be stored within four feet of the fence". Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried. Director Worley: This change matches the allowance for RV parking and has been posted for 1 month. Motion #3: Director Jim Worley moved to delete of the word "package" from Section 9.2.4, to take confusion away from Golf and the Golf Only package and to change the word "of" to "or" in the Rules and Regulations: "a partial medical refund may be given upon written request by a member or associate under the rules of this Section for "Golf only package" if there is a written medical excuse from a qualified medical doctor. [Dated 11/24/2015]. These changes can end possible confusion to the wording and the Rules Committee feels that it eliminates that confusion and this has been posted for 1 month. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried. ByLaws Motion #1: Director Jim Worley moved the following changes to the Bylaws: that all references to the "Initiation Fee" be changed to the "Working Capital Fee". This is the suggested language and has been posted for 1 month. Seconded. Discussion.

Call for the vote: Directors voted ave unanimously, motion carried. Motion #2: Director Jim Worley moved the Bylaws addition of the "Reserve Fund" language, Section 5.9 of the Bylaws, "Limitations of Powers of Directors Special Requirements" as attached, 5.9.6 "Reserve Fund". The Reserve Fund is a Board controlled Fund consistent with the ByLaws the Reserve Fund receives 100% of the "Working Capital Fee", is used solely for expenses for Common Area, Major Repairs, Budgeted Capital Expenditures or Emergencies. It will not be used for day-to-day operations or maintenance. The Board of Directors is responsible for preserving the physical plant and capital equipment by anticipating new or replacement equipment, major repairs or new construction and setting aside funds to protect the Corporation against "Unforeseen Catastrophic Losses". The Reserve Fund will be maintained at a minimum balance of \$250,000 to meet those needs. The effective balance of the Reserve Fund beyond the \$250,000 (lower limit), will be determined by updating annually. Reserve Study that includes for consideration those Capital Improvements, Replacement and repairs of \$1,000 or more, or for any single expenditure, the period of time to be considered in the Reserve Study will be from 2-30 years. Consideration will be given to current replacement costs eliminating remaining useful life at the rate of inflation. Reserve Study will be brought up to date each year concurrent with the annual budget process and prior to the first meeting of the Budget Committee. Disbursement from the Reserve Fund, including earned interest income, are made by transferring the approved payment from the Reserve to the General Fund. All disbursements to vendors will be made through the General Fund. Seconded. Discussion. This language is consistent and matches the Standard Operating Procedures and this language change will add the Reserve Fund language to the ByLaws, a stronger document in the management of the Association. Reserve Fund stated procedure is the practice of Woodburn Estates & Golf and this motion has been posted for 1 month. Call for the vote: Directors voted aye unanimously, motion carried. Director Worley: Under Rules established at Woodburn Estates & Golf Standard Operating Procedures, the Rules should ensure that these documents are kept up to date. Under Oregon Statute 94.625, Bylaw changes will be recorded in Marion County, the county where Woodburn Estates & Golf is located. Our Office Manager Julia Senter will make and record these changes, once the new changes are made in the ByLaws, and they will be posted after the recording is complete.

NEW BUSINESS:

Tech Committee Director Allan Lindberg (see addendum for Tech Committee report content), **Motion:** I move to add Clint Hansen to the Tech Committee. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried.

Treasurer's Motion: I move to create a legal contingency fund and dedicate up to \$350,000.00 to this fund. Discussion: This fund will be held in the reserve account and be dedicated to cover any unforeseen legal expenses and will be rolled over each year if not used. Although it is expected that this dedicated money will not be needed, it is our responsibility to dedicate money for the purposes mentioned. After an executive session meeting in which our lawyer from Vial Fotheringham was present, the question was asked what would happen if a board member or someone in authority at the association divulged confidential information from an employee's personnel file either verbally or through email, as did happen earlier this year when a former board director sent emails to ten recipients in which confidential information was included. This set a potential for Woodburn Estates & Golf to face legal suit expenses. It was recommended that Woodburn Estates & Golf have a legal contingency fund for those unknown times when the association may need to cover expenses due to unforeseen legal expenses outside of the proposed annual budget. First and foremost, the board and general manager will first send any potential charges due from a lawsuit to our insurance company as the first line of defense. At that point, our insurance carrier would tell us whether they will be covering a legal defense in our behalf or whether we are to obtain legal counsel and be reimbursed. Second, we do have regular legal counsel who we may call who can work or advise the board and general manager, or recommend counsel that fits the situation. The money that would be dedicated to the legal contingency fund would cover those unforeseen deductibles and assorted fees and expenses that the association may need to bridge the gap. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried.

Director Nancy Dale: I make a Motion to add Janice Aiken and Bernardine Bourne to the Membership Committee. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried.

Director Larry Jones: I have 2 motions to make. **Motion #1: Replacement of** Windows and Doors Asset ID# 1200. With the completion of the Health Center, the House Committee looked at the windows and doors in the Swimming Pool Building. With the help of Frank Jameson, we found that we are in definite need of new windows and doors. At present, we have windows that are not shatter-proof and numerous windows that have lost their seals. Also, a lot of the replacement windows that were installed years ago, were not the correct size and scabbed in to fit the opening. This mixture of old windows is costing us time and money. Dawn Cole and the house committee has spent a lot of time and energy to present this motion. The Summary of Bids for this job are: Dallas Glass for \$35,495.00, Woodburn Radiator & Glass for \$35,274.00, and Davis Glass \$30,960.00. Dawn worked with the contractors to replace the 29 windows and 3 double doors that surround the pool building with tempered glass for ADA safety compliance. Insulated glass was compared to vinyl Montecito windows w/solar cool-bronze. These windows have a superior 10 year warranty. The vinyl Montecito are also Energy Star with Energy Trust of Oregon and would net us around \$850 to \$900 in rebates. It also should be noted that WRandG is also including Exterior Trim, Cedar Trim and Water Shield installation if we find any dry rot. I want to make sure that if that happens we are prepared to handle the problem. The above windows have a 10 year manufacturer's warranty and a 1 year workmanship warranty. I am therefore asking the Board of Directs to approve a budget of \$35,274.00 to Woodburn Radiator & Glass to complete this job. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried. Motion #2: Replacement of Siding, Windows and Roof at Golf Maintenance Bldg. It was brought to the attention of the House Committee that the Golf Maintenance Building needs some TLC. The roof is way

beyond its serviceable life. The siding is in the same condition as the roof. All but 2 of the windows need replacing. We will also need to replace the gutters and paint the building. Dawn Cole has been spending a lot of time trying to find bidders willing to take on these jobs. We have 4 bids that include the siding, windows, roof, and gutter, plus paint. We have another bid (RoofMasters for \$6,200.00) that only quoted the roof and would have had to subcontract the rest of the work. This job is something that had not been planned on but for us not to address the issue would be irresponsible on our part. The Summary of Bids for this job are: J. Forrest Construction for \$30,973.20, Double I Construction for \$35,196.00, Roof Rite Construction for \$23,520.00, and Abney Construction for \$22,029.22. Of the bidders, J. Forrest Construction has the best rating. They are also platinum certified with siding and roofing suppliers. They are a company that Woodburn Estates & Golf wants to do business with. It is important that we get the approvals for these jobs so that any work can be completed will we have the good weather to work in. I am therefore asking the Board of Directors to approve a budget of \$30,973.20 to J. Forrest Construction to complete this job. Seconded. Discussion. Call for the vote: Directors voted aye unanimously, motion carried.

President Butts: Our next meeting will be May 24, 2016 at 1:30 p.m. Meeting adjourned at 7:34 p.m. to Open Mic. [On advice of attorney, we will no longer publish Open Mic comments in N&V. Ed.]

Malena Turner. **ADDENDUM: GM Report Tom Staskiewicz:** We have moved into summer time mode at Woodburn Estates & Golf. The course is busy and everything is in bloom. My wife and I were out walking in Woodburn Estates last evening and there are so many yards looking so beautiful. It's great to smell the flowers and enjoy the color. *On* the lighter side: if your neighbor has a dog and that dog does his business in your neighbor's yard and you don't think they are cleaning up quickly enough; there is nothing we can do from the office or the Board. The best we can suggest is don't look or close your blinds. The Pancake Breakfast last Saturday was a tremendous success. This event was a great opportunity to reach out to the greater Woodburn Community. From what I saw, we had members of the police and fire departments, city hall, public works, many of our residents and who knows who else attended. It was awesome! I have had some people question why we are donating the proceeds to the police department. The answer is 1) we are members of the community. 2) We are also building community spirit. 3) It's also a way to get the community to come to events at Woodburn Estates & Golf. We have all heard the old adage, "you need to think outside the box". I challenge that idea and prefer to say "you need to stand outside the box and look in to see what you have been missing." I learned long ago that I was overlooking experiences in my work history which I had basically forgotten or thought too insignificant to matter. I was wrong! When I went back and collected those experiences, I found I was qualified for a career path I had overlooked. Woodburn Estates & Golf is no different. Woodburn Estates & Golf is designated by the IRS as a 501C (7) club as Allan stated in the treasurer's report. As such, there are many opportunities for us to raise money from the outside. From my estimates the outside money could be as much as \$400,000. For this to happen, those outside our community must look at Woodburn Estates & Golf as a place to hold or participate in events, gatherings or other activities. We need the Woodburn Community to see Woodburn Estates & Golf as a place to come for fun and activities. Holding events to involve and support the community are important and need to be encouraged. Another community activity I am encouraging is for the Area Real Estate Brokers to hold their monthly meetings at Woodburn Estates & Golf. I was approached by Jim White and I wholeheartedly agreed. This will be our opportunity to work with all the area brokers to educate them on the requirements for home ownership in Woodburn Estates & Golf along with our documents, fees, age requirements, etc. We are finding homes being sold by realtors and individuals who are not familiar with our requirements and we only find out after the sale is completed. This creates awkward situations when we tell someone they are not old enough to live in Woodburn Estates & Golf after they have already purchased the home. We also have to tell them about the Working Capital Fee and the HOA dues. It's not pretty and I hope to get out front of these situations to avoid embarrassment for everyone. On the lighter side #2: I had a resident tell me the other day how he keeps intruders out of his yard. I mentioned this during Coffee Hour last week, but here it is again. This member had someone attempt to enter his yard late one night. All of a sudden he heard the intruder scream, when he went to look there was no one to be found. What he had done was attach an air horn to his gate and when the gate was opened the air horn sounded. The intruder screamed and ran off. Air horns cost about \$15.00 at Walmart. I've been working with Allan looking for ways to improve our financial reporting. Allan and I feel we need to make the reports more easily understood and we need to be breaking out operational areas for everyone to better understand the numbers. There are areas of the current method we use for producing the financial statements that do not conform with what an accountant or auditor wants to see, however, doing what the accountants and auditors would like does not present the information in a format a non-accountant or non-auditor would necessarily understand. Because we include budgetary numbers, sometimes our spending in one month is more than the budgeted spend for that month and so we see a negative. Next month the actual spend is less than the budgeted spend and we may end up with a surplus for that moment in time. Therefore, we create the balance sheet so it shows full year information to keep individual budget items in the black. Both Golf and Marketing need to be looked at as separate Profit & Loss areas because they both receive revenues and have expenditures and then the other pieces of the operations looked at collectively. Then we need to roll-up the three areas to a consolidated statement for Woodburn Estates & Golf. The other piece we should add is what is known as Fund Accounting. This is where you take accounts, such as the Reserve, which spans multiple fiscal periods or funds which start and end during two fiscal periods and monitor them separately. You cannot take one of these funds and try to close them within a fiscal period when they span multiple periods. You simply cannot get an accurate picture of the revenues and expenditures using that method. Fund Accounting is commonly used within government agencies and non-profits. Outside Woodburn Estates, we can look at the I-5 Interchange project for an example. This project started in 2013 with the completion originally set for the fall of 2016. Because the project spanned several fiscal periods, it had to be viewed in its entirety and not on a year-by-year basis because the budget was spread over several years. They couldn't say this is how much will be spent in 2013, 2014, 2015 and 2016. First of all, because they didn't know, and the second reason is they would still be working on the project for another 4 or 5 months instead of completing one-year early. Our Reserve is similar; not the same, but similar. We project things to do in each year, some happen and some do not as we reach the trigger date. The Reserve is fluid because our short and long-term repair/replacement needs are fluid. Last month a motion was passed by the Board to register the name Woodburn Estates & Golf and our logo for \$2250. I had a member tell me why he thought we were doing this and as one part of the decision - to protect our name and logo from being used by others - he was correct. The second reason for registering the name and logo was to stop the frequent name changes done by boards and previous general managers. By registering our name and logo we are not only protecting ourselves, we are also making future changes more costly and hopefully less likely for them to happen. Whenever there is a name change, we have letterhead, business cards and other materials to throw out and reorder with the new name or logo. We also have to change our signs and with the latest name change the new signs had to comply with the latest Woodburn ordinances. This is an expense we don't need and registering our name and logo can be an additional hurdle to the process because our protection disappears. I can assure I have no lack of things to do, but my door remains open to members to stop by and talk about what is on their mind or to just shoot the breeze. One more thing. I would like to form a Sponsorship Committee so we create a consistent and equitable process for sponsoring events from golf to Pancake Breakfasts, benches on the course, Coffee Hour, golf holes during tournaments, advertising and the list goes on. We have lots of opportunities to bring in revenue and keep member costs as low as possible!

COMMITTEE REPORTS

Architectural Director James Taylor: Since the Board of Directors meeting in February there have been 33 Architectural Requests and 16 Compliance Requests. I would like to remind our owners that as the weather warms and they want to start on those spring and summer projects, they will need an Architectural Permit for Fencing, Exterior painting, Roof or Driveway replacement, and most landscaping projects.

RV Lot Director James Taylor: Gate hours are now set to summer hours. Please note the item in the latest News and Views regarding the charge that owners will be assessed if they end up locked into the RV lot after hours. Calls to the Police or Fire Department to get you out cost the Association and prevent those responding from being available to perform their duties. As Frank is an employee, if he responds it results in overtime and again, an expense to the Association.

Activities Director Malena Turner: The meeting was called to order at 11:32 by Director Malena Turner. Members present were Mary Danielson, Nancy Reed and Rita Girard. Absent with notice was Jan Robarge. Also in attendance were Sharyn Cornett, Diana Lindberg, Becky Butts, and Tom Staskiewicz. A discussion was held regarding permanent coffee hour volunteers. The committee felt that it would work more effectively if there was a separate committee with each member taking on a separate responsibility and someone to oversee the entire event. Nancy Reed gave a Treasurer's Report showing our balance as of March 31 as \$14,777.92. Mary Danielson reported on the Pancake Breakfast preparations. Rita Girard reported that all volunteers are in place. Becky and Tom asked that proceeds be donated to the Woodburn Police Dept. for the purchase of speed monitors. The committee approved this request. Malena had a written request from Ron Ewing for 5 new pool balls sets which would be a cost of \$761.50. It was decided by the committee to table this request until the Pool Hall room would have ample security. Wine Tasting May 13th. It was decided by the committee to rent the glasses and white tablecloths for the serving tables from Capital Rentals and to pay the \$90.00 charge for delivery and pick-up. Malena is going to contact a harp player. A diagram showing the possible set up was reviewed. We will provide 2 licensed servers (Lon Reed and Nancy Dale) and Craig will have the remainder available. Oregon Wine Sales will need 4 tables for serving both the basic and premium wines. Diana gave a report on the progress of the car show. Malena reported that Wolfer's are planning a picnic in the Gazebo June 18th for the residents. They will be taking care of all arrangements. Meeting was adjourned at 1:07. Update on Coffee Hour: We have had great support from volunteers who want to give of their time at Coffee Hour. We have not missed a beat with Entertainment. The Activities Committee is very appreciative of the overwhelming support of the community in this endeavor to make Coffee Hour a fun and informative program. We love our community and want to make it a pleasant place to live and thrive. We are always looking for members who want to volunteer their time in some manner. This is why we want to have two teams to run Coffee Hour. It will give others a way to contribute their time without being committed to every Thursday, if they have other things they need to do. Volunteers are always welcome in any of our activities. Just give us a call. We can find a place for you. Thank you. On that note I want to say <u>THANK YOU</u> to all the volunteers for the Pancake Breakfast. It was a huge success. We Thank the Scouts that came to help put and take down the chairs and tables and do the Flag Ceremony at the beginning of the Breakfast. We thank our sponsors, McCully Realty and Legacy Financial for their support. We had a great turn out. As I looked out through the crowd, I saw all enjoying having breakfast with their neighbors and friends. That's what we want. Happiness! Malena Turner, Activities Director.

Golf Director Don Conway: The Greens/Golf Committee met April 11, 2016 at 11:00 am.

Allan Lindberg led the meeting. Representing the Women's club was Diana Lindberg. Guest was Don Conway. The other members of the committee were present except Tim O'Larey who was absent with notice. Tom Staskiewicz represented the administration. Fred Bourne said the signs for the bathroom locations are ready to go up. With Tim absent there was no update on when the rest of the signs will go up on the main streets that the golf cart paths cross. (Some

signs are up.) Chuck Siver stated that everything is up and going well, including game posting. However, there was concern in the Greens Committee that we have quite a few players who are playing non-postable score games which would not reflect their actual handicap. Clint Hansen said that this compromises the validity of the handicap system. Allan brought up the drainage problems near the pro shop. Chuck stated that he believed that there were broken tiles and there is no map of where the drains run. Allan will mention this to the House Committee chair, Larry Jones. There is also poor drainage near hole-1. USGA rule – Do not post if playing alone. This USGA rule was discussed, and if we can make a local rule that allows single player posting because most of our members do not play outside of Woodburn Estates. Allan said that he posed the question to the OGA and the answer was "no". Clint, Don and Tom had nothing to report. Allan gave a report about possible entries onto hole-10 and off of hole-18 so that there is less congestion between walkers, cars and carts, especially on Thursdays. Allan will continue the path discussion between asphalt versus concrete paths at the next meeting. Walt VanRheen talked about possible gazebo changes. Walt had toured the full course last week with the House Committee. Tim's office near tee box 17 is in very bad shape and needs siding as soon as possible, hopefully this year. It may also need roof work. Walt said the construction on the Golf Storage Shed is ready to go and will be completed in a week or so after the start. Possible energy credits will be checked along the way to see if we qualify. Tom has been in contact with Energy Trust of Oregon. Clint brought up the lights in the golf lounge and whether they could also be checked and the air hoses fixed or reconfigured outside.

Diana asked when the course should be rated, the last time being in 2010. Under the USGA rules it is within 10 years, so a full rating is not necessary at this time, although an adjustment rating could be done if needed before the full rating. A review of the trees and paths should be considered first to see if there will be any changes before the rating is done again. Diana posed a question from the Women's club. It is hard to see whether the lights are on at the end of the tunnels – could the lights be raised higher? Tom said that he would have Frank look at that. Tom will also check and see if safety meetings and "walk arounds" are being conducted with Tim's crews and around the maintenance buildings. Although Tim was absent, an email from Tim stated that aerification was starting on the back nine on April 11th. He will use the small tines which should help the recovery time. He recommended that the larger tines be used in the fall. Allan brought up the rose on hole-2, but with Tim absent there was no consensus. At the last meeting Janice Aiken and Diana Lindberg were tasked to remind our golfers about some local etiquette rules while at play. End of Meeting – 12:45 p.m.

House Director Larry Jones: <u>Road Trip Presentation</u>. To help in the planning of ways to create a vision of how the House Committee can better serve our community, we took a road trip. Dawn Cole, Walt VanRheen and Larry Jones went to Salemtowne, Summerfield, King City and Claremont to see if there were ideas that would serve us as well. Dawn took photos which we shared at this meeting. The above communities are all 55+ housing units. <u>Golf Equipment Storage Building</u>: With the passage of the budget we have contacted M and W Building Supply to start the Engineered Drawings that we can submit to Marion County to get our building permits. Jim Taylor has located the property markers for our plot plan we need to prepare for the county. This saved us from having to hire a surveying company to find our property lines. We have also had Excavator to look at what is needed to prepare the job site for construction. We are doing everything we can to get the job started as soon as possible.

<u>Pool Bldg. Glass Replacement:</u> Dawn presented 3 Bids for replacement of the 29 windows and doors that surround the swimming pool building. We discussed the different types of windows that were available to us. Although there were cheaper windows available it was decided to go with the vinyl Montecito windows with "solar cool-bronze". Costs showed that with the vinyl, the warranty was superior; a 10 year warranty as compared to a 5 year warranty. After discussing all the bids, I will present a motion to award the bid to Woodburn Radiator & Glass (a local company). Golf Maintenance Building: After discussing the need of upgrading this building which has roof, siding and broken windows to replace, and gutters that are no longer functioning, Dawn got in touch with four different GC contractors to find out what it would cost us to make necessary repairs to this building. Dawn presented the 5 bids, 4 of which included: siding, roof, windows. We were able to discuss the pricing. We are making a motion at the next Board of Directors meeting to authorize the repairs to J. Forrest Construction. With the amount of work that we have, it was suggested that we check with Energy Trust of Oregon to see if there are any rebates available for the work that we are planning to do. We will investigate and make sure that we do not miss any opportunity to capture any savings. Gazebo Repair or Remodel: At this point we have asked M and W Building supply to quote on making the repairs to the Gazebo. We gave them a copy of our engineered drawings to base their bids on. We are keeping our minds open to other solutions to provide Woodburn Estates & Golf with a suitable solution to the problem. Sound Proofing of the Conference Room Walls: I have been in contact with Sly Toran of Sly's Drywall Co. When I originally contacted him he told me he was booked until late May which is good with the other work that we have going on at this time. I will email him and confirm that we will be awaiting a contract to start the job at a time that can be agreed upon. Office Remodel: The office remodel has been started for us by our maintenance crew of Frank and Frank. The scope of work is much smaller than what was originally planned. Tom Staskiewicz and Board President Becky Butts discussed ideas with me. And so the work has started. We have new walls up and drywall installed. We have new carpeting ordered from Kelly's Flooring in Salem, as approved by the board of directors. New windows will be installed. I want to thank Frank Jameson who was also available to answer valuable questions for us to work within our planning the new office remodel. HVAC for Auditorium: Frank Jameson has informed us that the HVAC equipment has been ordered by Wolfer's Heating. In the meantime we are working with Energy Trust of Oregon to find out if there is rebate money available to us for this purchase. Water Draining Problems at Clubhouse: I was informed by the Golf Committee that the main drain in front of the pro shop is no longer draining properly. I checked with Frank regarding this problem. I met with Frank and Allan Lindberg regarding this. RotoRooter has worked on this line but, when we have heavy rains we have problems. We discussed installing a new sump with sump pump to pump this water to a new drain. The piano that was stored in a golf cart storage building has been removed and destroyed. Meeting Adjourned 11:30.

New Members & Real Estate Director Nancy Dale: I would like to thank President, Becky Butts for appointing me as the new Director of Membership and Real Estate. I will do my best to fulfill the duties that have been given me. *Real Estate:* Homes sold year-to-date in 2016: 45 (as of April 25th). Homes sold year-to-date in 2015: 39. *Membership:* A meeting of the Membership Committee is planned once the Board approves my nominations.

Marketing/News & Views/WEB Director Stan Hiller: We will be running ads this month in West Linn and Wilsonville. The Tulip Festival flyer has arrived with our ad in it. Flyers have been created for the Pancake Breakfast and Wine Tasting event. News & Views: it's a feast or famine with articles for the News & Views. The last issue, we had too many articles, but that is not a complaint. So, please keep sending in "filler article" to the News & Views. As space is available in the paper it makes it easy for our editor to use these filler articles and also send some photos in with those articles. WEB: February web users totaled 887 and March had 730 users. Last month we started a new web page titled "Golf Events" in which you could see the event and download the registration form. It occurred to us that we need to do the same for upcoming activities and dances. See our new web page called Activities which shows the Activities Schedule, Dance Schedule and Thursday Coffee Hour. Recently our GM, Tom said we need to have a web page for the realtors and those private home owner sales transactions. See our new web page "Buying or Selling under "Our Community". This page can also be accessed from the home page too. This web page will contain the forms to be down loaded by realtors and those doing their own private home ownership sales. Don't forget to click on the Facebook book symbol for the latest happenings.

Rules and Regulations Director Jim Worley: Approximately 20 open complaints in process.
