Lunch is served at a cost of \$5.00. All we ask of members is that they attend meetings, assist with fundraisers and spread the word about the mission of Lions in Woodburn. As a club, we pay state and national dues that cost the members \$35.00 per six months.



Men's Golf General Meeting

Woodburn Estates Men's Golf Membership Meeting December 7, 2016

President Russ Krussow called the Meeting to order at 10 AM in the Dining Hall, followed by the Pledge of Allegiance.

Roll Call: Russ Krussow, Paul Eaton, Jim Worley, Chuck Johnson, Clint Hansen, Ron Hansen, Stan Hiller, Allan Lindberg, Bob Price, and Steve Hobson. A total of 26 members attended the Meeting.

President's Report: President Krussow reminded us that this would be his last Meeting as our Club President. The new officers will begin their tenure January 1, 2017. Meeting times for the monthly Executive Meetings and General Membership Meetings will be announced by our new President, Paul Eaton. Notice will be posted in the Pro Shop and the Golf Lounge. President Krussow reported that we must use the mats at the Driving Range. Apparently, some golfers are hitting balls from the grass and in the process destroying the grass in front of the mats. President Krussow then reminded that there is a Two Person Chapman Tournament scheduled for Saturday, December 10th. He also stated that a New Year's Eve Golf Tournament is being planned.

Vice President's Report: VP Paul Eaton had nothing to report. His comments regarding the OGA will be reported under the Committee Reports.

Treasurer's Report: Treasurer Jim Worley reported that the Club's funds at the beginning of the month totaled \$2,247.80. Expenses during the past month totaled \$77.50 leaving a current balance of \$21,170.30.

Secretary's Report: Secretary Chuck Johnson had nothing to report. **COMMITTEE REPORTS:**

OGA: Chairman Paul Eaton reported that the OGA recently held their 2016 Annual Director's Meeting. Directors from individual Golf Courses were asked to give a report as to how they are focusing on increasing their membership. Various courses reported that they were using the following marketing tools to increase their membership as follows: active golf websites; free golf days; letters sent to all new home buyers within their community, informing them of the golf course, clinics, sales, etc; and the establishment of recruitment committees. Paul stated that we are currently marketing our golf course by using many of these same activities to increase our membership. Overall, the 140 golf courses within the OGA are experiencing either modest gains in membership or a decrease in membership. Paul also reported that there is an informal group of male golfers known as the NW Golf Guys who play numerous golf courses within the northwest. Paul then explained the Passport Program sponsored by the OGA that allows play on up to 73 golf courses for \$30 or less per round. Paul then concluded his report by explaining how the OGA spends revenue received from the OGA dues we pay annually.

Director/Rules: Chairman Ron Hansen had nothing to report.

Sunshine: Chairman Bob Price reported that during the year he had sent out a total of 33 cards. During the past month, he sent out appropriate cards to Don Strong, Herb Harrison, and Virginia Mustion regarding medical issues. Jim Worley then reported that Butler Stephens had fallen while playing the first hole and broke his ankle. Bob will send Butler a card. President Krussow then reported on the status of Jerry Marvin.

Handicap: Chairman Clint Hansen reported that the Most Improved Golfer Award in 2016 was won by Stu Davis. The Club will pay Stu's membership dues for 2017 in recognition of his achievement.

Membership: Chairman Stan Hiller stated that he will complete an audit of membership later this month and have a full report for 2016 at our next General Membership Meeting. Stan reminded us of the promotion allowing free golf for our friends during the month of December. Those receiving the free golf must be at least 50 years old and be accompanied by a member. Stan has been on the Corporate Board as the Marketing Director and reported that revenue earmarked for 2016 has been depleted. Stan also reported that a member of his Committee, Gene Stiles, checked out advertising for marketing our golf course through the OGA and found the cost to be prohibitive.

UNFINISHED BUSINESS: Nothing to report.

NEW BUSINESS: Nothing to report.

CLOSING COMMENTS: President Krussow reminded that there would be a Committee formed to review and update our Constitution and Bylaws. Larry Kemper inquired about when our cart paths would be repaired or resurfaced. Allan Lindberg, also on the Corporate Board as the Treasurer, responded that there is approximately \$68,000 in the cart path fund. Allan stated that any work on our cart paths would have to wait until warm weather begins. Allan then explained that there is a plan in the works to allow golf carts to move from one nine to the other without going thru the parking lot. Larry Kemper and Steve Hobson

both commented that based on the plan as explained by Allan they could foresee problems. Will Abshere inquired of Allan if there was additional revenue that could be used for cart path repair and/or resurfacing. Allan responded by explaining that funds received from the sale of homes within our community (\$3,000 working capital fund) goes directly into our Reserve Budget and that cart path repair or resurfacing would quality as common area expense; thus, additional revenue is available for this expenditure. Jim Worley then inquired as to the cost of installing concrete cart paths and Allan stated that they had not received a current estimate. Steve Hobson stated that tree removal is imperative before cart path repair. Allan agreed that tree roots are a problem, but not on many of the golf course holes. Terry Erickson commented that he would like to see our cart paths widened to allow carts to pass during "cart path only" conditions. Also it was pointed out that many of the golf course maintenance vehicles are wider than the current cart paths. Ron Aiken inquired why the drainage problem on the second hole had not been corrected. Larry Kemper responded that due to the excessive rain we have had this year, it is impossible for that area to drain properly. Allan Lindberg then suggested that the name of our golf course is not readily known as our dba has changed over the years. Stan Hiller then inquired as to the members present as to whether our Club should be involved in the annual Golf Show held in Portland. A discussion ensued with mixed feelings as to whether it would be money well spent to participate in the Golf Show. Allan Lindberg suggested that if we do participate, we should hand out a bag to those attending that would have information regarding our course, etc. Jim Worley reported that we gained very little from our participation in the Golf Show last year. Jim Carter pointed out that the Ladies Golf Club is currently meeting to discuss whether they will participate in the Golf Show.

CLOSING: President Krussow made a motion to adjourn our Meeting, the motion seconded by Stan Hiller, the motion approved, and the Meeting was adjourned at 10:40 a.m.



ADDENDUM-DIRECTOR and GM REPORTS:

Activities-Malena Turner: The committee met on December 1, 2016.

The Treasurer's report was read. As of November 17, the Activity Fund showed \$16,095.79, and the Coffee hour fund had \$1,817.79.

It has been hard to track the free coffee hour cards that have been given out to Greeters and then the Vendor Fair, as there have been no controls on who is doing it and when. We need to follow the cards better so that we do not have vendors showing without notice to the coffee hour set up crew and the announcers. A card procedure needs to be established with an end date, who gave out the card, etc., and the card needs to be presented when the vendor comes. The committee is working on a procedure.

There was a lengthy talk about sponsorships. Tom said that several of the coffee hour \$175.00 tables have been reserved for 2017, which is used to offset the entertainment costs.

The pancake breakfast needs a chairperson. If you are interested, please contact

The issue about a photographer for events was briefly discussed. I want to thank the members who helped decorate the indoor trees, including the activities committee and walking club. I also want to thank Frank and his crew for the work done outside.

The blood drive on December 8th during coffee hour was a success. We hope that it can become an annual event.

Architectural-Director James Taylor: Since the Board of Directors November meeting, there have been 3 Architectural Requests and 6 Compliance Requests.

Again, we would like to close out as many 2016 Requests as possible, so if you have completed your project, please call me or the office.

Golf-Director Paula Kilgore: *Rounds Played for November 2016:* 18-holes rounds played 697; 9-holes rounds played 245; Yellow Tee rounds played 2; Guest rounds played 20; Total rounds played 994, and total rounds played YTD 23,533.

Greens Meeting: Golf Course report (1) Arborvitae on number 11 have been cut down and now the removal of the stumps before planting. This will be done as soon as possible weather permitting. (2) Crew is refurbishing tee signs and benches for the course. (3) As we are a year round golf course, the standing water issue on the course is being addressed. (4) In January, we will be contacting companies for bids for repairing the damaged cart paths.

House-Director Larry Jones: The House Committee met on December 6th to discuss our various projects.

We have started the construction for the new 42" ADA doorway from the office to the Health Center. I should have more information on the timeframe for completion once our contractor has all his material available to him.

The House Committee has received the plans and drawings needed to start finding contractors willing to bid our Gazebo project. We have a couple of the bids in at this time. We spent a lot of time reviewing the plans and specifications trying to make sure that we are giving the members of Woodburn Estates & Golf a Gazebo that will provide function, usability and be a pleasant addition to the landscape for everyone's use. Walt VanRheen is working hard to make sure that the contractors and WE&G are on the same track.

Update on the exercise room expansion: Walt VanRheen has been hard at work with Michael Finkelstein Design in Silverton. We have the plans now in hand. The next stage will be to review the plans and request bids from building contractors who can handle the job. This is the early stages with much more work to be done.

The House Committee is still working on the updating of the Men's and Women's Restrooms in the Auditorium Lobby. At this time we are awaiting the bids for this project. We hope to have the bids in the next couple of weeks.

Update on the painting of the Club House. Although we'd hoped to have completed the paint on all the buildings by the end of December, the weather prevailed. The rear of the Pool Building remains to be done as do all the final sanding and touch-ups. We have re-negotiated for a finish date of March 17, 2017. We are holding back final payment until we are satisfied. This was unforeseen but we have managed. It's what can happen when you approve something like this late in the year during constructions busiest time.

Marketing-Director Stan Hiller: The marketing committee has completed all of our projects for this year, except for the contract with Pamplin Media that runs in 2017.

Membership-Director Nancy Dale: New residents in the Woodburn Estates & Golf community (since September, 2016) are being personally contacted (approximately 60) letting them know about the pending delivery of packets as well as personally welcoming them to our community, and letting them know about our new membership meeting on Saturday, January 21, 2017 from 1:00 p.m. to 3:00 p.m.

News & Views-Director Stan Hiller: Great job by everyone from editor, publisher, distribution, writers, and delivery volunteers – thank you.

Phone Directory-Director Stan Hiller: Our publisher, Cindy Hale of Imagebird, has completed the 1st draft and my proofers are checking it over (we've now completed draft #1).

Real Estate-Director Nancy Dale: This report is for homes sold as of December 9, 2016. Homes sold year-to-date in 2016: 144 (increased by 7) with an average age of 65.2. Homes sold year-to-date in 2015: 147 with an average age of 65.7. Home sales pending is 61.

Rules & Regulations/CC&R's-Director Jim Worley: As of December 13, 2016, 86 complaints have been filed. 15 remain open for the year of 2016; one each for 2014 and 2015---which are fined monthly. Total open is 17. Several of these include legal matters and 5 are registered letters. This means 5 are close to being fined on a monthly basis.

Documents: All documents are available to homeowners: Bylaws, Rules and Regulations, Declarations, Articles and SOPs (standard operating procedures) with the one exception of the SOS-which deals with Security.

And finally, a reminder regarding the Documents: Woodburn Estates & Golf is to be run by the Board, answerable only to the members of Woodburn Estates. This means the running, decision making and enforcing is decided by the Board and communicates its decisions to the general manager.

Many thanks for allowing me the privilege to serve on the Board these past 3 years.

RV Lot-Director James Taylor: The problem we reported at our last meeting has been resolved and access has been restored to the RV lot. Please remember to renew your space reservation for the New Year.

Technology-Director Allan Lindberg: The following was discussed at the meeting.

Phone System/Cabling: Will Abshere presented a request for proposal for phone system installation. Discussion followed and the proposal will be modified to include items brought in during the discussion. A proposal will be mailed out to 7 different vendors with a deadline of January 18 for their return. A January 23 meeting has been scheduled to review any and all proposals. Will Abshere will be the point lead on this project.

Server: Tom will connect with Mark, a computer network consultant and specialist to help completion of the server installation.

Firewall: Tom will be backing up all emails in preparation for the transition from email service from Multop Computer Service to our new service hosted on Go Daddy.

Projector screen in dining hall: Walt and Tom will get together with Frank on lowering the Bingo reader board in preparation of installation of our new screen to complete the overhead projector project.

Server Room: The server room has some extra furniture pieces that need to find a new home. Stan said the server room needs additional air filtration installed to eliminate the accumulation of dust.

Web-Director Stan Hiller: October web users totaled 721 and November had 945 users. The New Year will be here soon and I will need to update many items on our website.


During the conversation, he used the example of Juniper, when you say Juniper most golfers know you are talking about the course in Redmond, Oregon.


