# **A Fortunate Find**





...The Marmor cake is in the oven. Dishes are washed waiting to be dried. But...my mind went back to my childhood, as it does frequently when doing the dishes. But back to the winter wonderland for us children in 1947/48...Thick ice crystals covered the insides of our windows in the dormitory with beautiful designs only Mother Nature can produce, where all the little kids slept in bunk beds. Boys and girls together but separated in the middle of the room by benches where neatly folded clothes had to be placed by each child; girls on the right side and boys on the other.

One bitter cold night we children lined up by the beautiful green tiled Dutch stove in the middle of the hall of the home, ready to go to bed. Meantime, the older boys had placed bricks to be warmed up in the stove and one by one as the bricks were wrapped in towels, one child took off running to his or her bed, and the warm brick was placed at the foot of the bed. That was the greatest fun and treat for us little critters in winter.

At this time in my life, of course, I don't have anyone bringing me a warm brick for my cold feet. I use my heating pad and the socks my sister had knitted for me this Christmas. The cake is done, smelling delicious.

Keep your feet warm as well as your heart. It makes for a good night's sleep.

# **History of Billiards - Part 1**

"Bat-and-ball" games, from which lawn games may well have evolved, have been depicted on tombs, artifacts and in drawings, dating back more than 3000 years. Whether these images depict "sport" has been widely debated. Uncovered ruins and hieroglyphics offer a possible answer, setting back the timeline thousands of years.

Many rightfully claim that not enough is known – that the activities portrayed could very well have been social or religious in nature. Whatever the case, the ancient Greeks and Egyptians clearly utilized the tools (the bats, the balls and other curious devices) in some sort of integral activity. Tools strikingly similar to those wielded by kings in 14th century lawn games are dated nearly 3000 years earlier to at least as far back as 1500 BC.

An even earlier discovery – and one seemingly more compelling in proving the role of sport among the ancient cultures – was made during the excavation of a child's grave in Egypt (c. 3300 BC). A complete "Skittles" set was discovered, after more than 5000 years. ("Skittles" is the English game of ninepins, played with a disk or a ball.) The set was as exquisite in its beauty as in its significance. Each gaming piece – 9 skittles, 4 balls, and 3 bars to form an arch – was expertly sculpted and polished, comprised of fine marble or stone.

Billiards is a great form of entertainment from beginners to professional level of play. We have one of the nicest Billiards rooms in the Woodburn area. 

# **Men's Golf General Meeting**

### Woodburn Estates Men's Golf Membership Meeting January 4, 2017

President Paul Eaton called the Meeting to order at 10 a.m. in the Dining Hall, followed by the Pledge of Allegiance.

**Roll Call:** Paul Eaton, Will Abshere, Allan Lindberg, Chuck Johnson, Clint Hansen, Ron Hansen, Russ Krussow, Fred Bourne, and Steve Hobson. A total of 19 members attended the Meeting.

**President's Report:** President Eaton began by wishing those present a "Happy New Year". He then informed the members present that he was working with Stan Hiller, our Membership Chairman, in updating the list of the Club's Officers and Chairmen/Representatives, including phone numbers and email addresses. He then encouraged members to attend our Meetings and if they have questions, concerns, or complaints, our Meetings are where these issues should be discussed and resolved. President Eaton promised that if their questions or concerns could not be answered in our meetings, he would seek an answer on their behalf. He then advised that the Executive Committee of the Club has decided to not hold monthly Executive Meetings. In the future, Executive Meetings will only be scheduled as needed. President Eaton then listed the current Club Officers, Committee Chairmen, and Committee Representatives as follows: Vice President Will Abshere has been appointed to be our Publicity Chairman; Len Westphal, Mixed Tournament Chairman; President Paul Eaton, Tournament Chairman for Thursday Men's Golf Club Play; Allan Lindberg, Handicap Chairman; Clint Hansen, Handicap Co-Chair; Fred Bourne, Greens Committee Representative; Ron Hansen ,Rules Chairman, President Eaton then stated that he had asked our Rules Chairman, Ron Hansen, to discuss at least one rule at each of our Meetings. President Eaton will remain as our OGA Representative. The position of Chairman of the Sunshine Committee is yet to be filled. At that time, prior Sunshine Committee Chairman Bob Price reported on cards sent out during 2016. Steve Hobson gave a brief report on the medical condition of member Gene Stiles. Clint Hansen then gave a brief report on the medical condition of former member, Rich Bennett. President Eaton then acknowledged Past President Russ Krussow and announced that Fred Bourne will continue in charge of the End of Watch Tournament. Dick Hammond will continue in charge of the Harvest Invitational Tournament. President Eaton then stated that the scheduled time for the Harvest Invitational Tournament conflicts with a tournament being held at the OGA. In that many of the OGA members participate in the Harvest, President Eaton suggested that we move the date of the Harvest from August 25, 26, and 27 to July 28, 29, and 30. This change will have to be approved by the Association's Board of Directors and should be done as soon as possible. President Eaton then stated that on occasion various people will attend our meetings to make announcements or comments that need to be known by our membership. When this happens, these announcements would be made following the Pledge of Allegiance. President Eaton expressed that our General Manager, Tom Staskiewicz, should be at some of our meetings to discuss the Oregon Trail

**Vice President's Report:** VP Will Abshere distributed copies of the amended Constitution and Bylaws recently completed by his Committee. He requested that those present review the amendment and if any additions, deletions, or corrections are needed that these concerns be submitted to the Committee as soon as possible. Following review of the amendment, VP Abshere requested that all copies be returned to him. He then stated that the amended Constitution and Bylaws would be posted on the bulletin board for 30 days and voting for approval by the members will take place at our General Membership Meeting scheduled for February 1, 2017. VP Abshere then summarized the changes made in the amended document and the rationale for the changes. VP Abshere informed us that he has been appointed to be our Publicity Chairman and his goal will be to encourage attendance at our monthly General Membership Meetings. He then explained some of his ideas on how attendance could be increased and encouraged members to present their ideas to him on how to achieve this goal. VP Abshere then stated that the formation of a 9-Hole Men's Golf Group would be pursued as some of our members have difficulty playing 18 holes. A 9-Hole Group could play on Thursday, have their own formats and pay outs. Handicap Co-Chair Clint Hansen then discussed the handicap situation and the possibility of playing 9 holes on one Thursday and then playing with the 18-hole group the following week.

**Treasurer's Report:** Treasurer Allan Lindberg reported that the Club's funds on December 1, 2016, totaled \$2,170.30. Expenses during the month totaled \$55.56, leaving a current balance of \$2,114.74. Allan verified that annual dues for membership in the Men's Golf Club remain at \$40 if paid prior to February 1st. After February 1, the annual dues increase to \$45. The Pro Shop prefers that the dues be paid by check. Allan then inquired of the members present as to how many used Facebook with the thought that this social media could be a means of communication with the members. Less than half of those present used Facebook so this would not be a feasible means of communication.

**Secretary's Report:** Secretary Chuck Johnson had nothing to report. **COMMITTEE REPORTS:** 

**Handicap:** Chairman Allan Lindberg explained that former Chairman Clint Hansen has relinquished his position as Chairman, but will remain on the Handicap Committee as Co-Chair. Allan stated that he would be adding other members to his Handicap Committee in the near future. He will be informing Kelly Neely, OGA, of the change of our Handicap Chairman. Allan encouraged the members to feel free to report to the Handicap Committee any irregularities they may witness as

to the posting of scores. He and his Committee will be pro-active in examining the posting of scores as compared to dates signed in to play as well as any other irregularity that comes to their attention. The purpose is to identify golfers who are either "sandbagging" or trying to establish a "vanity" handicap.

**Mixed Tournaments:** President Eaton thanked former Mixed Tournament Chairman Bob Price for the service he has performed in the past. Our new Mixed Tournament Chairman is Len Westphal. Len stated that he is in the process of getting changes made to the Mixed Tournament bank account. He also verified that the after-tournament meals will be moved up to approximately 2:30 p.m. to accommodate Associate Members who live out of the area. Len also informed us that the after-tournament meals have already been planned for 2017.

Greens: Committee Representative Fred Bourne first inquired if our General Membership Meetings would continue to be held at 10 a.m. on the first Wednesday of each month. President Eaton verified that this schedule would continue as in the past year. Fred then asked if new score cards showing the changed hole handicaps had been ordered. Allan Lindberg responded that we have enough score cards to last until our golf course is rated again by the OGA in April, 2017. This new rating could change some of the hole handicaps. Fred then reported that the last Greens Committee Meeting was held on December 12, 2016. This Committee's meetings are held on the second Monday of each month. At the last meeting, our Golf Course Superintendent, Tim O'Larey, gave the following report: continued leaf cleanup; continued work on the arborvitae on the 11th hole; crane fly spraying; tree cleanup and stump removal. Fred informed us that the projected cart path around the parking lot had been tabled. He then discussed the wet spot on the left rough of hole number 2. This is an impossible area to correct at this time as this area is lower than the drainage ditch near the freeway. ODOT will not address the problem. Larry Kemper suggested that a large French drain could be installed to move water away from the wet spot in the rough on this hole. Fred will pursue this possibility with Tim O'Larey. Fred then asked the members present to vote on whether this wet spot should be marked as a water hazard or remain as "ground under repair" with a free drop for any balls entering therein. The members present voted to have this wet spot remain as "ground under repair". A brief discussion then ensued regarding our participation in the annual Portland Golf Show. According to our previous Board Director in charge of Marketing, Stan Hiller, we received very little in return for the cost of our participation in the Golf Show. Allan Lindberg, our current Director of Marketing, stated that the Association budget for Marketing in 2017 is \$8,000 and, in his opinion, we should concentrate our marketing efforts on areas closer to our community. The Ladies Golf Club President Paula Kilgore is said to have been discussing their participation in the Golf Show. A discussion then ensued relative to making our course more playable year round, including the use of sand in low areas and near the cart paths. Allan Lindberg verified that more sand has been approved by the Board in the 2017 Budget. Allan Lindberg then stated that he has been in contact with Paula Kilgore, the Board Director in charge of Golf, and Chuck Johnson, Board Treasurer, regarding the need to seek bids on cart path repairs for 2017. This will also be a subject addressed at the next Greens Committee Meeting. Bids should be sought early in the year so the work can be approved by the Board and begun as early as weather permits. There is approximately \$62,000 currently in the cart path fund and additional money can be approved by the Board from the Reserve Fund as golf course cart paths are part of the common area. Steve Hobson and Len Westphal also commented on cart path repair, including making the path wider, up to 8 feet, and removal of trees where roots are ruining the paths. Will Abshere recommended that a sub-committee be established to identify the problem areas as to the cart paths and focus our repairs on those areas.

**Rules:** Chairman Ron Hansen discussed the marking of golf balls on the green. A player should never mark another person's ball without asking permission to do so. If permission is granted, the player marking the ball becomes that person's representative and must be the one replacing the ball or a one stroke penalty will be assessed.

**Sunshine:** Former Chairman Bob Price reported that he had sent a Sympathy Card to Sharyn Cornett for the passing of her husband, John.

**OGA:** Representative Paul Eaton had nothing to report. **Membership:** Chairman Stan Hiller was absent with notice.

**UNFINISHED BUSINESS:** Nothing to report.

**NEW BUSINESS:** Nothing to report.

Closing Comments: Dennis Wichert stated that the golf course maintenance crew should cut the rough very short after tournament play in the fall as this would lessen the wetness in the roughs during winter play. Larry Kemper, Fred Bourne, Russ Krussow, and Ron Hansen all discussed various computer fraud scams to be aware of. Mike Dykes was present and was asked by President Eaton to give an update as to his medical condition. Mike then gave a very positive report on his improving health for which we are all grateful.

**Closing:** Bob Price made a motion to adjourn our Meeting, the motion seconded and approved, and the Meeting was adjourned at 11:25 a.m.

**NOTE:** Our next General Membership Meeting will be held in the Dining Hall at 10 a.m. on Wednesday, February 1, 2017.

# **Wasp Spray as a Protection Device**

Regarding the article in the January 13, 2017 *N&V* that advocated the use of Wasp spray for intruder protection, this may not be a good idea. Here are excerpts from an article from eXtension.org titled "6 Reasons Why Wasp Spray is Not a Substitute for Pepper Spray."

"Pesticide experts from Extension services at land-grant universities emphasize the public should use pepper sprays and pesticides only for their intended uses, and ask the public to help debunk urban legends about using wasp spray for defense. They also advise individuals to check with local law enforcement departments for specific laws about the possession and use of pepper spray products.

Why wasp spray should not be used for defense:

- 1. There's no research to suggest wasp spray would stop an attacker.
- 2. Using a pesticide in a manner other than according to labeled directions is a violation of federal law (the Federal Insecticide, Fungicide, and Rodenticide Act).
- 3. It is illegal (finable offense) for anyone to recommend a use other than the labeled use.
- 4. Personal liability is likely to be significant for a person who deliberately sprays another person with a pesticide.
- 5. Pesticides such as wasp spray have not been tested on humans. Direct human toxicity data comes from records of accidental exposures and suicide attempts.
- 6. Poison control records document an amazing number of people who have accidentally sprayed themselves or innocent bystanders when using aerosol cans. An emergency situation may exacerbate that reaction."

It would be wise to do some research before using wasp spray for anything but wasps.

**Technology-Director Allan Lindberg:** The following was discussed at the meeting.


