oodburn Estates & Golf renewed their liquor license with OLCC recently. There are no changes in the current license requirements.

Currently, we are asking for volunteers from our members to serve alcohol at events and approval has been made by the Board of Directors to reimburse or pay for that training for those who took the test already as a volunteer starting February 1, 2017. The offer is through the end of May. We are looking for a trainer to come to Woodburn Estates & Golf to train members here.

Events may include dances, tournaments, street potlucks held at the dining room, sports events watched on the "Big Screen". We need to remind you that you cannot drink if you are serving. So we would like volunteers who would be willing to volunteer at events and do not consume alcohol so that each event is covered. Contact me if you are interested in volunteering for this training.

In approved events and activities, one may bring wine but it must be opened by a permitted server. For clarification; Wine is the only item in the Oregon Administrative Rule that is allowed for a corking fee. Beer is not allowed to be brought onto our premises, per our license, but it can be purchased through the Pro Shop or Country Cottage. Hard liquor is not part of our license.

A small group, with representatives from several activities and the board, have regularly met to learn about the process with OLCC and have been in direct communication with OLCC in person and by phone or email. OLCC has been very gracious and helpful in guiding us.

Marlene Johnson moved to approve the minutes of the February 20, 2017 meeting as published in the *News & Views* March 10, 2017. Motion was seconded by Sally Carter and approved.

COMMITTEE REPORTS

OGA/Rules-Susan Gsell:

Proposed rule changes for the "Accidental Movement of a Ball on a Putting Green". The USGA will be changing this rule in 2019 to allow players to not receive a penalty when their ball is moved accidentally while on the green. It is recommended a local rule be adopted previous to 2019. Diana Lindberg moved to adopt a new Accidental Movement of a Ball on a Putting Green Local Rule where no penalty is assigned to the player when the player's ball moves under accidental circumstances. Paula Kilgore seconded the motion. Motion passed.

Ruling on "Standing Water and Moving a Ball". A current local rule exists to allow the player to pick up and drop their ball away from standing water and muddy, lumpy areas of the course. This may even allow for the movement of the ball from the rough to the fairway depending on the circumstances. Susan reminded everyone that accidentally moving a ball on the fairway requires the player to return the ball to its original location and taking a one stroke penalty. If the player does not return the ball to its original location and hits from the secondary location, they are assigned a two stroke penalty.

March 29 Luncheon/Meeting



Commissioner's Luncheon

At March 29 luncheon/meeting with County Commissioners Brentano & Cameron, and Woodburn Mayor Kathy Figley, we had a fair turn-out of about 20 members. An agenda was handed out, and after lunch the Commissioners introduced themselves and spoke about several projects.

- 1. Santiam Canyon/Detroit Lake: Have restroom facilities for tourism at Santiam Canyon, and a lower docking ramp for boats at Detroit Lake.
- 2. Health care: Question was asked about "Opioid addiction" in our county and what's being done about it. The answer was that law enforcement has a program to try and get people treatment in lieu of arrests, but that there is not enough money to run the rehab centers for long.
- 3. Questions were asked about the "Smith Project", and whether they were planning on punching through the development onto Santiam. The Mayor wasn't sure so Director Aiken clarified that at a Planning Commission meeting when brought up the idea was shut down because the lot the city would use has a water line running under it and WEG owns the land.
- 4. Question about whether the roads will be improved or added to accommodate increased traffic, and another freeway onramp/exit added. The Mayor responded that Settlemeyer and Boones Ferry are being looked at for widening (where possible), Hayes as being scheduled for resurfacing and widened from Settlemeyer to Evergreen, and sidewalks added on both sides. As for the new freeway access, the Mayor said if it happens it would most likely have to follow stringent federal guidelines and be placed at the St. Louis overpass.
- 5. A question about whether the *land south of Tukwila* is scheduled to be built on and the answer was yes.
- 6. A question about the "Mid-Willamette Homeless Initiative" just completed by the county with a possible suggestion of adding "Accessory Dwelling Units" (tiny houses) where possible to help house the homeless. The question was whether they have taken into consideration that wherever these might be placed there has to be plumbing, electricity, water and sewage hook-ups available.

Commissioner Cameron said that yes that was being looked into, and that placing these in our community is "permissive" not mandatory, so this would go through the Mayor and city hall.

7. Question was asked about drainage around WEG, or the lack thereof and that it's flooding areas of the golf course. Commissioner Brentano asked to speak to the member after the meeting to learn more.



President Jim Taylor: Welcome to our February Board meeting. We certainly hope this one will be shorter than our January board meeting, but I want to congratulate our Board members for the volume of business they accomplished at that meeting and the members who attended for their persistence.

In the past few weeks, I've had the opportunity to attend several committee meetings and observed the work of our volunteers. Woodburn Estates & Golf is fortunate to have so many dedicated people working for the benefit of our owners. I'm not sure we could even accurately calculate the hours they spend each week, without any compensation. If you have an opportunity, please thank those who volunteer for one or more of our many committees.

TREASURER'S REPORT-Director Chuck Johnson: The balances reported today were reconciled with bank statements and balance sheets provided by the Estates bookkeeper as of January 31, 2017.

Our Operating Account balance as of January 31, 2017, was \$1,154,879.40.

Our Reserve Account balance as of January 31, 2017, was \$946,824.21.

The Accounts Receivable statistics presented in this report were determined as of February 24, 2017. On this date, the balance of our Accounts Receivable was \$108,426.38. This delinquent amount includes several submitted payment plans which I will be presenting to the Board today in Executive Session for discussion and possible approval. We continue to encourage members who are experiencing financial hardship to submit payment plans to allow them to become current with their annual assessment within a specified period of time. We currently have 124 delinquent accounts, up substantially from my last report. However, since the cutoff for payment of the annual assessment was January 31, 2017, it may well be that payments will be received late or payment plans will be submitted for approval. There are 5 delinquent properties in foreclosure with a total delinquent balance of \$14,180.77. Our attorneys are currently handling 9 delinquent accounts in an effort to collect the money owed to the Association. These 9 delinquent accounts total \$21,642.10.

Also, during today's Executive Session, I will present to the Board information regarding a delinquent account that we received back from our attorneys wherein it was their recommendation that we write off said account as being uncollectible. The delinquent amount that is deemed uncollectible totals \$2,314.42.

ADDENDUM-DIRECTOR and GM REPORTS plus Open Mic–Member Comments:

Activities-Malena Turner: The Activities Committee is proud to work with our members and volunteers to fund many of the items that we enjoy at Woodburn Estates & Golf. The Pancake Breakfast crew worked for three years to make over \$20,000.00 to remodel and update the kitchen. The kitchen was done in April 2008. Over the years, we have funded painting, bought drapes, a sound system and chairs and tables for the gazebo, conference room and the library. We funded countertops, a hot water tank, griddle covers and two gas griddles for the gazebo with plans to do more for the gazebo. In the last two years, we bought tables and chairs, a television by the restaurant, a drop down screen in the dining room and three Wii Game televisions with stands. Currently we are looking at projects while we wait on updates on the gazebo.

Betty Bunnell prepares and hosts a monthly Tea and gives all the monies donated at the event to the Activities Committee on projects that the Activities Committee chooses. The February 15th Tea raised \$118.00. The committee voted and added \$32.00 more dollars, and working in conjunction with the Marketing Committee, will help sponsor the last Music in the Park concert in August through the Friends of the Woodburn Library and City of Woodburn. This event will provide Woodburn community support and recognition with our brand on posters and advertising.

The committee made a motion on February 10th to transfer \$500.00 from the Activities Committee Fund to the Marketing Committee to pay part of the cost

of the four digital screens that the association will have in the golf lounge, front living room, front entrance to the office and the auditorium. These screens will be used to advertise events, community calendars and notices to our members. The monies raised at the Chili Feed Cook-off on February 4 fully funded this expenditure.

On February 16, the committee made a motion to transfer up to \$2,500.00 to update the Card Room near the kitchen with paint, cleanup and new cabinets or tables, if needed, in association with the House Committee.

The Potato Bash is on March 18th, and the funds raised from that event will help fund the updating of the card room.

Ad Hoc-Director Janice Aiken: Meeting on February 15, 2017, called to order at 1 p.m. with those present: Mike Dykes, Retta White, Janice Aiken and Ron Aiken, Planning Commission Member. Absent with notice Linda Eaton, John Lukes and Ralph Kruse.

The Planning Commission met with the City Council on February 13, 2017, for their first workshop and training on "land use and the development permitting process associated with Woodburn's own comprehensive plan".

The Planning Commission members were told that there are three (3) areas of development, i.e., Southwest Industrial Reserve, Smith Addition, which runs north and south along South Cascade Drive, and east and west behind Santiam Drive out to Parr Road and an apartment complex behind the outlet mall.

There is no new information forthcoming on the Smith Addition development. The meeting adjourned at 1:58 p.m.

Architectural-Director Dawn Cole: Since the January Board of Directors meeting there have been 14 Architectural Requests and 13 Compliance Requests.

Facebook-Director Allan Lindberg: Activity events have been posted timely to Facebook to provide current information to subscribers and visitors. If you have not been to Woodburn Estates & Golf Facebook page lately, please do so and check back often. There is the option to "Follow us." If you click to follow us, new items posted will show up on your Facebook page automatically.

We are receiving reports from Facebook weekly showing the number of visitors. For the last 28 days, our Facebook Page has had 589 Views and 4,322 Post Engagements. Generally speaking, with Facebook Insights, engagement is defined as post clicks, likes, shares, and comments.

I have been working with Renee Hayes, owner of Country Cottage Restaurant, in reclaiming the Country Cottage Facebook page which was created by an employee when they were located at the I-5 Freeway exit. The waitress has since left and with her went the username and password information. Without proper username and password, there was no access and no activity on the Facebook page since before 2014 when it was originally created.

I went through the many steps required to reclaim the Country Cottage Restaurant Facebook page and have been coaching Renee on how to use Facebook to promote the business and special events. Her first posting is for St. Patrick's Day where she will be featuring a corned beef and cabbage dinner.

Having a thriving restaurant at Woodburn Estates & Golf is an excellent and no cost way for residents and nonresidents to enjoy the beautiful view of the golf course while feasting on breakfast, lunch or dinner.

A digital media display will soon be installed close to the restaurant entrance, with a changing screen that attracts attention. Next Greens Committee Meeting - March 13, 2017 11 a.m. in conference room. **House-Director Larry Jones:** The House Committee met on Feb 7, 2017 and

House-Director Larry Jones: The House Committee met on Feb 7, 2017 and Feb 21, 2017 for discussions on the projects we are currently working on. I want to thank Director Dawn R Cole for planning these meetings while I was on vacation. I returned on Feb. 20th and was able to attend the meeting on the 21st.

The replacement of the auditorium roof was our #1 priority. Again, Director Cole led the way obtaining bids from roofing contractors. From the bids received she went through the pricing and fine print to ensure that we were going to get the right contractor, at the best price to make sure that the job will be done correctly. I am happy to report that I will be making a motion to the Board of Directors to approve the repair of the Auditorium roof.

Another job that was discussed is improving the lighting in the parking lot and making sure that we are maintaining the paving in our parking lot. Walt VanRheen is going to meet with PGE to discuss what would be needed to light up our parking lot.

With the replacement of the heating unit for the office and dining hall the House Committee has been working with the Activities Committee to improve the heating and cooling in the card room. The Activities Committee would like to replace the card tables and give the room a new coat of paint. Also make plans to improve the storage in the room.

On the Gazebo: Walt VanRheen is keeping in touch with contractors. Because of the Auditorium roofing repair, we are delaying the building of the Gazebo to a date later in the year. We are still keeping in touch with the City of Woodburn to make sure we are meeting all of the Code requirements.

The Exercise Room expansion is on hold for the time being. We are having discussions on how we can best provide suitable equipment and training for the use of the new facility when we can provide funding.

The remodel of the men's & women's auditorium restrooms is still waiting for contractor proposals, but we cannot proceed any further until we have our roofing problems resolved. The roof has been leaking for 17 years and is about 30 years old. It is at the end of its serviceable life. If the roof is not completely replaced we risk losing access to the auditorium and all of the activities and events it provides to our members. In addition, if the leaking continues we may end up having to replace the hardwood floor which would add approximately \$70,000.00 on top of the new roof. Director Dawn R Cole asked several roofing companies to bid the job. Of those 7 roofing contractors, we received bids from 4. After review of the bids the members of the House Committee selected Snyder Roofing. Director Cole and the Estimator went over all aspects of what is needed to ensure that all problems would be addressed. Their bid was selected and is being presented to the Board of Directors because of the following reasons:

- The bid they presented was most complete bid & a 22 year warranty.
- They were the only contractor to completely examine job.
- They have a 20 year track record and have no CCB problems.
- They can schedule for installation in May or June and take approximately 2 weeks.

• We will coordinate it so it has a minimal impact on any scheduled activities.

This is Keizertimes' annual drive to increase circulation and our first color ad will be appearing in this issue, which happens to be one week after the Portland Golf Show. I have provided each of you a print out of what this ad looks like. Whether we attract any associates from these ad campaigns, our name and logo brand will be out there for everyone to see.

Music in the Park - Woodburn Public Library will again be presenting their summer series "Music in the Park," a well-attended free event for Woodburn and nearby residents. This year marketing has committed to a presence there by becoming a Modified Production Sponsor. The cost is \$750.00. The question is: What do we get for \$750, and why are we choosing to be there?

Woodburn Estates & Golf is part of the Woodburn community and needs to project a positive branding image whenever possible. By choosing to be a Modified Production Sponsor our Woodburn Estates & Golf name and logo will appear on every piece of printed and digital publicity material.

As example, two 24" x 36" color posters will be displayed, one at each entrance into the Woodburn Public Library and will list each sponsor and the name of the musician groups playing at each of the 7 events. Woodburn Estates & Golf will be the lead sponsor for the last event held on August 22nd when Paul Creighton Project will be performing.

We will also be provided with two of the same 24×36 posters that we will display at Woodburn Estates & Golf, one in the hall by Country Cottage Restaurant and one in the auditorium lobby area. We will have an additional 24×36 -inch framed logo poster displayed at the front of the stage at each of the 7 concerts.

At the August 22nd concert, Woodburn Estates & Golf will have a vendor booth where we can promote our community to all attending. This will be a fabulous opportunity to reach out to the community and promote ourselves.

Where will the money come from? The monthly Tea event put on by Betty Bunnel has contributed \$150.00. There is a private donation in the amount of \$150.00 and the balance of \$450.00 will be paid out of the marketing budget. The Summer Series, "Music in the Park" starts July 11th and ends with the August 22nd concert so we will have over three months of advertising. This is a great value for the price and really puts us on the map.

I am also working with Renee Hayes, owner of the Country Cottage Restaurant, with her Woodburn Independent Leaflet ad that runs monthly in the Woodburn Independent. We are asking Renee to include the Woodburn Estates & Golf Logo.

I have found Marketing and The Web have two similar goals but approach marketing differently and use different tools. By separating Web and Marketing into two separate committees each will be able to perform their function independently. The web committee will focus on the Web page and the marketing committee will be focusing on all other marketing avenues.

Membership-Director Nancy Dale: Members in our community that have moved here since January, 2017 will be contacted and offered new membership packets in the middle of March.

News & Views-Director Allan Lindberg: No report.

Real Estate-Director Nancy Dale: This report as of February 28, 2017.

Homes sold year-to-date in 2017: 21 total.

Homes sold year-to-date in 2016: 11 total.

Home sales pending is 15 total.

Rules & Regulations/CC&R's-Janice Aiken: On February 22, 2017, twelve (12) new complaints have been received. There are six (6) complaints remaining

open from 2016 and one (1) each for 2015 and 2014, for a total of twenty (20) open complaints. Six (6) of these are being fined.

Review of Legal Invoices: At the last Board of Directors Meeting on January 24th, a motion was made to audit the legal invoices from 2016, as a follow-up to an audit done in December 2015. The vote was a tie, with no decision made.

The audit in December 2015 suggested a review of some procedures like coding, that the lawyers should be giving more detailed invoices and that some refunds should be requested.

At the Rules committee on January 25th, President Jim Taylor stated that he believed that the audit should take place, perhaps in the next month.

A review occurred on February 17th at 1:00 pm, with President Jim Taylor, Rules Committee Chair Janice Aiken, Rules Committee Member Diana Lindberg and General Manager Tom Staskiewicz.

Tom held the invoices and read parts of the invoices to those who were present. Janice, Jim and Diana took notes. An audit was not done, as the paperwork was not independently audited.

This was a review. The review pointed out that some procedural changes in the legal invoices are needed, that were consistent with the 2015 audit.

They are:

- The office should implement coding for different kinds of legal work so that work can be priced out and evaluated.
 - The incoming legal invoices should be broken out more.
 - Supporting documentation should be with the invoices.

RV Lot-Director James Taylor: The card key system for the RV lot requires some updating as it currently does not allow access for new card keys. Existing cards still work but until the upgrade is complete, those newly renting space in the RV lot must borrow a card from the office for access, then return the card when they've cleared the space. We apologize for the inconvenience and are working to resolve the problem.

Technology-Director Allan Lindberg: Tech publicly thanks the Activities director Malena Turner and her committee, for their \$500.00 contribution towards the purchase of four digital flat screens that will be placed in service to display current and upcoming information.

The Wi-Fi router that was feeding the Library area malfunctioned. Many attempts to reset the Wi-Fi settings failed and calls to the manufacturer led to the decision to return three defective Wi-Fi routers to the place of purchase for a full refund.

During the investigation of the Wi-Fi Router problems, we learned the office is having issues with the computer cabling in which communication from the computers to the server was disrupted many times. The Pro Shop was also experiencing communication problems with the server and accessing the internet. In each case, programs were not exchanging information properly. The cause of these issues is loss of continuity in the data cabling.

A Request for Proposal was written for replacement and installation of new data cabling and Wi-Fi in all buildings. Three vendors including Advanced Communication Services submitted proposals.

The committee reviewed all three proposals. Merchtel bid came in at \$2,879.24. Azimuth Communications Inc. bid was much higher at \$6,210.00. Joe Foti of Advanced System Communication cabling bid came in at \$5,620.30 bid. Since we had chosen Advanced Communications Services for a new phone system we invited Joe Foti back for further discussions.

By combining Wi-Fi, Voice and Data cabling we will reduce the cost of the phone system by \$1,389.22. The cost for the new phone system bid is now at \$5,648.48. Since a motion was passed in January 2017 we will move forward with the original motion and report the savings at completion.

During this process, we learned voice and data cabling was not in the 30-year study. Tom did add cabling infrastructure information into the 30-year study. Data cabling and Wi-Fi infrastructure in the common buildings are now identified in the reserve study as 60-1229.

New Cat-6e cabling will replacement existing cabling, replacement costs will be covered from the reserve account, at no increase to members.

We found we could enjoy additional cost savings by discontinuing service of one phone line that we believe was not in use but we were being charged monthly for several years. By combining voice, data cabling and Wi-Fi together we will be able to eliminate one Wave Cable Modem for additional monthly savings.

Our GM, Tom Staskiewicz, has set up and maintains our computer network server and performs computer upgrades and backups. Currently, Tom is the only person knowledgeable to this system and set up. Should something happen to Tom we could be up a creek. We need a backup solution. A person or persons knowledgeable about our type of network are few and even fewer close by.

WEB-Director Allan Lindberg: Our web page has undergone many changes since January 1st. New pages have been added. Existing pages have been modified, relocated or eliminated altogether.

Counters have been added to each page. Every time someone visits any page, the counter increases by one. All page counters were reset to zero on February 8, 2017. As of February 27, 2017, we have had 3,490 visits to the front page. The top three pages beyond the front page were 2,170 visits to the Clubs & Events Calendar, 234 Visits to the Country Cottage Restaurant and 144 visits to "Buying or Selling" information page.

All page counters will be recorded and reset to zero monthly to coincide with the board meetings. The data will be used to determine which pages are visited the most and which are the least.

Connie Doyon is re-writing the information on the "About Us" page. When complete this will be sent out to the Northwest Boomer and Willamette Valley Life publications. Hopefully they will find this informative and print in their publications.

One new page we are working on is Golf Lessons. Our Golf Professional, Chuck Siver, who has spent over 30 years as a golf instructor still teaches and would love

to help any golfer. It does not matter if you are a beginner or an advanced player, Chuck is there to improve your swing and game.

Another item coming to the web page will be a live leader board for our major Sponsored Mixed Golf Tournament Events. As a tournament is being played, the sponsor will be displayed and player/team scores will be updated live as the game progresses just like on TV. A page and link will be loaded on the web page so anyone wishing to follow along can do so in the comfort of their home or through a smartphone.

General Manager Tom Staskiewicz:

Directors' Training: In January I met with the Chuck Johnson, Dawn Cole, Nancy Dale, Paula Kilgore and Jim Taylor to review the responsibilities and obligations of a board member. We reviewed The Guide for Non-Profit Board Members from the Oregon Attorney General. On February 18, six of our board members participated in a leadership training session conducted by the Portland chapter of The Community Association International.

Our directors are also regular attendees at training sessions hosted by our attorneys, Vial Fotheringham, in Lake Oswego.

I have included these references to training on the recommendations of our auditor. Her recommendation was predicated on the need to show we train our directors in the event there was a legal challenge at some point to the decisions of the board and the proper application of their fiduciary responsibility.

The auditor also advised us to have the directors approve the treasurer's report at each monthly board meeting. This is another action to show the directors meeting their fiduciary responsibilities.

Audit: Last week we started our annual audit with Gayle Klampe of Johnson Glaze Co CPAs. I have challenged our auditor to bring forward recommendations on how we can better report our financial information and identify internal controls we should strengthen or put in place. Our previous audits have not included a section on recommendations on how we can improve our reporting and controls. This is an integral component of any good audit because organizations should constantly be working to improve.

In discussing our audit we are already seeing areas where we can improve. One recommendation we will hear is with the reporting of recovered bad debts. We have been off-setting our bad debt expense and the recommendation is for us to create a miscellaneous income from bad debt recovery account so we can better track our success in recovering funds. We are also being advised to change our accounting process for activities to better identify the source of receipts and creating budget items for activities, including Coffee Hour, so we can improve reporting and transparency to our members.

Another recommendation is the use of our Reserve Funds. We have used Reserve Funds for new construction and the Reserve, by definition, is for repair and replacement of assets. The new golf building last year should have been paid from our operating account and not the Reserve. We will be making an adjusting entry for 2016 to reclassify the cost as an operating expense.

Another expense we have been covering with the Reserve Funds is sand for the golf course. This is not the repair or replacement of an asset and the sand should come from our Operating Budget, not the Reserve.

Our desire is to ensure the Reserve Funds are being spent in accordance with the law and accounting requirements for the Reserve. Our attorneys have confirmed these changes to our handling of the Reserve.

Legal: At the meeting with our attorneys last week, there was discussion on collection of past due assessments and fines and how many HOAs have the placement of a statutory lien included in their documents. I have confirmed our documents contain this clause.

Instead of placing another lien on the property we could have our attorneys file a notice of lien with Marion County to state our claim. After discussion with the lawyers I determined the cost of filing the notice through the attorneys is far more costly than our current practice of filing a lien against the property through Marion County. Not only is this less expensive, we have been seeing some great results in collecting not only past due assessments and fines, but also collecting additional Working Capital Fees from the banks and mortgage companies when they foreclose on properties. At this point, I am recommending we continue placing the liens and minimize the attorney expenses.

We are also taking an aggressive approach with the banks and mortgage companies. These organizations continue to procrastinate on foreclosures for years and then try to take the approach that the law permits them to discharge any pre-foreclosure fees against the property. I have learned from our attorneys that title insurance companies are very careful when insuring these properties and if there are any suspicions or concerns about the legality of the foreclosure they will require all liens to be paid. We are banking on errors and mistakes to reduce our losses.
