Understanding HOA Risk



ost homeowners are not fans of special assessments or any unplanned expense and whatever can be done to avoid special assessments is appreciated. Last month I attended a luncheon where the speaker was talking about the risks faced by HOAs and their members. The primary risk HOAs face is special assessments, which are caused by a lack of funds to cover the costs of asset repairs or replacement. As an HOA there are many steps the board can take to mitigate or reduce risk. Preventing special assessments requires the board to take 16 steps.

The list of steps includes:

- A comprehensive list of assets;
- An accurate estimate of the repair or replacement cost of the assets;
- An accurate estimated life of the assets;
- Written maintenance plans for roofs, HVAC, plumbing, technology, trees, electrical, etc.;
- On-going inspections of assets;
- Comprehensive liability and property insurance policies;
- A reserve study with annual updates for inflation;
- Annual reviews of reserve assessment amounts;
- Policies prohibiting conflicts of interest in awarding contracts;
- Board members with the good of the whole in mind, not special agendas;
- Comprehensive bid specifications;
- A bid process requiring multiple bids;
- Proper permitting and licensing of contractors for jobs;
- Strong vendor performance contracts;
- Detailed project plans; and
- Comprehensive project oversight.

Each step we undertake lessens the risk and chance for unplanned expenses and special assessments. Have we identified all assets? Not yet, but our list of assets continues to grow as overlooked assets are identified and new assets are included.



President Paul Eaton said if your event will be using any portion of our facility and needs to reserve a room, you must fill out a Club Function form for Harvest, End of Watch and Glow Ball. Paul had concerns about the Thursday game format. His schedule said one format, but when the day came, the pro shop had a different format. Paul said he will help the new president, Ken Bourne, get the 2018 schedule updated. Stan volunteered to print this complete draft for both presidents.

The following items were then covered:

- Men's play schedule with concerns for the format, such as Pink Ball, 3-club, scramble and other formats, plus donuts on shotgun starts.
- Shot gun scrambles with computer pick to get new golfers involved.
- Having the first Thursday of each month be a computer pick.
- Do we have too many scrambles and not enough posting of scores?
- Nov. 10 free golf at the OGA for veterans with identification.
- Nov. 11 Albany has largest Veterans Day parade west of Mississippi.
- Nov. 14 Our Annual Members meeting at 10am and be sure to vote.

Paul then asked the upcoming president for 2018 to come up and talk about the OLCC. Ken said we need to be cautious as the alcohol permit includes the restaurant. We don't want to jeopardize this, so please obey the rules. Also, some concerns about neighbors hearing swear words from the golfers.

Treasurer Allan Lindberg gave our opening balance is \$1,791.82; deposits \$130.00; expenses to OGA \$35.00; doughnuts \$41.06; and our current ending balance is \$1,845.77.

As a reminder, our Men's Club dues are now \$45 starting in 2018. Also, our constitution says the Voucher Fund should be under the treasury. Jim Worley has made all Voucher Fund money deposits to the respected accounts. The pro shop will now get reports to show what you have on the books, but the reports could be a couple of weeks old.

Secretary Stan Hiller said he will not be returning as secretary after this meeting.

Green: Fred Bourne said I want to comment on why Ken Bourne was summoned. The rules chair made the decision to take out OLCC rules from the rules committee. It is now the duty of the rules chair and the President. Question: why are two people on the Board able to make decisions that affect the whole Board and community?

Paula Kilgore has reviewed several paving contractors and has chosen one to pave the cart paths. We reached out and a new golf pro, Jason Holh, was hired and will start tomorrow. The bunker rakes will remain, but with a longer holder and a pin, so that the rake handle doesn't touch the sand.

Larry Jones said the fence contractor who will be installing the fence near the 17 tee will be done in December. Dawn Cole and Paula Kilgore are working towards doing a 3-year paving of golf cart paths. Allan commented that the cart path on #1 is to be done this year along with the damaged areas. A larger area will be added to the existing area west of the clubhouse and the ropes for parking.

Mixed Tournament: absent no report due to health.

Handicap: Allan Lindberg said he is retiring from handicap position and thanked Russ Krussow for stepping up. Russ is now temporary certified for handicapping. Paul Eaton also thanked Russ for stepping up.

Rules: no report.

Membership: Stan Hiller reported that golfers need to pick up their Bag Tags at the pro shop. Without a current bag tag displayed you are not a member in good standing. Overall we have more annual golfers than last year and I think this is due to the referral program. Allan also stated that you can now pay for 2018 and golf free for the rest of 2017. This program has already gained 5 new golfers.

Sunshine: No report. Paul said if you hear of anybody needing a card, please call Ron Gripenstraw.

NEW BUSINESS:

Men's concerns with the sand on the grassy roughs. Just move the ball and continue to play. Hopefully the rain will wash it down. Tim will cut the rough shorter, so when spring arrives the grass will not be too tall.

Fred wanted to know when Paula Kilgore made the motion to do away with the cart path fund. Where did this conversation come from as it was not from the Green Meeting?

Paul had a couple of ideas from the OGA:

- He will post a chart on which tee you should be playing from, based on driving ability. Paul said we should all play now and again from the forward tees as it is fun.
- Posting scores is a must. Posting will end on November 30.
- Getting relief; obey the rules on how to do it.
- Local rules can be used and still post your score.

A request was made to have all the white chairs on the patio deck replaced with sturdier chairs. Larry Jones, House Chair said he will bring this up at the next Board of Directors meeting.

1:30 p.m. President Jim Taylor called the meeting to order and requested that all in attendance please stand for the Pledge of Allegiance and silence their cell phones. President Taylor welcomed everyone to this meeting.

Establish a quorum: Board members present: Jim Taylor, Janice Aiken, Malena Turner, Chuck Johnson, Dawn Cole, Larry Jones, Allan Lindberg, Paula Kilgore, and Nancy Dale. Per Secretary Malena Turner there was a quorum.

President Jim Taylor: Welcome to our September Board of Directors meeting. While our Annual Owners Meeting and election of new Board members isn't until the second Tuesday of November, the deadline for those interested in running for a position on the Board of Directors is rapidly approaching.

By our Bylaws, all nominations for Board positions must be submitted to the Office 40 days prior to the election. That date is October 4, 2017. If you are interested in running for a position, there are two ways to get on the nomination list. One, contact a member of the Nominating Committee and request your name be added to the list, or Two, obtain a petition from the office and have 25 members in good standing sign the petition nominating you for election. In addition, all those interested in running for election must fill out a résumé form that provides some general background and experience data. All nominees will have their pictures taken for inclusion in an article for the *News & Views*. The members of the Nominating Committee are: Carol Bolton, Barbara Rose-Cox, Sherry Hunt, Jan Robarge and Katie Taylor.

Finally, I must give those attending today a bit of an apology. Our Executive session today is likely to be quite long. There are several issues, many with legal implications that must be addressed.

Agenda: President Jim Taylor then asked if there were any additions or corrections to the agenda.



Treasurer's Report-Director Chuck Johnson: The balances reported today were reconciled with bank statements and balance sheets/ledgers provided by our bookkeeper as of August 31, 2017.

Our Operating Account balance as of August 31, 2017, was \$867,604.85.

Our Reserve Account balance as of August 31, 2017, was \$992,125.06.

The Accounts Receivable statistics presented today were determined as of September 22, 2017. On this date, the balance of our Accounts Receivable was \$50,536.76, a reduction of \$8,812.69 when compared with last month's balance. We currently have 51 delinquent accounts. Again, a reduction of 24 delinquent accounts when compared with last month's report. Our attorneys are currently handling 3 delinquent accounts in an effort to collect the money owed to the Association. These 3 delinquent accounts total \$7,017.85. Two properties with delinquent accounts have been foreclosed on and are now bank-owned. The total of these two delinquent accounts is \$6,815.71.

Our 2018 Budget Committee will continue to meet on most Wednesdays and tomorrow we anticipate completing a draft of the 2018 Reserve Budget. We will then begin to prepare a draft of the 2018 Operating Budget. Our goal is to have a draft of both the 2018 Operating and Reserve Budget completed by November 1. I will then ask President Taylor to call for an Open Board Meeting which will be a Budget Workshop wherein Directors not on the Budget Committee can provide their input.

UNFINISHED BUSINESS: None.

NEW BUSINESS:

President Jim Taylor requested a motion to approve the regular minutes for August 22, 2017; it was so moved. Seconded and approved.

President Jim Taylor requested a motion to approve the special minutes for September 1, 2017; it was so moved. Seconded and approved.

President Jim Taylor requested a motion to approve the special minutes for September 15, 2017; it was so moved. Seconded and approved.

Director Chuck Johnson motion #1: I move to approve the Treasurer's Report as presented today in this meeting. Seconded and approved.

Director Janice Aiken motion #1: I move to approve the change to the Rules & Regulations: 13.1 Members may obtain space. Only members may obtain space for their own unit(s) in the Associations RV Lot. (See Bylaws-Members). The units stored MUST be movable and must be identified on the form and/or photo may be attached. Ownership must be verified at the time of application. Seconded and approved.

Director Janice Aiken motion #2: I move to approve the following changes to the "Club or Group Facility Usage Application form.

Page 1 – strike: Single Occurrence date

Page 2 - #1 Will Alcohol be dispensed? Strike: dispensed. Insert: on the premises. Then after yes and no, insert: Maybe.

Page 2 – Outside Servers Must comply with all rules above and 1, 2 and 3 below. Seconded and approved.

Director Janice Aiken motion #3: I move to approve in the Standard Operating Procedures #1 "housekeeping" a reference change under 4.2.5 GOLF CAR PATH FUND. Strike: contained in paragraph F; insert: See Section 4.4. Strike: Budget Management, below. Seconded and approved.

Director Janice Aiken motion #4: I move to approve in the Standard Operating Procedures #1 "housekeeping" a reference change under 4.3.1 FIDUCIARY RESPONSIBILITY. Strike: See paragraph 4-D-1; insert: See SOP Two 6.5.3 concerning certificates of deposit. Seconded and approved.

Director Larry Jones motion #1: I move to approve \$8,000.00 to Advanced Locking Solutions for additional materials to complete the installation of the new security system for the clubhouse. Seconded and approved.

Director Allan Lindberg motion #1: I move to offer, beginning October 1, 2017, any resident member of Woodburn Estates & Golf can prepay 2018 golf membership and golf the remainder of 2017 free. This offer is only good to residents and associates if they are not currently a full golf member. The cost to members is \$650 and associates \$875. Seconded and approved.

Director Paula Kilgore motion #1: I move to approve and to move forward from the 2018 Reserve Budget, line item # 102067 in the reserve budget to 2017, for purchase of a Neary 555 SRI Reel/Spin Grinder from RMT Equipment in the amount of \$34,500.00. Seconded and approved.

Director Paula Kilgore motion #2: I move to approve the 2018 Golf Schedule. Seconded and approved.

EXECUTIVE SESSION: President Jim Taylor announced that the Board would be recessing to Executive Session. The Board of Directors came back and resumed the meeting. Director Janice Aiken summarized the executive session and moved to exempt 50% of the Working Capital fee for a homeowner buying a second home in the Association, provided homeowner continues to abide by the rules in our Bylaws associated with it. Seconded and approved.

Motion to Adjourn was seconded and approved.

our resident master poster-maker, to create a poster for the digital displays that can be used month after month. This, along with normal formal meeting notice posted on the bulletin board next to the office lobby, the normal Bugle Blast, Facebook and published in our News & Views activities calendar, provides many avenues of communication to keep members informed.

Web: Highlighting the top five webpage visits: front page 3,948; Calendar 3,455; Country Cottage 350; Buying & Selling 225; Our Community 209. I have attached a more detailed monthly report of page hits from January through August 2017.

Facebook: The number of followers on January 1 was 277. As of September 24, the number of followers has grown to 332, an increase of 20%. If you use Facebook check us out and see what's happening.

Publications: The June 22, 2012 News & Views article Board minutes by Secretary Dick Koessel: Our legal counsel has just advised the Board that we should discontinue the policy of publishing "unapproved minutes" and only print approved ones, in the newspaper. The June 26, 2012 Board Minutes by Secretary Dick Koessel brought to the attention of the Board that we had received information from our attorneys that we were not to publish unapproved minutes, nor are we to publish our monthly financials. Our SOPs need to be updated to reflect this opinion so we have clear guidance in future years with future boards.

MEMBERSHIP-Director Nancy Dale:

The changed venue at our New Member meeting on Saturday, August 26, was a success. Our new residents seemed to really enjoy visiting with reps individually from the different clubs, activities and Board members instead of listening to individuals talks.

I want to thank all the clubs, activity reps and Board members that turned out in good numbers. I've received constructive, positive feedback from many of those that attended. I hope to have even more representation at our next New Member meeting.

I am going to keep the same format, but introduce a few variations so the gathering will run more smoothly. I am open to hearing feedback from my fellow Board Members, and the clubs and activity members as well.

The next new member meeting is Saturday, December 16, at 1:00 pm in the Dining Hall.

REAL ESTATE-Director Nancy Dale: This report as of July 18, 2017.

Homes sold from July 21 to August 18: 12

Homes sold from August 19 to Sept. 22: 12

Homes sold year-to-date in 2017: 112

Homes sold year-to-date in 2016: 114

Home sales pending-to-date in 2017: 23

RULES & REGULATIONS/CC&R'S-Director Janice Aiken: On August 22, 2017, I reported there were twenty-nine (29) open complaints as of August 17, 2017. As of September 21, 2017, nineteen (19) new complaints were received and thirty-six (36) were closed. There are now ten (10) open complaints.

RV LOT-Director James Taylor: I've received several notes and calls concerning the RV lot and its drainage problems. We are well aware of the problems and have been seeking a solution. One company toured the lot and gave an estimate for a partial solution that well exceeded \$100,000 and they conceded that given the fact that our lot drains to the ditch along I-5 and then under the freeway to the wetlands, unless that drainage pipe is clear, their suggestion was not a long term fix. Estimates for grading and paving the lot have been estimated at over \$250,000. We met with another company to discuss alternate ideas to reduce flooding in portions of the lot. This not a problem we are ignoring, but it is one that has a potentially large cost and is impacted by conditions over which the Association has no control. I've spoken to Public Works and the County and ODOT has also been contacted. At this point, correction of those issues beyond our control have not been made or planned.

SAFETY-Director Dawn Cole: This past month the Safety Committee discussed and completed the following:

- 1. Ordered 3 additional AED's for placement in the Pro Shop/Restaurant entrance/Golf Maintenance Building near the green for Hole #12. The 4th AED is located just outside the entrance to the office. We are tentatively scheduled for the 2nd week of October to have a "How to Use Class" in the golf lounge.
- 2. Added another handicapped space in front of the Rose Garden. It should be noted that as we add a Handicap space we lose two regular spaces due to the clearance required on both sides.
- 3. Supervised the roofing crew that were re-roofing the cart barns ensuring they were roped-off and wearing 5-point harnesses.
- 4. Added one-way arrows in the newly sealed parking lot to direct traffic where golf carts will be more visible.

General Manager Tom Staskiewicz: I have several items for the Board to

Understanding the Reserve: The Reserve Account is to be used for repair and replacement of assets. I understand there have been questions by some members, including committee members, regarding some of the projects we have undertaken as Reserve projects. The comments range from this wasn't in the 30-year study to these are not repairs or replacements, they are enhancements.

Regarding the first comment about not being in the 30-year study; this document is a work in process. The studies done in years past did not include many assets. Some of the notable missing assets include the auditorium roof, auditorium and dining hall floors, dining hall sliders, Tim's maintenance buildings and common area trees. The studies also had broad items such as golf course construction A - F or groupings of HVAC units, appliances, and asphalt cart path overlays A - G and asphalt cart paths seal coat A - E. Why are the cart path overlays identified as A - G and the seal coat identified as A - E? The study needed updating to either include or further define assets so we know what we are discussing. Attempting to judge the projects on the old studies is not realistic, so even though projects may appear to deviate from the old studies, it is only a deviation because the previous studies were flawed.

As to the second comment about enhancements and not repairs or replacements when discussing the forward tees. According to the USGA Consultant our forward tees were not placed properly and needed to be relocated. Classifying this as a repair or renovation is appropriate and can be supported.

If we were a for profit organization instead of a non-profit organization the use of our Reserve could be subject to review by the IRS because of tax consequences. This isn't a concern because for non-profits there are no tax consequences whether we use Operating or Reserve funds.

Rental Properties: I attended a manager's meeting at Vial-Fotheringham last Thursday with the main topic being rental properties. Much of what was discussed did not pertain to Woodburn Estates or PUD organizations in general but I did come away with a few recommendations. The first thing was a reiteration of the fact that if rentals are to be punished they must be more than a "slap on the wrist". The fine must be substantial enough to impact the benefit of renting. Anything else the owner will consider as a cost of doing business. With that said we should be fining illegal rentals \$800 to \$1500 per month. These are going rates for Woodburn rentals and will make renting unprofitable. There is case law to support fines of this amount.

Neighborhood Parking Issues: The next thing I learned had to do with onstreet parking and whether the HOA can have rules and fine if those rules are broken. Woodburn ordinance requires waiting 48 hours before a parked RV can be reported and then Code Enforcement tags the vehicle and waits another 48 hours before removal. We have a legal opinion that Woodburn Estates & Golf can have rules that notify and start fines 48 hours after notification of the violation for on or off street rules violation. We do not need to have 48 hours pass before we are notified by a resident and we do not need to wait an additional 48 hours before we start the fines. This should be a daily fine and it should escalate until the violation is cured. We can also establish that driving around the block is not sufficient to demonstrate movement. We have many members who put up with vehicles parked in violation of our rules and we need to support our homeowners by addressing these issues.

Electronic Voting: Last Wednesday evening I attended a CAI Roundtable on the topic of electronic voting. We all know the problems we face when we attempt to change one of the original documents and there is the State mandated 75% participation of our members with a simple majority of the 75% to pass the change. There are several challenges we face in the process of getting to 75% and electronic voting can provide the mechanism to make reaching 75% more easily accomplished. In 2007, electronic voting was approved for HOAs in Oregon. As we look at our new members we are finding a more tech savvy group and the use of electronic voting demonstrates we are moving in the technological world and would make voting easier for our Snow Birds.

Mr. President, I would like to work with you to schedule a special meeting where the Board and interested community members could learn about electronic voting.

Database Queries: Earlier this month I was approached by Jim Taylor, Janice Aiken and Paula Kilgore regarding our database capabilities and the ability to track information and query for special reports. Sadly we are pretty limited in our capabilities. We currently use ACT! which is a contact management program designed for use in a sales environment. ACT! is a great product used in the correct situation, however, we are not the correct situation. When I was at the CAI Conference in Las Vegas, I started investigating some of the HOA software solutions. I was learning about the features and benefits each offered and how they might apply at Woodburn Estates & Golf. These packages offer many data collection opportunities over and above accounting. Some of the features include compliance and architectural records, property histories, standardized

letters, as well as the ability to customize the information we capture and the reports we can generate. Most of these packages are "cloud based" so those with permissions could access from their home computer or from a "smart" device. I am continuing to investigate options to determine what might best meet the needs of Woodburn Estates and our board.

Banking Options: I have also been in discussion with representatives from Alliance Bank, a bank focused on HOA communities. There are some issues with our current banking processes and working with a bank specializing in HOAs might offer some advantages. There are three other banks that are closely tied with HOA organizations and I will be looking at them as well.

Some features I would like to see for WEG include the availability of a "lock box" where members send their payments to the "lock box" and the bank then reports payments electronically to WEG.

Monthly Payments: I am also investigating providing the option for monthly payments as a means to manage our cash more efficiently and reduce the number of required banking relationships because of the FDIC \$250,000 insurance maximums. Monthly payments would align better with our cash usage and make cash management easier. Monthly payments will be easier for our members as well. No one wants a relatively "big" bill right after the holidays. Monthly payments would reduce the number of payment plans necessary to assist members with their budgeting.


Memberships: As a means to increase revenues and involve more members the board is investigating new membership categories. The current categories are exclusive and do not meet the needs of many members or associate members. By increasing members through expanded membership categories we will increase revenues.

Golf Is Fun – The New Mantra for Golf at Woodburn Estates & Golf: Your board is working to bring more fun and excitement into golf at Woodburn Estates.
