



#### President's Welcome: Jim Taylor

In the past few months, the Board has received more input and suggestions from our owners than I can remember in a comparable period. As always happens, we are urged to support both sides of any issue that affects the membership. In some instances, we find that local, state or federal regulations dictate the direction we must go. And in others, input from our legal counsel helps us to ensure that regulations we are considering are consistent with laws, customs, and standards for HOA's. And regardless of the outcome, some are sure to be unhappy with the results, while others applaud.

As everyone is aware, we recently sought legal assistance regarding whether allowing owners to rent a room in their home was legal, given the severe restrictions on home rental that our Declaration of Restrictions dictate. This request was made based on what seemed to be considerable support for the idea. A later, more inclusive survey of our membership proved the opposite. While the initial opinion was that room rental was permitted, questions remain regarding what restrictions we can place on the practice, or even if we can prevent the practice. As a result, we are continuing our discussion with legal counsel to ensure we fully understand what can or cannot be done. When that is fully understood, we will fully inform our membership and appropriate regulations will be promulgated.

Approval of the minutes: President Taylor requested a motion to approve the minutes of the May 22, 2018 General Board Meeting. President Taylor asked if there were any corrections or additions to the minutes. Moved, Seconded and approved with corrections, deleting names in complaint heard at April general meeting.

#### **Treasurer's Report-Director Chuck Johnson:**

The balances reported today were reconciled with bank statements and balance sheets/ledgers provided by the Association's bookkeeper as of April 30, 2018.

Our Operating Account balance as of April 30, 2018, was \$1,040,639.60.

Our Reserve Account balance as of April 30, 2018, was \$704,226.42.

The Accounts Receivable statistics presented today were determined as of May 17, 2018. On this date, the balance of our Accounts Receivable was \$66,500.88, an increase of \$6,111.01 when compared with last month's report. We currently have 56 delinquent accounts, an increase of one additional delinquent account when compared with last month's report. Our attorneys continue to handle 2 delinquent accounts in an effort to collect the money owed to the Association. These two delinquent accounts now total \$10,387.26. Five delinquent properties were foreclosed on and are now owned by a bank or other lending institution. The total amount owed to the Association due to the delinquent accounts of the properties foreclosed on is \$14,188.77.

In today's Executive Session, I will be presenting a previously approved payment plan wherein the home owners have asked for a modification as to this payment plan, citing unforeseen financial difficulties for the reason for the request for modification. The Board will then consider if the modification as requested is feasible and if the request should be approved.

**Director Johnson:** I move to approve the treasurer's report as reported. Seconded, and approved.

#### Golf & Greens-Director Paula Kilgore:

Golf Rounds as of April 30, 2018: Total rounds played 4101 up 1396 more than April year-to-date in 2017.

*The May 14, 2018, Greens Committee Meeting:* 

On our agenda was Golf Course Superintendent Tim O'Larey's report on the course and projects.

Northwest Tree Service was here in April and pruned several trees and removed the damaged pine tree by the Pro Shop as well as a diseased Poplar on #6. Stump grinding will be in May and the areas will be cleaned up and planted as time permits.

#11 old cart path will be filled in and sod will fill in the area. Currently the area is ground under repair. The back-tee box will be extended to meet the front golf

Drainage on #12 and #17 are complete. Cart path paving will begin May 21, 2018 and be completed by June 1, 2018.

Yardage markers removed on the course and the decision to add flexible markers at the 100 yards only and leave the 150-yard poles and ground discs in.

Aeration of the course for spring has been completed. The company, Reject was a cleaner process and hopefully can be budgeted for next year. Greens have been improving daily.

Upcoming projects remove bunker on #1 slated for September. Hedge planted

between #8 green and #9 tee box, for safety. Number 9 tee box to be shortened and made wider; removal of dying arborvitae.

Request from Homeowner to have a shrub planted by his home on #14 discussed and we have decided not to proceed with it. Thank you for the idea and the offer.

Request for free rounds of golf, from Family Golf and The Car Show for door prizes give away, was approved.

Tournament schedule change discussed. There seems to be some confusion as to who makes the schedule and who approves. I would like to make this clarification. The Director meets with tournament committee and anyone else who wants to have a tournament here at WEG in August of the current year. The dates of tournaments are decided at that time and will be submitted in September for board approval. Any changes to that schedule must come back to the golf chair in written form requesting the change and why. The Pro Shop is not in charge of scheduling and all Member events will take precedence over outside events. Glow Ball is not on the schedule, but we will be meeting with Friday Funnies to discuss a date.

Event Insurance was discussed, and I will submit questions at this meeting.

#### House and Safety-Director Dawn Cole:

Project update for 2018:

- 1. Blue Room update starts May 21 and completes June 11, or hopefully sooner.
- 2. Exercise Room project will begin the last week of May. W we just received the permit. Frank Jameson is working on alternate parking for golf carts during construction. The current Exercise Room will not be closed during construction, and the project will take approximately 12 weeks to complete.

The following Safety Items were covered:

- 1. Two converter boxes had to be ordered for the new lights and the second should be here next week, we are installing 12" red LED light bars at the entrance and exit of the golf tunnel to hopefully improve the visibility.
- 2. In the last two months we have had two attempted assaults reported on the golf course, one on the back nine and one recently in the tunnel. **Publications/Communications-Director Allan Lindberg:** Last month the web page shut down because we had reached the maximum storage capacity, which I reported at the board meeting. Further checking with YG Media Technical support, I learned our Go Daddy hosting storage limit is 128 MB. It is time to upgrade our hosting service one step, which will provide us with 60 GB storage. The biggest upgrade is the memory which doubles from 1GB to 2 GB and will make our web page run faster. Our current monthly cost is \$16.99, and the new cost will be \$30.00 per month. I have already spoken to both Jim and Tom about this before moving forward.

**Motion 1 - Director Lindberg:** I move to increase our web storage capacity from 128MB to 60 GB, which will raise our monthly charge to Go Daddy from \$16.99 per month to \$30.00 per month. Budget line item 6-6005-web site. Seconded and approved.

Last month there was an outside function using the auditorium and the group unplugged the digital display. This is not the first time someone has unplugged

the digital display. We need to have an electrical outlet located directly behind the display.

I am asking Dawn to pursue getting our digital screens direct wired so that the connection is not unplugged when a group comes in and by using available plugs disconnects the digital screens.

The Show and Shine Car Show is scheduled to take place on Sunday, July 8,, 2018. The event has been promoted by Diana and myself by attending local car shows including Salem Roadster Show, Albany Winter Rod and Street Show, Jefferson Flower Festival, Fire Hall Breakfast & Auto Show and Kool April Nites week-long Classic Car Show in Redding, CA.

Don Watcher, a member of the car show committee, passed out over 100 flyer registrations at KeizerFest Car Show on May 19.

Lowell King of KISN Radio 95.1 FM, also a member of the car show committee, has passed out over 100 flyers at two car show events this year and will be plugging the Show and Shine Car Show on the air during the one week prior to the show.

Awareness of the Show and Shine Car Show is growing and at this time, we have 21 cars preregistered, which is twice the amount of last year at this time and in 2017 we had over 100 cars participate in the Show and Shine Car Show. Talking to car owners at the shows we have attended they tell us they often wait until a couple days before the event to see what the weather has in store before deciding if they will attend.

My concern is with this growth in interest and awareness, we will outgrow the west side parking lot which has 138 parking spaces. I would like to close off hole one and use that area to park cars if needed. I have talked with our golf course superintendent to see if the rough or fairways would support the weight of automobiles and he said yes.

#### **Board of Directors Meeting Minutes (Cont.)**

**Motion 2 - Director Lindberg:** I move that we close hole one from 7:00 a.m. until 3:00 p.m. Sunday, July 8, 2018, the day of the Show and Shine Car Show, to park show cars entering the Show and Shine Car Show if the west parking lot fills up and more parking space is needed for show cars. Seconded and failed 7 nays to 2 yay.

Director Lindberg: Under ORS 94.625 (C) this is my written notice as a member in good standing to cause the Bylaws to be updated and recorded as at least some of the Bylaw changes have been amended over 180 days ago. I am also asking for the Rules and Regulations and Standard Operating Procedures (SOPs) to be updated.

Per Director Aiken: All have been updated, they are awaiting further action, proofing, printing, recording etc.

This section, ORS 94.625 - 3. (B) (c) also states: The 180-day period specified in Paragraph (a) of this subsection may be extended as necessary if the board of directors is unable to record the bylaws for justifiable reasons.

Justifiable reasons: All documents were sent to us in PDF, which we could not make additions to, and needed to be converted to Word. Also reformatting was needed. After updating, the Bylaws were sent to the Attorney for review. We received them back with corrections to be made which has been completed. The Index is now being updated. When this is completed the Bylaws will be presented to the Board for approval.

#### **Rules and Regulations-Director Janice Aiken:**

Rules received sixteen (16) new complaints and closed twenty-two (22) complaints. Total complaints remaining open fifteen (15).

Motion 1 - Director Aiken: Mr. President, the Event Insurance Resolution that has been posted since our last Board meeting, has been modified. I move that the modified Resolution be posted until our next Board Meeting. Motion seconded and approved.

**RV Lot-Director Jim Taylor:** No Report. **General Manager Report-Tom Staskiewicz:** 

CAI National: I appreciate the support of the board in allowing me to attend the CAI National Conference earlier this month. I continue to learn from the presenters and the other attendees information I can bring back to Woodburn Estates & Golf to improve operations.

This conference enabled me to talk with individuals in Senator Merkley's and Wyden's and Congressman Schroeder's offices about issues we face at Woodburn Estates & Golf. Some of the topics discussed were:

- The traffic on OR214 and the accidents and dangers presented to our members:
- The increased traffic congestion in Woodburn as the new developments come on line and the apparent disregard from the City, State and developers;
- The lack of planning as the sound wall was built and not extended to the end of the WEG property; and
- The squatter and homeless issues and the way banks are handcuffed for acting on abandoned properties along with the challenge of determining the mortgage holder on these properties.

These are all new issues and a start to the process of bringing the necessary attention [to them].

I was amazed at the number of individuals and groups seeking time with our representatives. It was a constant stream. There is also an incredible lack of space for them and their staff to work. Two of my three meetings took place in the hallway outside their offices.

Wednesday of the conference, I had the opportunity to have a personalized demonstration of the new accounting software I am recommending. My goal was to see features demonstrated that are needed to meet board reporting requests.

Wednesday, I also met with the president of Alliance Association Bank, Craig Huntington, regarding bank offerings. During the discussion I learned how the switch in banks can save us over \$13,000 per year in credit card fees and how we will be able to offer our members ACH payment process for direct payments from their accounts reducing the workload on the office staff.

Thursday, I was in several meetings and the keynote session. One meeting that stands out was about Social Media. As you know, we have a Facebook page, but you might not know we can control the content in the event something inappropriate is posted. If there is bullying, inappropriate language or other objectionable posts we can take them down. We have control. However, on sites like Nextdoor Woodburn Estates we do not have that ability. Those sites are managed by Nextdoor or some local representative and we have no control over the content. This is not an official Woodburn Estates & Golf site.

There was a recommendation that all HOAs create a standard for what is appropriate content and make the information available to anyone who might choose to post on the sites where we have control.

#### **Board of Directors Meeting Minutes (Cont.)**

Friday, I attended a session pertaining to the HOA industry and the challenges faced as the number of HOAs continues growing at exponential rates. Municipalities today look to HOAs as a means of offloading oversight of communities to the HOA organizations. The cities and towns are spread too thin and the HOAs relieve them of some of the burden. There is a continued push by municipalities for more Home Owner Associations.

Another meeting I attended was a leadership group for Large Scale HOAs. This is a select group of HOAs with over 1000 units and a \$2,000,000 budget for operating and reserve. Large Scale communities have unique challenges as they work to meet the requests of many segments of their communities. Balancing the requests of one group with those of another can be a challenge as we so often see. It is valuable to get the perspective of these other managers to learn how they handle situations.

Tulip Tee Off: The Tulip Tee Off was a success, raising \$3000 after ALL expenses (including green fees and cart rentals) for the golf program at Woodburn High School. The money will be used for scholarships for three high school golfers. In addition to the scholarships my objective was to demonstrate to members the ability to obtain additional sponsors. There has been a belief the sponsor pool was limited to a few Woodburn businesses, but this is not true. The sponsor pool is much larger and getting a sponsor for one event does not mean we have to cannibalize sponsors for other events.

*Insurance*: Insurance has been a topic of conversation for the past few months and for that reason I invited Paul Quandt of HUB insurance to attend today and address some insurance issues. HUB is an insurance company specializing in insuring HOAs. We have made a change from our local broker to HUB because of the added value of both a much larger agency and their HOA expertise. What are other HOAs doing about insurance and how are they handling the challenges? Paul will give us some insight on the topic.

Why the change? The insurance discussions have centered on event insurance and our current liability and umbrella coverage. Although we have not had a significant claim, on April 25, Darrel Mendenhall came to the office and told me our umbrella coverage had been reduced from 5 million dollars to 1 million dollars. On April 26, I was scheduled to attend a CAI event in Portland and while there I went searching for insurance options with a specific HOA focus. I found two and put out requests for meetings. Paul responded so we met to discuss our current policies, claims we have had and the reduction in our umbrella. With a short time frame before renewal on June 1, it was imperative that I make a move immediately. My discussion with Paul brought to light many advantages his firm offered, and I made the switch. For 2019, I will be going out for additional proposals, but that door was closed for 2018. We needed answers now!

Introduction of HUB Insurance and a question and answer period for the board.

I would bet many of us residents came from neighborhoods with sidewalks or from the country where we could safely walk our dogs in the summer. We've had a few hot days lately and I have seen folks walking their dogs in the heat of the day. I have enclosed an article from HGTV Magazine dated July/August 2018. I hope it will educate everyone to how dangerous the pavement can be in the summer.

#### Q: How bad is it to let your dog walk on hot pavement?

Your pup's paws may have padding, but it's not nearly as protective as human shoes, and scorching-hot pavement could cause burns. You might not even realize what's happening: "Dogs can be very stoic about pain, especially if they are distracted by the joy of exercise," says Ari Zabell, a veterinarian at Banfield Pet Hospital in Vancouver, WA. "They may continue to play until they have painful open wounds." The best rule of thumb is...your thumb. If it is painful to touch your hand to the ground, head to soil or grass. When there's no way to avoid pavement, toss water on the surface to temporarily cool it off, walk in the shade and keep it quick. You could slip booties on, though not every pooch will tolerate them. If you suspect there's a paw burn, get to the vet: A dog could make it worse by licking and chewing.
