All members may ask the office for copies of the requested changes and have the opportunity to review and ask any questions - which should be in writing - and addressed directly to the Rules Chair Janice Aiken.

2018 Annual Meeting

It may seem early to talk about our November Annual Owners meeting, but there are several specific due dates for things to get accomplished prior to that meeting. I've listed those due dates below:

1. New business requested by owners: Any new business requested by Members to be considered by the Property Owner Members at any annual or special meeting shall be: **A motion, concisely stated in writing, and signed by the requesters. The motion shall address only one subject that is not inconsistent with Oregon Law, the Articles of Incorporation, the Bylaws, the Rules and Regulations or the Declaration of Restrictions, and shall be delivered to the Secretary at the Corporation office for notice and publication at least sixty (60) days prior to the date of the meeting.** Our 2018 Annual Owners meeting will be held on November 13th. Sixty calendar days prior to this day is therefore **September 14, 2018.**

2. A notice shall be prepared stating the date, time and place of the meeting. **This notice shall be delivered neither less than ten (10) nor more than fifty (50) days before the date of the meeting.** That means the notice must be delivered to voting members between **September 24, 2018 and November 3, 2018.**

3. **Nominations for open Director positions, either by the Nominating Committee or with the signatures of twenty-five (25) members in good standing, shall be delivered to the Secretary at the Corporation office at least forty (40) days prior to the annual meeting.** That means those nominations must be to the Secretary no later than **October 4, 2018.**

4. The Agenda for the meeting shall list separately each matter or item to be considered at the meeting. **The agenda shall be posted at the Corporation office in the club house thirty (30) days prior to the meeting and delivered to the News & Views for publication.** That means the agenda must be posted **October 14, 2018.**

5. **Quorum proxies must be received by the Business Office by 5:00 p.m. on the day before the election.** That means the proxy must be received by the office no later than 5:00 p.m. on **November 12, 2018.**

6. **Ballots must be received at the Business Office by 5:00 p.m. on the day of the election.** That means the ballots must be received by 5:00 p.m. on **November 13, 2018.**

Obviously, the most time limiting due date is that for new business requested by owners. But, to ensure any requested business meets the specific requirements set down in our Bylaws, work on creating the desired motion should really begin much earlier than September 14. Work by the Nominating committee or individuals obtaining owner signatures should also begin early in order to meet the October 4 due date.

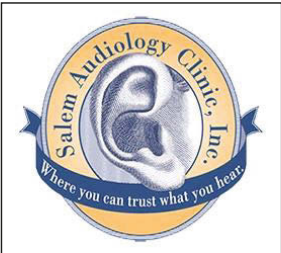

We have had a rash of solicitors in Woodburn Estates recently and many members have expressed their frustration and disappointment. Sadly, there is little the Board and Office can do as well as the City of Woodburn.

In the past, the City had ordinances regarding solicitors like many other communities, but these ordinances have been challenged in Court and the Courts have deemed the ordinances to be a violation of the individual's right to Free Speech. This means the cities cannot do anything from an ordinance perspective however, they can enforce violations when you have a No Soliciting sign posted and the solicitor approaches you regardless.

If this happens, you can report it to the Woodburn Police Department's non-emergency number at 503-982-2345. If possible take a picture of the individual as well. The Code Enforcement officers will respond and the fine for violating your right to no solicitors is \$750.

President’s Report: President Bourne welcomed the members to the Meeting and began his report by stating that the winner of the Spring Handicap Tournament was Jerry Radaford. The Club will purchase a jacket for Jerry as is the tradition within the Club for the winner of the Spring Handicap Tournament. Treasurer’s Report: Treasurer Allan Lindberg provided the following report: Beginning balance on May 31st...\$3,931.58...Checks & Payments made...\$560 to the OGA and \$36 for donuts. Deposits...\$274...Interest of \$0.16...Ending balance as of June 30th...\$3,609.74. As of June 30th, we have 135 members in the Men’s Golf Club. The fifty/fifty raffle balance as of June 30th is \$489. The Voucher Fund was balanced on June 30, 2018, with the bank statements.

Secretary’s Report: Secretary Chuck Johnson had nothing to report.

COMMITTEE REPORTS:

Greens: Representative Dean Lambert was absent. No report.

Handicap: Co-Chair Russ Krussow had nothing to report.

Mixed Tournaments: Representative Fred Bourne reported that there will be a large field of participants in the July 4th Tournament. He reminded members of the Mixed Tournament scheduled for July 21st. He reported that everything is going well, including the needed volunteers.

Rules: Chairman Jim Hutchinson discussed the rules of Match Play.

Sunshine: Chairman Ron Gripenstraw reported that he sent appropriate cards to Jerry Egan and Don Peters.

OGA: Chairman Paul Eaton was absent. No report.

Membership: Chairman Stan Hiller was absent. President Bourne stated that Stan had reported to him that a total of 245 golfers have paid the annual fee. This represents a decline of 27 golfers when compared with this time last year.

UNFINISHED BUSINESS: Nothing to report.

NEW BUSINESS: Fred Bourne announced that the annual End of Watch Tournament is scheduled for August 11th. There will be a sign up sheet posted in the Pro Shop. Entry fees are \$40 for our members and \$50 for guests. There will be Mixed and Women’s Teams in the tournament. Participation last year included 14 teams from the Ladies and Men’s Golf Clubs. Fred then reminded the members of the annual Harvest Invitational Tournament to be held on August 24, 25, and 26. VP Will Abshire stated that there is an eight member Ad Hoc Committee exploring a renaming of our DBA and a possible logo change. It was suggested that a survey be prepared and distributed to the members asking for their feedback on these two issues.

CLOSING COMMENTS: Fred Bourne inquired as to the red markers installed on the golf course indicating 100 yards to the center of the greens. Are they to remain as permanent markers or is this a test? The Head Pro and the Pro Shop personnel should be able to answer this question. Allan Lindberg reported that where tree stump remains are located on the golf course, these areas should

be marked as “ground under repair”. Apparently, these areas have now been so marked. Gary Vogue reported numerous unrepaired ball marks are to be found on the greens and the Pro Shop needs to remind golfers to repair their ball marks. Mike Wentworth reported that there are two LPGA Tournaments to be held this year at Pumpkin Ridge and the Columbia Edgewater Golf Course and there are volunteers needed at these tournaments. Anyone interested in volunteering for either or both tournaments should contact Mike.

Door Prizes: The 50/50 Raffle was then held. The total money collected for today’s raffle was \$74.00. President Bourne held the winning ticket and split the pot, winning \$37.

Closing: President Bourne asked for a motion to adjourn our Meeting, the motion made, seconded, approved, and the Meeting was adjourned at 10:45 AM.

Harley-Davidson

It will turn the head of every normal male Human Being... But Spiritual?

Hogs? Spiritual? Just be patient. In the motorcycle world, Hog means “Harley Owners Group”. One billion members in the 1400 chapters around the world are riding the famed Harley-Davidson motorcycle, and occasionally experiencing heightened Spiritual Awareness. Still skeptical? Read on.

When we flow with nature, we are on a high, with a clean mind, and no tension. This state can be measured on an EKG brain wave analyzer indicating a frequency of 8 to 14 Hz. In 1981, the company was sold to 13 investors for 80 million dollars and led by Willie Davidson.

The book I refer to, ‘Tao of the Ride’, has testimonials of dedicated Harley riders. I will include one by Dr. Horst Birkoff, a German dentist: Motorcycling kind of takes me back to my roots. When I was a 16-year-old boy, I got my first motorcycle. It was a small 50 cc Kridler, but I went on a two thousand mile trip through Germany, Netherlands, Belgium, France, and Luxembourg. Even visited Paris with it! Since I was raised in a small town, this 50cc Hummer enlarged my world. For the first time in my life I could go wherever I wanted. I was free! Even today, more than twenty years later, I still remember that first ride out of my hometown with the sun in both mirrors! And I still get that feeling of freedom, and everyday sorrows just disappear with every beat of the big V-Twin under my butt. Interestingly, Harleys seem to work better with that kind of Bier philosophy. I have ridden all kinds of bikes and liked most of them, but there’s nothing compared to my Harley. Don’t know why. Maybe the rumble of the V-Twin is kind of synchronized to the human heart beat? Hell, who knows? Doesn’t matter anyway, it’s just pure, plain fun feeling good! It clears my heart and soul! And for me it’s the key to meeting interesting living people who live and feel like me and the platform to meet the best friends you will ever have.

Director Communications and Publications

I have other questions on behalf of our members and myself. *[Allan’s questions & concerns are followed by response in italics.]*

1. Members are confused on which set of documents are the correct version. There have been many changes to the Rules & Regulations, By-Laws, and SOPs. There have also been Resolutions and fines lists made and changed several times. It is time to update our documents and publish the new documents for our members. The Communications committee posts the most current governing documents on our webpage under the Forms Heading when they are provided to us by the Rules committee. *Attorney has paperwork and we are awaiting any corrections, Director Aiken.*

2. I wonder how many of the board members are using the most current version that has been provided by the Rules Committee dated 2017, or if they are using an older version? How can the board continue to vote on changes to the documents and the Schedule of Fines if we do not know what they are? I have not seen the updated Schedule of Fines Attachment to the proposed Resolution since it was posted on November 2017 and passed in January 2018, and yet many changes up and down have been made since then. If the board cannot follow what is going on, how can our members? *Bylaws and Rules approved in 2018 are currently being added to 2017.*

3. Under ORS 94.625 (C) this is my written notice as a member in good standing to cause the Bylaws to be updated and recorded as at least some of the Bylaw changes have been amended over 180 days ago. I am also asking for the Rules and Regulations and Standard Operating Procedures (SOPs) to be updated. *SOPs are [updated] and are to be printed. Adoption of the initial bylaws.*

4. I am hearing that the Rules Committee members no longer visit a member in person but that members are called from the office or they get a letter. I do not know which is true. Quoting the most current version of the documents that the Board is working with, our Rules and Regulations dated 6/27/2017 state that a system for processing notices will be established by the Rules committee.

a. The most current SOP available to the board is SOP version ONE, dated 7/25/2017. Under enforcement 2.7.3, it states that the “normal” procedure starts with a personal visit, by two members of the committee, with hope to resolve the issue at the first meeting” and then it goes on to say what the additional steps might be. The above procedure has been the normal procedure for many years. *Complaints are processed as written.*

5. Will the beds around the building be planted with flowers this year? Our budget allows for maintenance around the buildings, which should include yard and flower bed maintenance. I know that volunteers have made the beds ready, planted them and maintained them for a long time, and I want to say thank you. Is it now time to make that part of our regular maintenance and presentation?

a. 6-2000 Maintenance has line item 6-2055 Clubhouse Improvements budgeted at \$250 and 6-6000.

b. Office Expense line item 6-6035 Lawn Care Expense is budgeted at \$1,000.

c. We have budgeted over \$20,000 for marketing and branding this year so why not spend \$800 to have the flower beds planted so we look good for prospective buyers?

d. Do we need to get a line item in the budget to cover the cost of plants? Several years we have had a solid line of flowers along with all the beds on the front of the buildings. It was beautiful. *Director Butts reported the Green Thumbs, a volunteer group, is donating time to do these areas.*

6. Members are saying that we, as the board, are jumping from subject to subject with the ratification of new processes or rules or changing the processes without ratification. Our members are also saying that the atmosphere is currently very negative with threats of *Good Standing* being taken away.

Our Bylaws state: “A member in good standing is a member fifty-five (55) years of age or older whose dues and assessments are fully paid and who is not in violation of the Restated Articles of Incorporation, Bylaws, Declaration of Restrictions, or the Rules and Regulations.” Therefore, anyone found to be in violation of one of our rules and being fined, is already not in good standing.

7. Before presenting new rule changes we need to investigate a subject, such as event insurance or renting a room. Before these subjects are talked about to our members, we need to see if there is a NEED and the legal ramifications of our conversations.

a. Does the example that has been used about lawsuits apply to Oregon State laws?

b. The lawsuit that has been raised as the reason to talk about event insurance was a lawsuit about **negligence for maintenance** not done and had nothing to do with alcohol or activities.

c. These continued mishaps and “rumors” are out of control and reflect badly on the board and our association.

Often, the need for a given rule is brought to our attention by those we pay for opinions, such as our Insurance Broker. And while the example that has sometimes been used is for negligence, there are many examples for the need for an insurance rider for other reasons. In my case, I’m associated with several organizations that require event insurance for anyone using their facility if the event includes alcohol. That insurance has often paid for damage to the facility that occurred during the event.

The issue of room rental was brought up, first by an owner, then discussed at length via the Good Neighborhood website. Most of those comments were derogatory of the Board for being so callous as to have a rule that could force an owner to move due to financial difficulties. A legal opinion was then requested because previous practice had been to prevent such action given the severe restrictions on home rental. It was thought if an owner could not rent their home (except under some very limited conditions) it was probably illegal to rent a room in their home. We asked for the opinion simply to have an answer to our owners.

8. I am having problems with “all of these legal opinions” that are being quoted, but as a board member, I am not seeing those opinions. If I am making decisions based on legal opinions I would like to make the decision on the actual opinion. I would also like to know the costs that have been spent on these opinions, sometimes before we have had an open board discussion to see if we want to go forward.

Every board member has a right to view any legal opinion we’ve received. They are not to be copied to the membership, as the Attorney/Client privilege issue is between the Attorney and the Corporation, represented by the Board, not by the owners. If any board member has heard of a legal opinion and would like to read it, please see Tom at the office. Costs for legal opinions are an expected Corporation expense, and it should not be a surprise that we pay for the work of our Corporation lawyer. I do know that Angie has provided some of the opinions at no charge.

9. This year we do not have a Marketing committee, but the language for the General Manager’s job description was expanded to include marketing although marketing is not used in the Bylaw change made on March 26, 2018.

a. I see that more than \$4,000 has been spent out of the budget for marketing.

b. How many New Associates have we gained from the marketing program?

c. Our BYLAWS 5.8-7 still state that our committees are to be headed by a Board member.

d. The Pro Shop has a selection of clothing including hats, shirts/blouses and the Tulip Tournament that just finished had a special ball marker made that is currently on sale in the shop for about \$15.00. All these items have a LOGO with a “W” and the tree from hole 11. Approval for a new Logo has never come to the board. Why? I heard a few board members said they had seen it and thought

it looked good. Is that all that is needed now for something to be changed? *These are a prototype. Director Kilgore is in process of meeting with Ad Hoc committee regarding this Issue.*

10. It is my understanding that 44 people participated in the recent Tulip Tournament and I understand that we rented carts for the event even though most of our members had their own carts and the Association owns 6 carts.

- a. How much was spent on cart rentals?
- b. Before it is said, I have already heard that we had hole sponsors and that a contribution was made to the junior golf which I support out of the sponsorship money.
- c. Although our Bylaws 5.8-7 still state that a committee is to be headed by a board member, this bothers me as to transparency. Because there is no Marketing committee, who is getting the final report on this event? The event was not run through the Golf Committee, the Men’s or Women’s Golf Clubs or through the Activities Committee, as far as I know, so who authorizes the expenses, the paperwork, the billings, and the monies out?
- d. What was the advertising cost for this event in the various newspapers? *All costs incurred from the Tulip Tee Off were paid by the sponsors and attendees.*

11. **Past Practice** has seemed to go out the window this year. Not only have we changed the approved budget for this year on at least two occasions – Marketing and now the Blue Room remodel – but we are not making motions to move money as we have done in the past so that members may follow what we are doing.

a. Last year we made motions at the board to move approved budgeted money. This year there is obvious money being spent on the golf course, around the buildings, on marketing and more, but there is no mention of the movement of the money. I do not disagree with the concept that approved money can be spent, but again I ask when and how did these procedures change with no explanation? Where is the **transparency**? *The monies being spent from the reserved budget were approved last November. We will bring these forward as money is needed. The money does not have to be re-approved as it was approved in the budget. Reports are made when that money is spent. Money for Reserve expenses is transferred from the Reserve Fund to the General Fund to be spent. The practice of moving money to pay for unexpected problems is not new and one of the duties of board members. Examples include replacement of the HVAC systems over the Restaurant. The work on the Blue Room was at the request of a number of our owners so that food and beverages could be allowed in the room, and provide another location for gatherings such as birthday or anniversary parties.*

b. Recently our general manager went to an HOA conference in California and he just got back from an HOA in Washington D.C. I asked Jim Taylor who authorized the D.C. trip as the decision to spend that money or another week out of the office had not come before the board. I was told that Jim signs the checks and that he had authorized it. Yes, we do have a line item for education and travel, however, how much of that line item has been spent as of today? I must question the need to go to Washington DC for our HOA in Oregon especially when our general manager is attending local meetings with another close by associations with similar Oregon rules and interests. Where is the **transparency**?

Our GM’s contract calls for him to continue to attend CAI conferences and continue his training in HOA general manager duties. As President I review any expense accounts submitted by Tom. I carefully ensure that only work related expenses are included. If he takes a family member when he travels to a meeting, it is at his own expense. The meeting in DC was a unique opportunity to visit with our elected representatives to voice specific concerns our HOA has with respect to current conditions or pending legislation. Some conferences for large HOA managers are located at some distance as many states have far more large HOA’s than Oregon.

12. An additional question about money – last month our general manager reported that the bank accounts are being transferred to Alliance Banks. There is no Alliance bank in Woodburn. How will this process work with the new bank regarding current daily or weekly deposits? *This was in GM report at the April meeting and we are in the process of changing, but currently are still with the local banking institutions. We are working to establish a meeting at which Alliance personnel can be present to answer Board questions.*

13. Discussion among board members is an important part of the meeting. I know there are some board members spending a lot of time in the office and may be discussing issues. If, and when five or more board members are together at the same time it is considered a quorum. The same holds true for board members who are emailing each other. It appears that this year there has been outside discussions by part of the board and including the general manager where decisions have been made. Perhaps not all the parties were together at the same time, but things are happening, such as the approval of the Bench Craft book where 5 board members were reported at the board meeting to have approved the draft that was later pulled. The 2018 printing of the Bench Craft booklet never came before the main board and I am only bringing it up as one example. *Director Kilgore: there was never a motion for the Bench Craft booklet because it doesn’t need board approval. It is free to the Estates because the advertisers in it pay for the printing.*

Great pains are taken to ensure that we don’t have five or more board members in the office at the same time. If four are present when a fifth arrives, one will leave just to ensure a quorum is not present. As far as discussing issues between two board members, that is part of the process of determining how our owners feel about issues facing the board. If I’ve had owners comment to me about an issue a specific board member is working on, I transmit that information to him/her. I also ask the owner that contacted me, to contact the appropriate board member

directly. I don’t know of a single instance when a decision has been made by a quorum of board members prior to a meeting. In many cases, we don’t even see the wording of specific motions until the day before or even the day of the board meeting.

14. We as a board rarely hold a discussion at the board meeting following any board reports. However, at the April 26th board meeting when it came time for discussion on the Lap Swimming Lane motion, I spoke in opposition to the motion and the President then asked if there was anyone in favor of the motion. This was the first time that I have heard President Taylor ask for an opposing view of any discussion in the two years he has been President. The President’s role under Roberts Rules is to keep order, be fair and impartial, not to ask for opposition to one of the board members.

As President, I try to always give an opportunity for someone to speak up after a report or motion. If someone is slow to speak up, I’ve still stopped further reports for that board member to have his or her say. I don’t believe it is necessary to have an extended period of silence after a report waiting for someone to speak up. In general, if there are two sides to an argument, those who made the motion have the first opportunity to speak. Those opposed to the motion speak next; then alternating back and forth. Often, a limit is placed on the number of total speakers and speakers are usually cautioned not to repeat what others have already said. In general, we tend to be less formal and often, there are no opposing sides.

15. I appreciate, as do our members, that open mic (microphone) has now been moved in front of the executive session so that they may speak. I am getting complaints that the board minutes are not reflecting what was stated at the mic and that the President is rushing the open mic session. The Board of Directors only meets once per month in open session and this is the only time members can speak to the entire board. I will state that the latest minutes printed in the *News & Views* reported the open mic more accurately.

As has been commented on by many people, including Allan, we do not take verbatim minutes of the meeting. We make an effort to at least report comments made by members, we don’t always catch each subject if an owner covers several issues when speaking.

16. And on behalf of myself, and our Members,
- a. Why are the Board members not asking more questions about these issues? I cannot be the only one that is concerned.
 - b. Are we being shut down by remarks from fellow board members before or during the meetings?
 - c. Are we ignored in and outside of the meetings, or ridiculed when we ask questions?
 - d. Are we being separated from the rest of the board without information?

Swimming Pool Rules

Recently we have been receiving and hearing about many issues regarding children, non-members and guests with the swimming pool and spa. The first rule is non-members are not allowed in the Health Center. Please don't confuse this with guests of members. I'm actually talking about non-members who have found their way into the swimming pool.

Non-Members in the Pool - Yes, we actually have had multiple incidents where non-members have been using the pool. Typically these are young adults who have either tail-gated (followed a member into the pool area when the door was opened), found a card that was not reported as lost, was inappropriately given a card by a family member of a member and other, as yet to be determined, ways. Regardless of the method of entry; non-members do not belong in the pool or any area of the Health Center.

If you see a young adult in the Health Center, who is there without a member, they, most likely, should not be there. What we need our members to do is to report a description, time and the area where the individual was seen to the office. We can check access records and videos to obtain the necessary information to contact the owner of the card, report the incident to the police or take other action.

Recently there was a theft in the locker room. Obviously we don't have cameras in the locker room to catch the theft on tape, but we were able to provide the Woodburn Police Department with the necessary information to identify the non-member young adults who were in the pool at the time. The couple was well known by the local authorities. Help prevent thefts by using and locking the lockers provided. You must have your own lock and locks must be removed when you leave the Health Center to go home.

Children in the Pool - As a convenience to our members we allow their children, grandchildren and great grandchildren (you get the picture) to use the pool under the following guidelines.

- Children ages 4 – 17 must be accompanied at all times by a member.
- Children are only allowed in the pool between the hours of 11 a.m. and 2 p.m.
- No running, jumping or diving.
- Respectful of others who may be in the pool or sitting in the area.
- Children must use the appropriate locker rooms.
- Children are not allowed in the spa for any reason (the temperature is too hot for children)
- No diapers.
- No food or drinks in the pool area.

Guests in the Pool - Again as a convenience guests are allowed to use the pool under the following guidelines.

- Guests must be accompanied by a member at all times.
- No running, jumping or diving.
- Respectful of others who may be in the pool or sitting in the area.
- No food or drinks in the pool area.

Locker Room Behavior - The locker rooms are for the convenience of all and part of this is ensuring all have access to the changing areas. After changing into your swimwear please put your clothing in one of the lockers and use your own personal lock to lock the locker. We have had occurrences where items have gone missing and the best solution is to place your clothing and personal items in a locker and lock the door. If your items go missing there is nothing we can do other than report it to the police but without visual proof of someone removing an item there is little the police can even do. The best solution is to secure your items in a locker. All property and locks are to be removed when you leave the locker room to go home.

Towels, Clothing and Personal Items in the Pool Area - The chairs in the pool area are for parents and others to sit while attending to children or guests in the pool. Please don't use the chairs for towels and personal items; leave them open for people to sit.

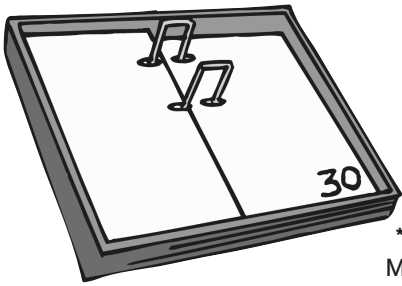
