

# **Swing Speed** Shuffle

This reprinted article highlights our golf course and was in the October 5, 2018, issue of the USGA, Green Sections West Region which is read Nationwide. It tells how we are a forerunner in our approach to making golf fun again for all ages. Paula Kilgore, Golf Director

Properly positioned forward tees offer golfers the ability to play from tees based on their swing speed; a good way to improve pace-of-play and golfer

The Tee It Forward initiative is one of many ways to encourage improved pace of play and golfer enjoyment. Golfers can use swing speed data collected by the PGA and the USGA to estimate which set of tee markers to play based on their game. Unfortunately, many insist that they must play golf from a certain color of tees or from tees that play a minimum distance. Some simply resist the notion of moving forward. Woodburn (Ore.) Estates & Golf took a creative approach to addressing these challenges.

Woodburn Estates & Golf is in the upper end of Oregon's Willamette Valley. A retirement community, their golf course plays 5,398 yards from the back tees. The course is a perfect distance for many male players, but the forward tees were far too long for the players with a swing speed of 60 MPH or slower. Often, golfers playing the forward tees were left with long fairway-wood shots into greens. To provide a proportional challenge for golfers with slower swing speeds, Woodburn decided to add a complete set of forward tees that play 4,064 yards. The new tees were well received by female golfers with slow swing speeds, but many golfers still resisted the idea of moving forward. With a semi-stalemate to deal with, Head Golf Professional Jason Hoth implemented a simple, unique idea – the Swing Speed Shuffle.

Hoth's initial concept was to hold a tournament played from the new set of tees. The response was less than enthusiastic. However, when Hoth came up with more than \$500 for prizes, it provided the impetus for a 50-player field - 30 males and 20 females. The only requirement to enter the tournament was to submit to a swing speed analysis. Golfers were then assigned to play the tournament from certain tee markers based on their swing speed and not their gender. Nearly 1/3 of the male field was assigned to play the new forward tees. Most of the female golfers also were assigned to play the new forward tees. Even shorter tees were placed in the fairways of certain holes for some golfers to use.

The tournament's goal was to provide golfers with a chance to play from the set of tee markers best-suited to their game based on swing speed rather than gender. Hoth also hopes that more golfers will use the new forward tees as their swing speeds slow. Thus far, the results have been positive. Many golfers truly enjoy the experience of putts for par and birdie that simply did not exist when they played from tee markers that were too long. Ultimately, pace of play and golfer enjoyment are key to moving this great game forward. The Swing Speed Shuffle touches both of these focal points.

- The summer concert series was a great success and we have added one more for Oct 7th, back by popular demand Pin and the Hornets. We will help the dance committee plan and set up. This will probably happen again next summer.
- Coffee hour sponsor and program agendas are full for the year. Our numbers continue to increase every week -90-115. The TV game shows are a great success with lots of audience participation. Any suggestions let us know. This is the last week for school supplies –have already taken large load to administration
- There have been some complaints about the condition of the auditorium floor especially after coffee and golfing banquets. Remember for each event you are responsible for cleaning of floor. ### Greens/Golf: Director Paula Kilgore;

Golf Course Superintendent Tim O'Larey's reported the course updates as follows; Maintenance Mondays is working out well, the crew is able to spray the greens with Fertilizer, insecticide and wetting agents. The trees have been sprayed with herbicide.

All bunkers are being edged. Greens have been Verti-cut and top dressed.

Other projects in the works are hauling the excess dirt from the sewer project to Hole number 12 to start building berms in the area where the cottonwoods were. Drainage at number 17 tee box area in completed. Stump grinding and wood chips have been completed. Ground will be leveled and reseeded when the weather cools downs. The area on number 11 will also be weeded and reseeded in the fall growing season.

Future projects: Trees are to be ordered to replace the 6 removed from the course last year. They will be planted in areas where shade is needed or to improve the view.

Spring Project: We have the bid from Bernhardt Construction for renovations to the tee boxes on #9. #11, and #14. We will be asking a revision on part of the work and will be presented at the Budget meeting in September.

We are asking the House Committee to build a cover over the practice area. If covered, it could be used year-round. We are also asking the House Committee to add a Uni-sex Bathroom off the Golf Lounge in the area of the old locker room/storage area.

Due to a recent accident in the parking lot, I have asked to have the golf cart traffic off of Hole # 18 redirected. Tim has since built up the area after, Frank had the parking lot curb removed to facilitate the process. We will block of the old exit and pave the new part of the path when we have another paving project. I encourage golfers to use the new exit and drive next to the fence back to the pro shop.

The area around the Po Shop needs drainage and will be added to the 2019 Budget.

The USGA Resource Management Tool, aka GPS trackers will be here this month. The trackers are used by all golfers, gender and age are used as well as skill level to see where the players are using the course as well as where they are not. This web-based tool can be used to determine methods of reduced maintenance costs while transferring labor into areas that are being used. If anyone is interested in the entire article please contact me and I will get you a copy.

> **WOODBURN ESTATES AND GOLF** ENFORCEMENT RESOLUTION ("RESOLUTION")

At a regular meeting of the Board of Directors, held on 2018, the Board unanimously made the following findings:

WHEREAS the Association Secretary, by signing below, attests that pursuant to the Association Bylaws, all Board members were provided notice of the meeting and a quorum of the Board of Directors was present in person at the meeting;

WHEREAS the Board has authority to enact rules regarding enforcement pursuant to the Boards' powers to exercise all powers and authority vested in it per the Bylaws;

WHEREAS the Board may establish fines for violations of the Governing Documents and additional penalties for violations not corrected by date set by Board per the Bylaws;

WHEREAS the Board finds that it is in the best interest of the Association to adopt new enforcement policies in order to maintain peaceful enjoyment of the property by all residents;

NOW THEREFORE IT IS RESOLVED that the procedure set forth below shall be used for handling complaints and enforcement of violations of the Governing Documents. PERSONAL CONDUCT VIOLATIONS

Personal Conduct Violations include, but are not limited to, the following types of conduct:

- 1. Any behavior directed at or offensive to others that goes beyond the bounds of good judgment and common sense and that a reasonable person should know would be unwelcome.
- 2. Inappropriate physical or verbal conduct towards others based on physical characteristics, race, gender, sexual orientation or other factors that support inclusion within a protected class as defined by the Oregon Equality Act.
- 3. Bullying or any aggressive, abusive, intimidating, or harassing behavior meant to influence one to act in a particular manner. This behavior may be verbal or physical.
  - 4. Inappropriate or defamatory actions in retaliation for reporting a Violation. Process for Personal Conduct Violations:
- 1. Complaint. Any resident, the Board of Directors, or the managing agent ("Complainant") may initiate a complaint for a Personal Conduct Violation ("Complaint"). The written complaint must be signed and include:
- a. The name of the person whom the Complaint is against ("Alleged Violator") and their address, if known.
  - b. A description of the Complaint, including the date and time.
- c. The name, address, and contact information of the Complainant. This information will be held by the Board of Directors and manager in confidence unless the Complainant authorizes release of this information. The identity of the Alleged Violator will be disclosed if there is a hearing.
- 2. <u>Investigation</u>. The Board of Directors will review the Complaint and determine whether additional investigation or other action is warranted. If the Board determines that it is warranted, the Board will appoint an independent Investigating Committee of five DELETE persons. INSERT members. No Board Member shall serve on the <u>Investigative Committee.</u>

The Investigating Committee has authority to contact witnesses and conduct other investigation that it determines is appropriate. All information compiled by the

report ("Report") to the Board of Directors with a finding that a violation did or did not occur. The Investigating Committee's Report shall also include recommendations for

enforcement, if any.

3. Notice. The Board shall review the Report of the Investigating Committee and decide whether to send a violation notice. The Notice to the Alleged Violator shall be sent at least 15 days before any penalties are imposed or other actions commenced. Such Notice shall be delivered DELETE personally or by first class mail INSERT and by certified mail return receipt requested to the address of record advising that the Alleged Violator may submit a written response ("Response") and/or a written request for a hearing ("Request for Hearing"). The Response or Request for Hearing must be delivered to the Board of Directors not later than 10 days after the date of the Notice. If the Alleged Violator does not respond or does not appear at the hearing, the charges will be deemed admitted, and any penalties or actions described in the Notice shall be imposed without further notice.

4. Hearing. After reviewing the Response, the Board shall schedule a hearing if requested by the Alleged Violator, or if the Board determines that a hearing will be beneficial. Imposition of fines, penalties, and other actions will be suspended pending the outcome of the hearing. The hearing shall be conducted in executive session due to the sensitive and confidential nature of the violation.

a. If the Alleged Violator does not appear within fifteen (15) minutes of the start time of the hearing, the Board may deem that the Complaint is admitted and impose any penalties or actions described in the Notice without further notice.

b. Both the Complainant and the Alleged Violator may present evidence and witnesses at the hearing. The Complainant, if present, shall present the Complaint first, then the Alleged Violator may respond. The Board may limit testimony and evidence as it determines is reasonable and necessary. Unless otherwise determined by the Board, the time limit for the hearing shall be no more than fifteen (15) minutes.

c. Board Determination. At the conclusion of the hearing, the Board will discuss the matter in executive session and will provide its written decision to the Alleged Violator and the Complainant within 30 days of the hearing. A finding by the Board that the Complaint did occur is a determination of a violation ("Violation").

5. Recurring Violations. If the Personal Conduct Violation continues or recurs within 12 months of the date of the first Violation, the process will begin again. However, the fines set forth on the *Schedule of Fines* will be doubled.

6. Remedies. In addition to levying fines as set forth on the Schedule of Fines, the Board also has the authority to impose other remedies including suspension of membership privileges, suspension of use of amenities, and any other remedy authorized by the Governing Documents or applicable laws. In addition, the Board may refer Violations that constitute crimes to the police or other enforcement agency.

The Board may take additional enforcement action, including but not limited to:

a. Seeking injunctive or declaratory relief against any Alleged Violator or any tenant, guest, invitee, licensee, or other occupant of the Alleged Violator;

b. Taking immediate legal action as the Board finds reasonably necessary to stop conduct which it determines is in violation of the Declaration, Bylaws, Rules and Regulations, or any other Governing Document, or applicable state or federal law.

OTHER VIOLATIONS (other than Personal Conduct Violations)

All violations of the Association's Governing Documents (other than Personal Conduct Violations as defined above) will be handled as follows:

1. Complaint. Any resident, the Board of Directors, or the managing agent ("Complainant") may initiate a complaint of a violation of the Governing Documents ("Complaint"). The written Complaint must be signed and include:

a. The name of the person whom the Complaint is against ("Alleged Violator") and their address, if known.

b. A description of the Complaint, including the date and time.

c. The name, address, and contact information of the Complainant. This information will be held by the Board of Directors and manager in confidence unless the Complainant authorizes release of this information.

2. <u>Determination of Violation</u>. The Board will determine, in its discretion, whether the Complaint requires additional investigation by the Board, the Rules and Regulations Committee, and/or the Architectural Review Committee, and whether a Violation Notice is warranted. A finding by the Board that the Complaint did occur is a determination of a violation ("Violation").

3. Notices of Violation. The Board of Directors or its representatives must provide a first notice of a violation ("First Notice") to the Alleged Violator. If the Violation is not remedied or ceased within the time specified in the First Notice, then the Board will provide a second notice ("Second Notice") to the Alleged Violator. The Second Notice to the Alleged Violator shall describe the violation and any fines or penalties to be imposed in accordance with the Schedule of Fines. This Second Notice shall be sent at least 15 days before any fines or other penalties are imposed, and shall be delivered personally or by first class mail to the address of record advising that the Alleged Violator may submit a written request for a hearing ("Request for Hearing"). The Alleged Violator must deliver the Request for Hearing to the Board of Directors not later than 10 days after the date of the Second Notice. If the Alleged Violator does request a hearing or does not appear at the hearing, the charges will be deemed admitted, and any fines or penalties described in the Second Notice shall be imposed without further notice.

4. Recurring Violations. Owners who repeat any Violation of the same type as determined by the Board of Directors within a 12-month period of receiving a First Notice will not receive another First Notice of Violation. The process will begin at the Second Notice of Violation. For such repeat Violations, the Board may automatically begin fines outlined in the attached *Schedule of Fines*.

5. Continuing Violations. Should the Violation continue for a period of 15 days following mailing of the Second Notice of Violation, daily fines will commence in accordance with the Schedule of Fines. Daily fines for the same, continuing violations will not afford the Owner with the opportunity to request additional hearings on the daily fines.

6. Alternative Dispute Resolution. Nothing in this Resolution precludes the President, a designated Board member, or other person authorized by the Board from first attempting to resolve the matter either by an informal meeting, telephone call, or a warning letter to the Alleged Violator. This Resolution does not preclude the Board from making offers to participate in mediation to resolve any dispute, or from encouraging owners to resolve their disputes in mediation.

7. Hearings Procedure. In the event the Alleged Violator requests a hearing, the Board shall schedule the hearing to occur within 30 days of the request during a regular or special board meeting. Imposition of fines, penalties, and other actions will be

suspended pending the outcome of the hearing. The hearing shall be conducted in open session unless the Alleged Violator makes a request for confidentiality and the Board deems there to be confidential or sensitive information that warrants consideration in

- a. If the Alleged Violator does not appear within fifteen (15) minutes of the start time of the hearing, the Board may deem that the Complaint is admitted and impose any penalties or actions described in the First Notice without further notice.
- b. Both the Complainant and the Alleged Violator may present evidence and witnesses at the hearing. The Complainant, if present, shall present the Complaint first, then the Alleged Violator may respond. The Board may limit testimony and evidence as it determines is reasonable and necessary. Unless otherwise determined by the Board, the time limit for the hearing shall be no more than fifteen (15) minutes.
- c. Board Determination. At the conclusion of the hearing, the Board will discuss the matter in executive session and will provide its written decision to the Alleged Violator and the Complainant within 30 days of the Hearing. A finding by the Board that the Complaint did occur is a determination of a violation ("Violation").
- 8. Remedies. In addition, the Board may refer Violations that constitute crimes to the police or other enforcement agency.

- a. Seeking injunctive or declaratory relief against any Alleged Violator or any tenant, guest, invitee, licensee, or other occupant of the Alleged Violator;
- b. Taking immediate legal action as the Board finds reasonably necessary to stop conduct which it determines is in violation of the Declaration, Bylaws, Rules and Regulations, or any other Governing Document, or applicable state or federal law.

### **MISCELLANEOUS**

- 1. Renters and Other Non-Owner Occupants and Guests. The Owner of a Lot shall be responsible for the violations of any renter, tenant, guest, occupant, or family member who violates any portion of the Association's Governing Documents.
- 2. No Fines Pending Resolution of a Hearing. Pending resolution of a requested hearing, no fines will be charged against the account of an Alleged Violator. If no hearing is requested and the Board or its appointed Committee finds a violation has been committed, fines may be charged against the Alleged Violator.
- 3. The Board has the final decision-making authority relating to violations. Board decisions at hearings are final.

GM: Tom Staskiewicz; I enjoy working with and for the board and working for Woodburn Estates & Golf. Being a board member is not an easy task and one of my roles is to support the board and their decisions and carry out the tasks they assign to me. However, it is not my job to take bullets for the board or committees and committee members when decisions are made and those who made the decisions do not come forward when criticized.

### News & Views Article

Last month there was an issue with an article in the News & Views written by Director Lindberg. After receiving a phone call from a majority of concerned board members I attempted to stop the article from being published. The reasons were 1) the article was not approved by the board and it was agreed it would not be published without board approval; 2) the article did not reference that the answers to the majority of items listed by Director Lindberg could be found in the minutes of previous board meetings where the opportunity to comment on the motions was available and following discussion, if any, the board, including Director Lindberg, approved the motions; 3) the issues with the many Bylaw versions are the result of constant changes requiring quarterly updates of the Bylaws, Bylaws should be static and not subject to constant revision the Rules committee is working to regain control of the changes; 4) the comment by the editor that "no responses were given" was incorrect, the responses were in previous issues of the News & Views".

When this information was initially presented I took the information to our attorney for a legal opinion on 1) is this appropriate material for a board report and 2) does WEG or the board have any potential liability. The response was that it was not a board report and that it should not be printed. I discussed this opinion with Director Lindberg and suggested if he felt there should be more discussion he should make a motion to have new motions presented earlier for the board members to review and have an opportunity to reflect and develop questions.

### **OLCC Licensing**

Director Aiken and I have been taking the heat for the decision to bring in the OLCC

to establish rules pertaining to alcohol. Neither Janice nor I were responsible. This fiasco was the result of a Rules Committee member who insisted on bringing in the OLCC to get proper licensing and institute an alcohol policy. When contacted the OLCC said "Woodburn Estates & Golf is NOT on their radar". When the volunteer servers went for training they were told again "Woodburn Estates & Golf is not on their radar".

Last Monday, during the Snowbird Tournament, I was approached by a member couple asking if I could do something about the alcohol issue. This was the first request I received. I said I would. Yesterday I went to the OLCC to start the process.

### **Out of State CAI Events**

Recently there have been complaints, questions and accusations about the out-ofstate CAI events I attend. One suggestion is that why do I need to go out of state when I can get educated in state.

Here is an example of why out state education is necessary: in 2015 we were spending over \$25,000 of your dues per year on credit card processing fees. In 2017 I learned from a local source how to save you over \$8000 per year by changing the bank used to process credit card transactions. That's \$8000 saved year after year after year after year. I thought that was quite an accomplishment. This past May I went to Washington D.C. for a CAI Conference and learned how I could save the remaining \$17,000 of these credit card fees every year. Yes, I spent about \$3000 on the trip but I feel saving you \$17,000, actually over \$25,000 annually, made my attendance worthwhile. Since the trip I have talked to local banks and they are amazed and have told me they COULD NOT do this for us.

In January I went to a conference where I was able to talk and listen to hundreds of attorneys discuss issues important to us. I even sat in sessions where OUR attorneys were present and learning. The sessions were conducted by nationally renowned HOA attorneys and included questions and discussions by hundreds of other attorneys. I spent \$3000 for the conference and there is no way I could get the same depth of education, knowledge and expertise locally.

There are many legal challenges facing HOAs today and the board and I have to know what is going on locally and nationally. If it's not in Oregon today, it soon will be! We can learn now or wait for it to happen and learn when there is little time to learn.

### Extra Working Capital Fees and Delinquent Assessment Collections

Last year I attended national and local events and learned how I could collect working capital fees from banks, flippers and other intermediary owners of homes in Woodburn Estates & Golf resulting in an additional \$70,000 in working capital fees

that have never been collected in the past this is income in addition to what we collect from the new homeowner. I have also stopped the process of writing off delinquent accounts and instead collecting the money from the banks, flippers and others when the opportunity presented. Our write-offs declined from \$49,000 in 2015 to \$3,000 in 2017. Our delinquencies have decreased accordingly because of these collection efforts. Just yesterday we received a check for over \$1500 in past due fees we would have previously written off. I also instructed Julia to send an invoice to a trustee for over \$5500 to cover a working capital fee and unpaid dues and assessments on a foreclosed property.

### Manager of the Year Competition

In January my name was submitted into competition for Manager of the Year.

### **Board of Directors Meeting Minutes (Cont.)**

There are over 55,000 HOA managers and I was one of 414 managers nominated and finished in the top 10 of on-site mangers. The competition required numerous essays, completion of questionnaires and picture portfolios. I did it because it brings Woodburn Estates & Golf national attention.

### My Background Check

I have heard that some members have pulled a background report on me and are prepared to present it at open mic today. I have nothing to hide and I will tell you what they found.

- 1) I have two bankruptcies on my report.
- a. The first was in 1997 following my divorce and my being left with expenses.
- b. The second bankruptcy was in 2016 and resulted from the four years prior to my being hired at WEG when I was unemployed.
- 2) The background report also shows that during my four-year period of unemployment I had difficulty making rent payments and the landlord took me to court where we worked out payment arrangements and the cases were dismissed. The missed payments were reported as unlawful entry. I did nothing illegal but I did everything I could to keep a roof over my family's heads.

### \$2500 Spending Authorization

Recently an issue has been made of my ability to approve expenditures up to \$2500 without board approval. First, it is in my contract approved by the board and therefore I do have board approval. Second, no single board member has the authority to approve an unexpected expense that was given to me in my contract. I have the ability to authorize these funds because sometimes the needs arise for money to be spent without the board having time to meet and approve. Examples include:

- 1) Recently we had the heater for the pool fail. The new heater cost \$5000 and we needed to put a \$2500 deposit for the order to be placed. I have the authority and instructed Julia to cut a check to the vendor so the repairs could start. This approval avoided bacterial and algae problems which would have been far more expensive and required a closure of the pool and spa until resolved.
- 2) Recently we have had two instances where vandals destroyed the card key access to the RV Storage Area. The cost to repair was approximately \$1500 and with my authorization I could initiate the repairs without additional board approval.
- 3) We have noticed and members have brought it to the attention of the office and board that they do not feel safe on the property because of a lack of lighting. I used my authority and purchased 19 motion activated, solar powered lights to be installed around the property. These units are also being placed by the golf course restrooms, cart barns, the tunnel and other areas where we have seen non-members prowling the premises.
- 4) I have used the authority to purchase equipment for the restaurant to ensure the equipment works properly and protects our members from health risks.
- 5) I have also used the authority to fix doors, purchase security cameras and even to respond to board member requests.

Even with this authority, if time allows, I will confer with available board members. I do not take this authority lightly.

This ability to respond timely is critical to the operation of Woodburn Estates & Golf. Without this authority unnecessary damages could occur with far more expensive consequences. Any emergency expenditure would require a twenty-four delay while calling the board together for a special meeting. If a quorum is not available the board would have to postpone until a quorum can be assembled.

Recently we had a board candidate state that they would take this authority from the General Manager so I could not abuse the process. Is maintaining the assets an abuse? Do you want equipment to fail and have no one able to address the situation? Do you want a manager whose hands are tied and can do nothing without board approval?

### **Annual Independent Audit**

I read where this same candidate for the board and others asked for an independent review of income and expenses. At the June board meeting, where this individual was present, we received the 2017 audit report from our INDEPENDENT auditor. We are required by our documents and state statute to have an independent review or audit of our financial information. The board chooses to have an audit because it is more comprehensive and tests our internal controls to ensure there are no improprieties.

### Ask for Transparency and then Get Criticized for Being Transparent

We have members who request transparency in the actions of the board and I, however, when we provide transparency these same members criticize us because we share information. Last month I mentioned a conversation with our attorney who is looking into separating a similar association into three entities: golf course, common areas and homes the purpose is to limit liability to the members. During the discussion he thought of Woodburn Estates & Golf, as any good attorney should, and mentioned it to me. This same idea was raised by insurance companies as we were evaluating new insurance. My response to our attorney was to find out what might be involved, what our documents allow and the pros and cons. I committed to nothing; I simply wanted to know if it was an idea worth investigating; why shouldn't we leverage on research being done for others at no expense to us? Again, I was criticized for my investigating an idea and accused me of wanting to take Woodburn Estates & Golf into bankruptcy. I'm not sure how you jump from investigating to bankruptcy from this.

### **Duplicate Sets of Books and Files**

We currently have a few members spreading rumors about duplicate sets of books and files. Members are being told that when they come to the office and request a record they will only see what the board and office want them to see. I am appalled at the idea that some of our members would try to rile the membership over nonsense.

### **Nextdoor Website**

There are many negative and uninformed comments coming from the Nextdoor website. Early on I embraced the Nextdoor website as a way to communicate with members. My feeling was if members wanted to use that venue for questions and answers I support the idea. After a few responses it became obvious that not all members wanted a forum for discussion, they wanted a forum to attack the board and me. The innuendos and out and out lies are destructive to our community. Most of the complaints are random comments "we have a problem with the board or GM" but there is no specificity because in most cases there is none. Some members complained because they filed a complaint and were not satisfied with the results or they were not told of the results. Some of this stuff is just plain personal and we are not going to air the "dirty" laundry of one member complaining against another or a member complaining on behalf of someone else.

Because of the inaccurate information and innuendos Woodburn Estates & Golf has caused people interested in living here or being associates to change their minds. They believe the community is back biting and unwelcoming. Visitors also see it at the pro shop and with events we hold. I recently heard that during the Snowbird Tournament one visiting couple were embarrassed by the members sitting near them as they criticized and complained about Woodburn Estates & Golf. If you are that unhappy maybe a move is in order. This is a great place for great people.

### Forum for Members to Express Issues

Another complaint I'm hearing is about a forum on the website for members to express their issues. Instead of attacking the board in general or me; why don't you ask the director in charge of communications, publications and the website? There has never been a motion to add this capability to the website by Director Lindberg. If you want it, ask the appropriate director.


