

Diabetes Prevention Program

by Lorie Beyers from Northwest Senior Disability Services

Northwest Senior Disability Services will be offering a year-long class that will meet once per week in the Craft Room starting October 10. The class runs from 2:45-4 p.m., and will run for one year. Participation is free to members however, you must be "pre-diabetic", or pass a "risk test" showing/verifying you are at risk. Class-size will be limited to 15 members. Please call coordinator Lorie Beyers at 503-381-3748 to sign-up.

In this Diabetes Prevention Program, a trained lifestyle coach facilitates a small group of adults to discuss behavior changes that can improve the health of participants. The program consists of one-hour sessions delivered over the course of a year.

Program Goals

- Lose 5–7% of your body weight
- Gradually increase your physical activity to 150 minutes per week.
- Participants do this through:
- 1. Healthy Eating Eating smaller portions, reducing fat in your diet and discovering healthier foods can help prevent the onset of type 2 diabetes.
- 2. Increasing Physical Activity Moderate physical activity (walking, swimming, mowing the lawn) for as little as 30 minutes, five days a week, can help improve your blood pressure, raise your good cholesterol and prevent blood flow problems.
- 3. Losing Weight Reducing your body weight by as little as 5–7% can offer great benefits for people at risk for diabetes.
- Research has shown that the Diabetes Prevention Program can reduce the number of new cases of type 2 diabetes by as much as 58% and by 71% among adults aged 60 years or older.

Police Memories: Portland, Oregon 1974

A story by Ken Leonard as told to Connie Doyon

Police dispatcher: "171 arson."

"171 copy."

The Dispatcher said, "The fire department wants you to respond to a Third and NW Everett flophouse. Two people have been set on fire."

My job as a police officer was as a liaison to the fire department. I worked very closely with them to investigate arson. No one seemed to know what happened. It was my duty to find out.

I returned to the precinct and the Lt. said, "Go undercover in Skid Row for about a month's time and see what you can find."

I dressed in my most torn, ugly pants and shirt. My socks were mismatched and my shoes were ready for the dump. My job was to infiltrate the bums that stayed in this hotel and find out who the arsonist was.

I went down there to make friends with anyone I could. I was trying to blend in and see if someone would squeal.

The storekeeper was in on my ruse and arranged for me to have 2 bottles in paper bags. One was Pepsi (my favorite drink) and one was cheap wine. He "paid" me to sweep the storefront and street for a few "mickeys." This offered me exposure to anyone who came and went. I was well accepted as soon as I offered them a taste of my "mickey." A mickey is a small bottle of cheap wine.

After a few weeks, a couple of them made comments about some weirdo who had a bunch of strange pornographic pictures. "Could I see them?" I asked. After I gained their trust, they took me to the third floor and told the occupant that I had some wine and could I have a look at the pictures?

I recognized the man, whose face I had seen on a wanted poster, an escapee from the Washington State Insane Asylum who had a record of setting people on fire. What he had done in this house was set several residents on fire by pouring lighter fluid on a sleeping person and igniting them. Luckily, no one had died as a result of his actions.

I drew my concealed weapon on the suspect and told him I was a police officer and that he was under arrest. My "friend", who had taken me up to see him, said, "You're a cop!" in disbelief. I sent him down to the office and told him to call the Police and tell them that "officer needs cover."

I handcuffed the suspect and he was charged with Arson and taken to jail.

Men's Golf General Meeting Minutes

Woodburn Estates Men's Golf General Meeting July 3, 2019

President Ken Bourne called the Meeting to order at 10 AM in the Dining Hall, followed by the Pledge of Allegiance.

Roll Call: All Officers & Committee Chairmen/Representatives were present unless otherwise noted in this report. There were 38 members in attendance at today's Meeting.

New Members Present: None.

President's Report: President Bourne welcomed the members and then presented the results of the recent Match Play Tournament as follows: Champion - Don Gienger; Second Place - Allan Lindberg; Consolation Champion - Len Westphal. President Bourne then reported on a recent Board Meeting where the Golf Chair presented a motion to lower the age of Associate Golf Members to 45 years of age. The motion was passed without any discussion. After the Board Meeting, President Bourne reported to the Golf Chair that a poll of the Men's Golf Club members and the Ladies Golf Club members resulted in a negative response to the passed motion. Both Clubs deemed the motion to not be a sound decision as there was no input from the either Club prior to the motion being presented and passed in the Board Meeting. Even though additional Associate Golf Members could be obtained, it was pointed out that the 45 year old age group is undoubtedly still employed and would only be able to play on weekends and/or in the late afternoon, times that are often occupied by tournaments and groups such as the Sundowners and Friday Funnies. The motion should be revisited by the Board and the age of Associate Golf Members returned to the previous standard of 50 years of age. A poll taken of the 38 members present at this Meeting resulted in a unanimous "no vote" as to reducing the age to 45 for Associate Golf Members.

Vice President's Report: VP Will Abshere and President Bourne reported on the sample of a new score card as presented at the recent Greens Committee Meeting. President Bourne provided input at the Meeting to slow down the process of obtaining new score cards to ensure that the new cards provide a minimum of 6 lines and preferably 8 lines as on the current cards being used. Also the new cards need sufficient space to allow for the computer number and name of the player on each line. The Golf Chair has agreed to allow President Bourne, VP Abshere, and Head Pro Jason Hoth to handle the production of the new cards. The Ladies Golf Club President will also be invited to join in the production of the new score card. President Bourne also stated that the score cards we are currently using should continue to be used until said supply is gone. VP Abshere then stated that there was discussion at the Greens Committee regarding the use of tree branches to replace the current tee markers. Again, it was felt that placing tree branches as tee markers is a poor idea and that the current tee markers should continue to be used. If there is a stigma regarding the red tee markers, these red tee markers could be replaced with another color or merely painted a different color. VP Abshere then discussed the need to have a marker and/or other competitors when playing during Men's Golf Club Thursday Play. No twosomes are allowed without competitors and/or markers. VP Abshere then reported that on Tuesday, July 16, there will be a 9-hole mixed scramble event where the 9-hole Men's Group and the Ladies 9-hole Group will participate together. After the golf, there will be a lunch provided by the ladies. VP Abshere then reported other news from the Greens Committee, including the use of the Northwest Tree Service which is currently removing trees on the course; the suggestion of a beverage cart to be used on the course; 3 more tee boxes will be renovated this year on holes 3, 7, and 8; and old tee marker signs are desired by some homeowners. The next Greens Committee Meeting will be held on Monday, July 8.

Treasurer's Report: Treasurer Mark Jorgensen provided the following report: Balance of the Club's Account as of June 28, 2019...\$4,633.24...Balance of the Men's Golf Club Voucher Account as of June 28, 2019...\$6,936.45.

Secretary's Report: Secretary Chuck Johnson had nothing to report.

COMMITTEE REPORTS:

Handicap: Co-Chair Abshere had nothing new to report.

Mixed Tournaments: Representative Fred Bourne stated that the July 4 Mixed Tournament will have many participants so expect slow play and display patience with the pace of play. Fred also reported on the beverages and other items that were purchased and will be available at the July 4 Tournament. Fred concluded his remarks by reporting that our Club provided a foursome to play in a Pro-Am Tournament at the Creekside Golf Course and that our group finished in fourth place.

Rules: Chairman Jim Hutchinson discussed the rules involving playing from a sand bunker, including some of the new rules pertaining to such play.

Sunshine: Chairman Ron Gripenstraw reported that he sent a card to Bob Price and Clint Hansen. A report was then given on the health condition of members Mike Dykes and Jim Worley.

OGA: Representative Paul Eaton reported on an upcoming fundraiser raffle for Junior Golf involving play at the Bandon Dunes Golf Course and other prizes totaling around \$4,000. Raffle tickets can be purchased for \$25 per ticket or \$100 for 5 tickets. Paul pointed out that fees to play at the OGA Golf Course can be seen on the OGA website or merely call the Pro Shop. Paul recommended that we invite the OGA handicap person, Kelly Neely, to schedule a seminar at Woodburn Estates

to be attended by Men's Golf Club members and Ladies Golf Club members. It was agreed that such a seminar would be beneficial to our members and Paul will follow up with Kelly to schedule a seminar.

Membership: Chairman Stan Hiller stated that we are now only 2 members short of the membership we had at this time last year. He encouraged the members to seek new members for our golf course.

UNFINISHED BUSINESS: Nothing to report.

NEW BUSINESS: Nothing to report.

Closing Member Comments: Alton Sharrow asked why players in the Match Play were allowed to practice on the day of play. This was reported as an inadvertent happening and has been corrected with the Pro Shop. Alton then asked about the prior use of handicap flags on our course. Older and somewhat disabled golfers could use handicap flags to allow closer access to the greens. A discussion ensued and it was reported that handicap flags were removed from the course due to abuse by golfers not entitled to handicap flags. It was reported that more research is needed on this subject as a disabled golfer could demand such a privilege based on the provisions of the ADA (American Disability Act). Russ Krussow and Alton then discussed the need to build up an entry and exit area from the cart path to the fairway. Dick DeFerrari then encouraged golfers to remove sand from their shoes after exiting from a sand bunker. Larry Jones then described the need for a one day member-guest 2 man best ball tournament. He stated the member and guest would need to have USGA handicaps within 10 strokes of each other. Other conditions would limit the age of guests to 50 years old minimum and allow the guest a reduced green fee. Based on the number of participants, there could be 2 or 3 flights and a meal to be served after the tournament. It was agreed that such a tournament would be a positive event that could be scheduled either on a Thursday or a weekend day. Russ Krussow reported that a Glo-Ball Event will be scheduled for sometime in September with a maximum of 27 teams. Jim Carter asked about the cost and need to remove some of the poplar trees on the golf course. It was reported that this type of tree is messy and affects the health of other trees on the course. Stan Hiller reminded golfers that during the Car Show to be held on July 14, golfers will need a different route to go from the front 9 to the back 9. Mark Jorgensen then reported on the cost and use of a beverage cart on our golf course. Staffing for such a beverage cart would be handled thru the Pro Shop and would require a licensed server.

Door Prizes: The 50/50 Raffle was the held. The total money collected for today's raffle was \$78.00. Ron Sartin had the winning ticket and split the pot, winning \$39.00.

Closing: President Bourne asked for a motion to adjourn our Meeting, the motion made, seconded, and approved. The Meeting adjourned at 11:15 AM.





Ten-Ton ONV

Cora and I have been feeding the birds that visit our second-story deck ever since we moved into our home in Sun Prairie, Wisconsin, 18 years ago. I'm certain that the cardinals, finches, jays, juncos, sparrows, and the occasional nuthatch and downy woodpecker exhibit impeccable manners while dining at

On our deck, competing for a meal, they scatter a fair amount of the seed onto the grass below. They pay scant attention to the flighty seed, preferring to obey the 5-second-rule, much to the delight of their rivals: gray squirrels, chipmunks and as it turns out, opossums and a raccoon, all of whom are unconcerned about etiquette.

After several unsuccessful attempts to discourage the community of marauding gray squirrels, I purchased a seedy catch-alive trap at a garage sale for \$2. I set and baited it with the daily fare, and within minutes captured a white-bellied porker. Later that week, 3 squirrely looters made the same mistake. I transported all of them to a wooded area well to the north.

As you might expect, one trap proved insufficient to rid the deck of the prolific pests. I now own several secondhand traps of varying sizes and nationalities. Over the past 6 years, I've trapped and transported 351 of the moochers. The \$17.50 I invested in the traps, added to the cost of the bait, say \$50, and the gas to transport the varmints out of town, roughly \$200, has saved me untold torment and nearly \$40 worth of birdseed.

I spent the savings on a technologically advanced, plastic, squirrel-proof, Walmart bird feeder, which proved to be surprisingly ineffective; the seed level fell precipitously from evening to morning. I could not account for the losses. I checked the lawn for overnight spillage. It proved to be littered less than the floor beneath my dinner chair.

As I age, at least my displeasure with aging matures. One aspect is particularly unsettling, nightly junkets to our bedroom's bathroom. On one such unconscious excursion, at 2:45 in the a.m., when I didn't stub a toe on the dresser and wake my wife Cora with muffled remarks; I sort of heard strange sounds emanating from the deck.

I delayed my appointment and maneuvered through the living room towards the patio door located just off of the kitchen/dining area. Without the advantage of lighting, I slammed two left-footed toes on an end table, and then a kitchen chair. Remaining mostly silent, I flipped on the deck light, opened the drapes, and spotted a raccoon the size of a Mini Cooper perched on the railing. It had latched on to our non-raccoon proof, squirrel-proof bird feeder and emptied half of its contents through a nickel-size portal by use of its prehensile tongue.

We exchanged cordial greetings until it tired of our dialogue, flumped onto the deck, and lumbered down the stairs. I returned to the bathroom in much the same fashion as I had traveling to the patio door.

Later, that early morning, while updating my owies on another jaunt, I once again found the raccoon, now dubbed Ten-Ton Tony, ravaging the bird feeder. We exchanged pleasantries, and after a time, agreed to retire for night.

We met each other again, twice, that week. Perceptive and somewhat amused, Ten Ton Tony could see that I was losing patience with his company.



I chose to go on the offensive.

Tonight, I will be prepared for Ten-Ton Tony, the masked raccoon bird-feeder bandit, and his gang of opossum minions. He started this. Bring it on! I'm setting four catch-alive traps; and for safety's sake, I'll turn on the lights before I check on them. (2:32 a.m. ouch.)

As of this telling, Ten-Ton Tony has escaped my efforts and remains at large, minus a few of his possum puppets who now live in a forest far away, in the company of 300+ squirrels.

Cora, to her credit, has endured the conflict with little comment until this evening. She could no longer bear my feet, suppressed language, and temperament; and gave into her impulses by offering this advice, "Why don't you take the bird feeder inside at night?"

I replied, "Um, yeah, well...Where's the fun in that?"

Edgar Allan Poe

Have you ever wondered about the life of the man who originated the mystery story and added psychological depth to the tales of horror? Edgar Allan Poe was orphaned as an infant after being born in Boston in 1809 to itinerant actors. He was then sent off to live with a Richmond merchant named John Allan.

Poe attended the University of Virginia in 1826, but had to withdraw that same year due to gambling debts. He entered West Point in 1830, but was dishonorably discharged the next year. By then, his first book of poems was published. The stormy relationship with John Allan was completely broken off that year.

Over the next five years his stories began to be published and praised and he grew close to a young cousin named Virginia Clemm. He and Virginia married in 1836. Virginia was actually thirteen years of age but was listed on the records as twenty-one. Poe, his bride and her mother moved to Philadelphia and then on to New York.

Poe eked out a marginal living contributing to newspapers and editing magazines. He was a brilliant editor but had a combative personality and never received adequate pay for his accomplishments. In 1845, The Raven was published and made him famous after already having been established as an author.

Poe started to lecture and at that time engaged in a celebrated feud with Longfellow. At that time, he became the sole proprietor of his own magazine named The Broadway Journal. The magazine went bankrupt in in 1846 and his wife died of consumption in 1847. His ill health and drinking worsened and in October of 1849, he was found semiconscious outside of a polling place in Baltimore. His death followed a few days later without regaining consciousness.




