

## From The General Manager

Here is hoping everyone had a happy Fourth of July! Many activities are taking place in our community, not only at The Estates, but also throughout Woodburn and the surrounding area. If you get a chance, be sure to check the weekly e-blast at City of Woodburn [jason.horton@ci.woodburn.or.us](mailto:jason.horton@ci.woodburn.or.us). Jason Horton is the Communications Coordinator for the City. He also provides updates from ODOT on the 214 Hwy \& I-5 Interchange project.

My June 24th report to the Board of Directors has some interesting statistics from the National Association of Realtors Report stating that sales increased nationally by $4.9 \%$ in May. The Estates housing sales increased 7.5 \% from May 2013 to May 2014. Seventy-one homes sold to-date with the highest price $\$ 180,000$, lowest price $\$ 42,000$. Total dollar amount of sales is $\$ 7,459,127$ averaging $\$ 105,058$. Two homes sold to fix-up and resale (flip); one paid $\$ 42,000$ in January, sold for $\$ 72,900$ in March. The second house sold for $\$ 57,000$ in February and resold for $\$ 72,900$ in May. Sales reveal average age for females is 65 , for men 68 . The national 2012 census report shows that between 2000 and 2010, the total population in America increased by 9.7 percent. However, the population 65 years and older increased by 15.1 percent, and according to the Pew Research Center's population projections, 10,000 Baby Boomers will retire every day until 2030. These statistics support positive sales for our community.

In keeping up with demand and looking into the future, the Board of Directors and Administration has been diligently updating policies and procedures. One of the most challenging has been updating our Governing Documents. Through

the assistance of our legal firm, Vial-Fotheringham we are in the last stages. ## Why I am Here

My name is John and I moved to The Estates two years ago. I am a true blue Woodburn Bulldog. I was raised in Woodburn, graduated in 1964 and watched The Estates being built.

Let me give my answer to the question asked of "Why Are You Here?" I moved back to my roots, and even with just my social security and small pension, here at The Estates I found a beautiful inexpensive home with wonderful yard and great neighbors around me. Did I move here to play golf? Oh heck No! I am another of the huge majority that moved here for other reasons than
golf. I'll bet most of us just want a nice peaceful environment, nice neighbors, quiet streets, and a community center to meet more friends and swim and work out and socialize if we choose.

I have fairly serious osteoarthritis that prevents me from playing golf, although I have played a lot of golf in my time. I have met both golfers and non-golfers here and have found both to be quite nice. Paying my dues allows me to use the pool, and the hot tub, and the workout room which all helps my arthritis. However, most of my exercise is from walking.

Since a portion of the dues that I pay also pays for the golf course, I assumed that I would be able to take a nice walk on the golf course paths, but found signs that say, I cannot do that. What is that about? Are you serious? The answer will probably be because of some perceived liabilities, but what about liability using the hot tub, or pool or weight room as seniors? Don't the signs saying you use them at your own risk cover that?

I also read a line in Mr. Johnson's article suggesting that our property values are increased $\$ 20 \mathrm{~K}$ because of the golf course. That's hilarious. If that's true, why do we have some of the lowest property values in the region? Property values would be higher yes if I lived around McNary, or OGA, or Langdon [Farms], or Evergreen, but it is clearly not true of The Estates golf course.

I have friends who live around the golf course in McNary Estates. They pay an HOA fee of around $\$ 250$. This fee covers landscaping,

clean up, common areas, etc., but none goes to their incredible golf course. The course pays for itself and is open to the public. That's how it should be. There are non-golfers in McNary Estates but they don't pay for the golf course. Why isn't our course paying for itself? Why aren't we open to the public too?

Mr. Johnson also stated that our dues may be substantially raised soon, and yet I have also heard that some of the fees to play the course were actually lowered. Our course seems to be managed only for the benefit of the $10 \%$ of Estates residents that are golfers. Let's open the course to the public, have some sponsored tournaments that generate lots of income for the course, or try whatever it takes that other courses do to make the course pay for itself and not make non-golfers pay for it. I pass by the golf course a number of times a day, and at any time only see
a small number of golfers on the course. This appears to be a very expensive piece of property to own and maintain that so few people use.

Now I don't mind paying my dues, but I honestly think that the golf course should make efforts to be more self-sustaining and more accessible to everyone. I am still wondering about the $\$ 2000$ that I paid when I moved in. Friends that bought in other HOA's didn't pay that fee.

I don't want to make huge waves or not get along, since I do love living here, but I don't want to be bullied either, and neither do the large majority of the residents of The Estates, I'm pretty sure. We need to discuss these issues that affect all of us, not continue to ignore them. I am a non-golfer and I have rights and opinions too.

## Ever Been to Butteville?

Looking for adventure on a summer's day? How about having lunch in Butteville! The Butteville General Store (the only retail property in Butteville) is now run by the Oregon State Parks and is open from 10 a.m. to 5 p.m. every day in the summer. You can get a good lunch while you look at historic photos and documents. On a Saturday night you can also make a reservation for dinner and listen to some live music.

Butteville is now classified as a ghost town, even though it was once a center of bustling trade when it was first settled by French Canadians in the 1840 s. There was a lot of wheat grown in the area, which due to the lack of roads, had to be shipped by boat. Butteville had a warehouse and a pier. It also had a ferry that ran between Newberg and Wilsonville. When the railroad came in, it bypassed the town and took over the wheat shipping. A flood in the late 1800 s washed away many of the old houses and the ferry landing.

There are still a few historic houses, a

community church on Arndt Road and just outside of the community on Butteville Road is a model airplane airfield run by the Portland Barnstormers model airplane club. You may be lucky enough to see members flying their planes.

The area is also important because it is the nearest settlement to Champoeg Park, the site of the famous vote that decided whether Oregon Country would be French or British. You can get there by following Butteville Road north or by going west on Arndt Road. You can also get there on the bike trail from Champoeg Park.

## Golf Course Etiquette and Rules

Summer is here, the fairways are calling and it is time once more to review a few of our course rules and etiquette

1. Golfers MUST have their own golf bag and a set of golf clubs.
2. Practice is not permitted on the golf course.
3. Golfers that fail to keep pace on the course and lose more than one clear hole on the golfers in front must invite the golfer's following to play through.
4. It is requested that you carry sand/ seed mixture on your golf car or pull cart when playing golf.
5. Sand trap rakes are to be left in the sand trap in a position to cause the least interference to following golfers and the green mowers.
6. Golf cars MUST NOT be driven within 30 feet of the putting greens, onto the apron, onto the tee, or into a sand trap.
7. Golf cars bearing a Handicap Flag may drive to the side of the approach to green, not closer than ten feet from the green and not on the approach to the green.
8. Any golf car(s) operated on the
premises must be registered by owners with the purchase of a decal that must be displayed on the windshield of the golf car.
9. Hand or an electric type hand golf cart must not be within 15 feet of the putting green, onto the apron, onto the tee, into a sand trap or across other designated areas of the golf course

DRESS CODE FOR GOLF COURSE

1. Soft spike golf shoes are mandatory May 1 to October 1.
2. Shorts must be reasonable and proper. Jogging shorts, short shorts, cutoffs or swimming-type shorts are not permitted.
3. Tank tops are not permitted; sleeveless tops are permitted.
4. Bare midriffs, halter-tops or strapless garments are not permitted.
5. Jeans are permitted but must be of good taste.
6. Sweat pants are not permitted.

To review the entire Golf Course Rules and Etiquette, refer to the Rules and Regulations, Revised January 24, 2012, page 6 \#14 through \#14.31. Enjoy your golf experience and have a great summer.

During the month of June, expenses totaled $\$ 411.91$ for OGA fees and donuts, leaving a current balance of $\$ 3,064.62$. Jim also reported that there are now 139 members of the Men's Golf Club.

Secretary's Report: Nothing to report.

## Committee Reports:

Handicap: Clint Hansen reiterated that the Spring Handicap Golf Tournament was a success. Clint then discussed the upcoming Match Play Tournament based on the top 32 golfers who participated in the Spring Handicap Tournament. Clint explained that handicaps for Match Play uses the most current handicaps. If a

Match Play Event spans a revision date, handicaps will still be used based on the day of play. In response to a question from Tony Pye, Clint explained how scoring takes place in Match Play relative to high and low handicap competitors. Larry Kemper inquired as to whether the Spring Handicap Tournament in the future could be reduced to a two day event rather than the current three day format. He pointed out that some of the Men's Golf Club members might not sign up to play the three day tournament due to health reasons. Based on information provided by Clint Hansen and President Bourne, they were only aware of one golfer who did not play based on the three day format; thus, the three day format will continue for future play in the Spring Handicap Tournament.

Membership: Stan Hiller reported that he has made 258 bag tags as of this date.

Sunshine: Bob Price reported that he sent out two cards during the month of June. One card was sent to Mrs. Alma White relative to the passing of her husband, Lee. The other card was sent to Richard Hughes as he recently had a surgical procedure. Cards will be sent to Barbara Westphal and Joe Brown as they will be having surgery soon.

Closing Comments: Dick DeFerrari stated that based on the most recent Profit and Loss Statement for the Estates HOA, there is a current shortfall of some $\$ 40,000$. A discussion followed wherein it was determined that many of the golfers, male and female, paid one half of their annual golf fee in January with the remainder to be paid by July 31, 2014. Chuck Johnson, also the Treasurer for the HOA, stated that we will not know of the actual shortage till sometime in August, but Johnson stated that the number of
golfers willing to pay the annual golf fee continues to decline; thus, a shortage of revenue is a likely scenario at year's end. President Bourne commented on the condition of the golf course, stating that there are many parts of the course (mainly where irrigation pipes were placed) that need to be heavily reseeded or sod placed to cover the ditches. Until then, President Bourne in concert with our golf Pro, Chuck Siver, have agreed that these bare areas where the piping was installed should be considered as "ground under repair." During the Spring Handicap Tournament, it was determined that "lift, clean, and place" was allowed due to the inclement weather during the tournament. Handicap Chairman Clint Hansen voiced his opposition to the decision regarding "lift, clean, and place" as he pointed out that free drops could have been allowed for casual water. The Golf Committee needs to follow up with the Golf Course Superintendent regarding the condition of the course relative to the areas where the recent irrigation pipe was laid. Clint Hansen stated that this year's Match Play Tournament will have a match to determine the third and fourth place winners. Bob Price stated that he recently played in a tournament at the Woodburn Sand Green Golf Course and won tickets to the Woodburn drag strip event. Bob

 GolfThe Meeting was called to order by President Ken Bourne at 1:30 p.m. in the dining hall, followed by the Pledge of Allegiance. A quorum was established with Directors Bourne, Butts, Bunnell, Johnson, Aiken, Cole, Cornett, and Worley in attendance. Director Westphal was absent with notice.

President's Welcome Report President Ken Bourne: Welcomed everyone to the meeting. He gave a short report on what has generated a lot of discussion in the past month. As you may be aware there have been three new homes built on private property behind the \#12 tee box. The builder then installed a white vinyl fence that separates the home sites from the property of the golf course. The white fence has been a subject of conversation since it was built. He has received many opinions by many different people on what should be done.

The outcome of the talks is that some sort of plants or hedges need to be added to provide some color and beautification to our course as well as to blend in the white fence. After meeting with our General Manager, Golf Course Superintendent, and many others, the consensus is to plant some sort of hedge. The final decision will be made by a management team consisting of the General Manager, Golf Course Superintendent, Men' Golf Club President, Women's Golf Club President, Golf Pro and the President of the Board. He will be setting up a meeting soon to work on this. He thanked the Men's \& Women's clubs for their offer to fund this project but advised that the Association will fund it.

There were no changes to the agenda. The minutes of the April 22, 2014 regular meeting were approved unanimously, with 2 minor corrections.

Treasurer's Report - Treasurer Chuck Johnson: (1) The balances reported today were reconciled with bank statements and balance sheets provided by The Estates Bookkeeper as of April 30, 2014. Our Operating Account balance as of April 30, 2014, was $\$ 653,561.44$. Our Reserve Account balance as of April 30, 2014, was $\$ 802,303.43$. (2) The Accounts Receivable statistics presented herein were determined as of May 23, 2014. On that date, the balance of our Accounts Receivable was $\$ 75,055.67$, a reduction of $\$ 9,199.74$ from my last report of April 22, 2014. (3) We have 68 delinquent accounts which represent a $4.5 \%$ delinquency rate, a reduction of 16 delinquent accounts from my April report. We have 14 liens filed against properties with delinquent accounts. There are 13 delinquent properties in foreclosure. Our attorneys are working on 26 delinquent accounts in an effort to collect money owed on said accounts. We are reviewing several delinquent accounts that may be uncollectible due to our lien being subordinate to other liens, resulting in no equity in the property.

## Committee Reports:

Architectural - Director Len Westphal: Presented by President Bourne. Since the last board meeting there have been 29 architectural requests and 11 compliance requests.

Activities- Director Sharyn Cornett: (1) The Beach Party Dance will be on Saturday June 14th and there will be an $\$ 8.00$ cover charge. Refreshments are sponsored by our friends at Country Meadows Village. Come and enjoy great music, dress is casual. (2) The annual Picnic and Carnival will be on Sunday, June 22, in the Auditorium from 11:00 a.m. to 1:00 p.m. The event is sponsored by Cascade Park and admission will still be $\$ 5.00$ for lunch and some raffle tickets. Additional raffle tickets will be available for purchase. The dunk tank will return with a volunteer team of Ken Bourne, Pat Lucas and her son. Come and take a chance to dunk the team. New this year is a peanut auction with many prizes led by Marie Worley. This should be lots of fun. Come and enjoy the food and fun. (3) Neighborhood Watch signs are coming for East \& West Clackamas Streets. We will be selling Neighborhood Watch stickers to go on your screen door or window during Coffee Hour. (4) We are working on a date for engraving your identification on your golf carts like last year. Watch the News \& Views for the date and details.

Golf - Director Janice Aiken: Reported the following was discussed during the Greens committee meeting on May 12: (1) The rules booklet will be updated by Men's Golf President Fred Bourne and will include information on golf carts driven on the golf course and in the common areas by golfers and nongolfers. (2) There was a discussion on out of bounds stakes and it was concluded that they should be 3 feet beyond the homeowner's property stake which is measured from the center of the street. (3) Golf Superintendent Tim O'Larey reported that the arborvitae on the \# 8 Tee box will be completed in the next

2 weeks. There are lots of spike turn marks around the cup on the greens and divots that have not been repaired. Two part time employees have been approved by the Board to start in June and go through August to help with grounds maintenance. Work continues on the tree wells, shrub beds and curbs. Edging around the sprinklers is in progress. We now have 900 sprinkler heads. (4) The Committee asked if there was anything that was needed to maintain the grounds in the shape they are in now.

House - Director Donna Cole: (1) The contract is now signed with Rebecca Abraham Design. Rebecca did a walk through with the Maintenance Manager, General Manager and Donna Cole. (2) A work-session is scheduled for June, where color palettes will be presented to the committee and decisions made in order to present the decisions to the Board for the July board meeting.

RV Lot - Director Jim Worley: There has only been one alarm in the RV lot this month. They are continuing to spot spray weeds and grass where they shouldn't be. That project will be done very soon.

Membership - Director Dave Bunnell: There will be a new members get acquainted meeting on Friday, June 13th in the Dining Hall. All new members are invited. The membership committee will deliver new members packets to all our new members prior to that date.

Real Estate - Director Dave Bunnell: (1) A total of 7 homes have sold during the month of May. There are 13 sales in title and 3 sales are pending. (2) To date a total of 55 homes have sold this year. (3) A total of 12 homes were sold in May 2013 and a total of 43 were sold through May of 2013

News \& Views/Directory/Website Director Becky Butts: There was nothing new to report today.

Rules \& Regulations CC\&Rs Director Jim Worley: (1) The committee has received 34 complaints this year, 13

have been closed. There are currently 21 open. Five are in the attorney's hands, five have received certified letters and 11 are still in committee. (2) The committee has edited 35 pages of our Bylaws and there are 11 pages to go before they go to our attorneys. This has been slowed by the number of complaints and the time it takes to resolve the complaints.

Marketing - Director Donna Cole: The contract with Angled End Identities has been approved and the check for the advance has been issued. We will now be able to begin the project of rebranding our community.

General Manager's Report - Sharon Schaub: (1) As a follow up to my last report on the meetings with the Woodburn Police on the additional security for The Estates, namely around the golf course, Detective Sergeant Nick Wilson mapped out specific locations for the 8 new "No Trespass" signs. We are also looking into placing solar lighting over the signs. (2) May has been a very busy month starting with the seal coating on the parking lot and new striping. The area between the maintenance and pool building has been cleaned and the majority of recycled debris has been removed. The building has been repainted between the maintenance and pool. The patio off the golf lounge has been pressure washed and stained and the three tables have been cleaned and painted. We replaced the drinking fountain by the Pro Shop and installed a new drinking fountain by the breeze way. Installed the garage door in \#2 cart barn. (3) Quotes have been submitted for a new company to test the fire alarm system and for extended security around the RV lot. (4) The insulation for the east wing is scheduled to be installed this week. This would be phase 2. The total for the insulation for the $20,063 \mathrm{sq} \mathrm{ft}$ of both wings is $\$ 16,912$ and working with the Energy Trust the net cost will be $\$ 4,874.20$. (5) The Golf Course Superintendent reported all the aerification has been completed and with the three day holiday the crew is catching
up on all the mowing. One part-time employee will start working this Friday, Saturday and Sunday on May 30th. He will work Friday, Saturday and Sunday for the first three weeks and then will be available 40 hours per week on June 16th. The second part-timer will start on June 16th and work 40 hours per week. (6) Quotes are due today for our general liability insurance. Liberty Mutual is not renewing our policy. In checking our claims loss totals Liberty Mutual has paid out $\$ 104,124.28$ from 2008 thru 2011. No claim have been filed since 2012 forward (7) We have been notified that premiums for our Director's \& Officers insurance could go up $25 \%$. The renewal proposal form is being prepared for submission.

Unfinished Business: There was no unfinished business.

New Business: There was no new business.

This is a huge step forward for our communication with the city. (2) The Security meeting and the meeting honoring our veterans went very well. (3) Members were asked to volunteer for the nominating committee and to volunteer to run for the three Directors positions that are up for election during our annual meeting. Current Directors may run for reelection. Contact Lon Reed or Becky Butts if you have questions or want to volunteer. (4) The News \& Views
will now have color and everyone is asked to get pictures of your events for the paper. (5) There was a request for the golf committee to consider for next year letting members who want to play in our tournaments that do not have a handicap to be able to play as a "scratch" golfer. (6) Thanks were offered for the great job by Ken Leonard in photographing the Memorial Day tournament and Stan Hiller in processing the pictures for display at the dinner that evening.

The meeting was recessed to Executive Session at approximately 2:05 p.m.

The Board returned from Executive Session at approximately $3: 10$ p.m. and reconvened the meeting.

The Board advised that they had
reviewed delinquent payment plans and the advantages to changing our current banking arrangements.

Director Bunnell made a motion to change our banking from Columbia Bank to Washington Federal Bank by resolution to be prepared by Staff and signed by our President and Secretary. The motion was seconded by Director Johnson. The motion was approved unanimously.

There being no more business, Director Bunnell made a motion to adjourn the meeting. It was seconded by Director Butts. The meeting was adjourned at 3:15 p.m

Rebuttal to the Article by John Thomas

Ithave read the article that Mr. Thomas asked editor, Kathy Hiller, to publish in the News \& Views (this edition, page 2), and would like to rebut his comments. As many of you know, in March of this year, I wrote an article that was published in the News \& Views, entitled "Why Are You Here"? As treasurer of the HOA, I was prompted to write this article in response to the numerous delinquent accounts that the HOA had in February of 2014. Yet at that time, of the three pages of delinquent accounts, hardly anyone had come forward to explain why their account was delinquent nor had they contacted our General Manager with a payment plan to meet their financial obligation to the homeowners who live in The Estates.

Note I said "homeowners". When an annual assessment is not paid nor any effort made to offer a realistic payment plan, each of us as homeowners become the unpaid creditors. If I ran up a debt of $\$ 20,000$ and made no effort pay the debt, how many of you homeowners in The Estates would be willing to pay my debt? I would guess none of you. Yet, we, the homeowners, had to write off over $\$ 20,000$ in bad debt from delinquent accounts in 2013! So in essence, we who paid our annual assessment paid for this $\$ 20,000$ bad debt.

I don't believe that Mr. Thomas read the first article I wrote in March. Mr. Burt did, and subsequently wrote an article that was published in the News \& Views which caused me to respond to rebut his comments. Mr. Thomas seems to only be aware of the second article that I wrote as most of his comments are directed at that second article.

Mr. Thomas immediately brings "golf" into the equation. In my first article, the only reference I made to golf was to explain why my wife and I moved to The Estates. I did state that we have a fabulous golf course and I truly believe that or I would not be here. I also stated that we have other fabulous common area amenities such as the pool, spa, exercise room, pool hall, etc. My only appeal in the first article was to ask why a person would move here if they had either no intention of paying their annual homeowners assessment or were financially unable to pay said assessment. Who did they think was going to pay for the maintenance, repair or replacement of these common areas? Anyone buying a home in The Estates signs a document provided by a realtor and/or a title officer that explains that they are buying into a Planned Community and said buyer would be subject to an annual assessment for the maintenance, repair or replacement of common area amenities.

Mr. Burt then had his article published and made comments regarding golf

I never stated in either article that a person should live here just for the golf course. I have many friends in The Estates who have no interest in golf, but enjoy the many other common area amenities that we have.

Anyone can experience a financial hardship. Years ago, I was faced with

raising seven children, six that were step-children with no financial support from the natural father. I worked three jobs for 8 years to ensure that we had a roof over our head, clothes on our back and food on the table. Since I have been the HOA Treasurer, I have submitted some 20 payment plans to the Board of Directors for property owners with delinquent accounts and the Board has approved every payment plan ever submitted. This is all I ask. When a hardship occurs, work with us to meet your financial obligation if at all possible.

In my second article, I quoted an on-site realtor at the Fairway Village Planned Community in Vancouver, Washington, who unequivocally stated to our Board while we were attending a seminar at that location that Planned Communities built around a golf course in Oregon and Washington typically increased the value of homes in such a community by $\$ 20,000$. Mr. Thomas infers that this is "hilarious" as we have "some of the lowest property values in the region". Compared to what? Most of the homes in The Estates range in age from 30 to 50 years and average less than 1300 square feet. Perhaps that is why you can buy an inexpensive home in The Estates. Compare that with the homes you cite around the OGA Golf Course and the McNary Estates.

Mr. Thomas also states, "I have also heard that some of the fees to play the course were actually lowered." Yes, by approval of the Board, homeowners who want to pay the daily green fee did experience a slight drop in the green fee rate as non-homeowners who are part of the Oregon Trail Sister Program only pay a $\$ 20$ green fee and we thought it only fair that residents here should not have to pay more than a non-homeowner. The annual golf fee for homeowners was increased to $\$ 650, \$ 25$ more than the previous year; a non-golfer saw his annual homeowners assessment only raised by a mere $\$ 3$.

And, yes, your annual assessment is likely to rise substantially in the future as we have an aging infrastructure in need of repair, renovation or replacement. The aging infrastructure that I am referring to has little to do with the golf course. The Estates celebrated its 50th Anniversary in 2012.

Mr. Thomas, you questioned the $\$ 2,000$ initiation fee you paid in escrow to buy a home in The Estates. Did the realtor and/or title officer forget to mention that to you? I think not. Be thankful for that $\$ 2,000$ initiation fee as these fees pay for a majority of our Reserve Budget and without said fees, your annual homeowners assessment would have increased $\$ 183$ in 2014 rather than $\$ 3$ !

The comment you made that I agree with would be to open our golf course on a limited basis to the public. That would add some revenue to our budget, but keep in mind that the money raised in this way would only put a dent in the overall cost of maintaining our golf course. Exposure of our course to the public would be of more value as it might attract homebuyers or associate members who don't live here, but would like to play our course on a regular basis.

In conclusion, Mr. Thomas, I firmly believe that if the 1508 property owners within The Estates were polled as to whether they like $\$ 20,000$ of their hardearned money added to their Operating Account each year as a "bad debt", the vast majority would say, "No!"
[I want to thank Treasurer Johnson, Mr. Burt, and Mr. Thomas for their views. This is the last that will be published on this subject since it is not likely that anyone's strong opinions will be changed with further discourse. I hope we are all better informed regarding the assessments we all must pay. Ed.]
