

The proof of notice of this meeting was posted to the website, the bulletin board and sent out to all members on October 10, 2019 with the ballots and the census.

Establish a quorum of Members and Directors: 268 proxy's + 9 Directors + 73 members present total in quorum = 350. 20% of 1492 members in good standing needed 298.

Secretary/ Director Kilgore: I move to approve the November 12, 2014 Minutes of the Annual Meeting of the Property Owner Members.

Discussion: These were previously approved in a General Board Meeting on Nov. 25, 2014. It was brought to the attention of the 2019 President and Board Members by Diana Lindberg that the Annual Minutes must be approved by the Members. On the date 11/12/14. There were 1443 members eligible to vote and that 20% of that number is 290. There were proxy's votes and members present establishing a quorum, to approve said minutes according to Secretary Dave Bunnell. Copies of these are posted to the bulletin Board. Motion seconded and approved.

Director Linda Hepburn: Treasurer's report, 2020 Budget

Many hours of work and meetings with the BOD's, WEG employees and budget committee members have taken place to arrive at a reasonable budget for 2020. We have reviewed expenses and reduced projected account balances where we could. In order to balance the 2020 budget, more income needs to be raised. Several alternative proposals were discussed, reviewed and eventually tossed out. Since it is my responsibility, along with the full board of Directors, to present a balanced budget, I am proposing a \$20 increase to the homeowner dues. The only other increase is to the rental rates for the auditorium, dining hall and kitchen.

Our investments are doing well and we now have our CD's set up on a laddered basis and can project just when funds will be available for anything needed from our Reserve and Operating accounts.

This year, we were subject to a random State audit and at this point that audit has been completed. According to the State we are now 100% compliant with our accounting procedures and processes. The auditor went into great detail of every entry done to the books going back to 2017 and other than adjusting where some entries were recorded, no major problems were discovered.

On the bulletin board is a copy of the unapproved budget for the operating and reserve for 2020. I will be making a motion for approval of both the Reserve and Operating budgets and the fee schedule at our regular BOD meeting on November

News & Views reported a 40% increase in dues and fees.

January 13, 1968 News & Views article Nine Candidates Nominations to the Board. The annual SEGCC membership meeting held at the Woodburn Armory on January 9, 1968. There was 216 homes represented with nine candidates for the Board of directors and the election is Jan 29.

George F. Brice Jr., president of Senior Estates, Inc. presided at the meeting and disclosed that although a complete financial statement is not yet available, tentative figures show a net loss of about \$1,900 for the past year. Mr. Brice also stated that 80 members have been added during 1967. Due to the Change in the Bylaws, three directors will be elected annually.

January the News & Views reported Publication and Delivery to all residents courtesy of Northwest Natural Gas Company of Portland, Oregon. This occurred several times throughout the year.

February 15, 1968 Special Board for the proposed budget prepared by the finance committee. Treasurer Gus Stroh stated that in reconciling the 1968 budget to the present dues structure, a deficit of \$19,000. This deficit is against the Operating Expense budget for leveling and graveling the parking area out front, replacing the metal marine toilets with permanent toilets on the golf course, enclosing the shuffle board courts, enclosing the golf cart area, and in the RV area install drain tile for RV holding tanks.

March 5, 1968 Board minutes President Ed Stephenson has received one estimate of \$3,700 for the blacktopping of the parking lot. Also, stated that the clubhouses needs painting this year. Local volunteer painters will do all the work of applying two coats for \$600.

Secretary Max Dunham moved to hold regular meetings on the first and fourth Tuesday of the month starting the month of June – motion passed.

May 7, 1968 Board minutes House chair, Joe Blazek reported all the volunteers are doing an excellent job of cleaning, sealing, and painting the exterior of the clubhouse.

July 13, 1968 N&V article "Home Building" Bob Withers said Woodburn Construction Company, under the partnership of Bob Withers and Jake Triplett, has taken over home building operation at Senior Estates. Their construction company has opened an office at Oregon Way.

August 27, 1968 Board minutes members making comments were complaining about the golf dues structure between the single rate of \$105 and the man and wife rate of \$140. Clinton Miles suggested setting dues by lot ownership rather than by individuals for golf.

September 24, 1968 Board minutes planning chair Max Dunham presented estimates on the proposed improvements at the RV Park, a total of \$1,350 for a water and sewer pipeline to a cement block for trailer washing and general care.

October 1, 1968 Board minutes Rules chair, Richard Steen reported checking on the RV Park \$1,350 expenditure improvements. He found that of the 53 trailers only 27 showed visible evidence of having holding tanks. This is too few trailers to warrant the spending of \$1,350.

November 6, 1968 Board minutes led to considerable discussion ensued over membership applications coming from Mobile Home Park renters and the dues and possible extra payments to be assessed these renters.

Planning chair, William Marpert reported the request for many applications from owners wishing to install metal shed on their properties. Looking at Article III section F in the Declarations of Protective Restrictions attached to every owner Title Insurance which rules out the placing on any properties of outhouse, tent, shed or trailer.

November 26, 1968 Board minutes Merle Lietzke brought up the matter of thievery at the RV Storage area. President Pete Laurs appointed Bill Marpert to work with the trailer owners to solve the problems.


Member, Lee Heady asked what the actual amount charged against each lot by the developers for clubhouses and golf course. Answer was Senior Estates Inc. paid for them with no thought or break down per lot.

December 3, 1968 Board minutes described the preparation for the Annual Meeting of members set for January 14, 1969.

December 23, 1968 Board minutes a member Elmer Hayes brought a report from the 41 trailer owners asking for better security and weed control. Mr. Hayes stated that some owners are now using other areas for storing of their units due lack of security.
