EMERGENCY PREPAREDNESS

This past year has given us several opportunities to wish we were prepared for an emergency. First it was a pandemic forcing us to stay home more than ever before, then wildfires coming so close to us that we had terrible air quality and ending in February with a 100-year ice storm causing a massive power outage affecting all of Woodburn!

Most of us are guilty of being at least a little complacent when it comes to getting prepared for an emergency when there is not one happening at the moment. But... this is the time to do it so that when stuff happens, we will be prepared to handle whatever Mother Nature or whoever throws our way!

First off, disaster can strike at any time whether it's a home fire or an earthquake. There is also the possibility of tsunamis, wildfires, erupting volcanoes, wind and ice storms, landslides and even flooding. Sounds like a disaster movie, but any one of those (or more) could happen in the Pacific Northwest. There are some differences in being prepared for each disaster, but there are some steps that are the same for any eventuality.

You will need to make a plan with others in your household and make sure others in your family and neighborhood know of your details.

Emergency notifications will be issued via TV, radio, and weather radios. You may also be notified by phone or cell and through social media. As we found out in the wildfires, there are three Emergency Evacuation Levels. Level 1 means Be Ready for potential evacuation. Level 2 means Be Set to Evacuate at a moment's notice. This level may be the last you receive if conditions deteriorate rapidly. Level 3 means GO NOW. No other notice will be given and if you do not evacuate, you may not be able to be reached in time to help you.

- Wildfires can move at speeds of up to 14 miles per hour.
- Before a wildfire (these are also helpful to prevent a house fire):**
- Learn about risks in your area.
 - Remove flammable materials (wood, propane tanks, etc.) from within 30 feet of your home's foundation, garage or shed.
 - Prune trees so the lowest branches are 6 to 10 feet from the ground.
 - Choose building materials to remodel that resist fire.
 - Keep a garden hose long enough to reach any area of the home.
 - Gather items that can be used to fight fire, i.e., rake, bucket, shovel.

- During a wildfire:**
- Listen to air quality reports.
 - Keep indoor air clean by closing windows and doors. Put towels at the bottoms of doors to eliminate seepage of smoke into the house.
 - Use the recycling or recirculating mode on the air conditioner.
 - Do not burn anything to add to the smoke level such as candles, fireplaces and gas stoves.
 - Avoid vacuuming.
 - If you have asthma or other breathing problems, follow your doctor's instructions.

For any emergency, it is wise to keep important items handy. Keep hearing aids, glasses, contacts & cell phones near your bedside. Label any wheelchairs, canes, etc. with your name and phone number. If you know an emergency is imminent, remove all throw rugs, carpets or any furniture out of your way to prevent any impediments to evacuating.

- Before a winter storm:**
- Have working carbon monoxide detectors in your home.
 - Insulate your home by installing storm windows or insulated ones.
 - Maintain your furnace and chimneys by having them inspected annually.
 - Change furnace filters monthly.
 - Keep sand, rock salt or kitty litter around to make walkways less slippery.
 - Keep warm coats, hats, gloves, and blankets accessible.

- During a storm, especially when power is off:**
- Run water at a trickle to keep pipes from freezing.
 - Open cabinet doors to allow heat to circulate around plumbing.
 - Wrap outside exposed faucets.
 - Bring all pets indoors for the duration of the storm.
 - Keep garage doors closed.
 - Never use generators or grills inside.
 - Use an outside generator or a power converter to run refrigerators or other electric appliances. Consider buying lightbulbs that run on batteries and will stay on when electricity is off.
 - Avoid driving when conditions are unsafe.

- After a storm:**
- Let people know you are safe.
 - Replenish any emergency supplies used.

Especially for Seniors and Individuals with Access Needs:

- Write an emergency information card to include your medications, allergies, sensory or mobility impairments, special equipment you need and contact phone numbers. If you use augmentative communications, keep track of the model number and note where you bought it. Plan ahead for accessible transportation if necessary. If you use a wheelchair, label it and keep a patch kit to repair a flat. If you are hearing impaired, install a smoke/carbon monoxide detector that uses a strobe light. Keep pen and paper handy to communicate with first responders. Keep an extra cane by your bed that is easy to reach.

- Preparing Animals for Emergencies**
- Service animals and/or pets are allowed in Red Cross shelters but may not be allowed in other disaster shelters. Make a plan on where you will go with your pets or where you will take them (like friends and relatives out of the danger zone) to keep them safe during the emergency.
 - Contact hotels/motels to find out their policy on pets and if a no pets policy can be waived in an emergency. Keep a list of pet friendly hotels, including phone numbers in your emergency kit.
 - Keep a list of boarding facilities and veterinary offices that will shelter animals in an emergency. Ask local animal shelters if they provide emergency shelter or foster care for your animals.

- Keep your pet's essential supplies in a container that can be easily transported. This should include medications, copies of vaccination records, medical records and first aid kit for animal, leashes, harnesses and carriers to transport pets safely. Current photos of pets and paperwork for the microchip if they are microchipped. Food and water for 2 weeks, bowls, plastic bags, kitty litter, and manual can opener should be packed and bedding if room allows. Information on your pets' schedules, medical conditions, and behavior problems and the name and phone number of your vet should also be included.

The next issue of *News & Views* will contain a check list of what you should have on hand as emergency supplies for 2 weeks (other than for pets as that is indicated above).

January 12, 1980 N&V the 1979 President comments on groundbreaking.

In the year of 1979, the members of this club united to support the Board's efforts to expand our clubhouse and to annex the property that firmed up our boundaries. In breaking ground for the addition to our clubhouse, it is my hope that we, the members of this club, will continue to support the Board in its efforts to improve our facilities and establish programs and policies that will enrich the lives of all our members. January 12, 1980 N&V “GIFTS” program introduced – Now that our President has broken the ground for our new hall, it is time for us to start working toward the inside furnishings. We are going to have a fundraising program for this purpose. The program shall be called **“GIFTS”** for – Gratuities Ideal For Trustworthy Seniors and shall be known as this for all future references. All sorts of enjoyable and entertaining fundraising projects shall be used. We shall welcome any new ideas. We want no soliciting for funds and no additional assessments.

to club members. All commitments must be voluntary and entertaining. We are counting on you and the Board thanks you the members.

January 26, 1980 N&V – Governor Victor Atiyeh to attend 10:30 Coffee Hour – the Coffee Hour in Rush Hall on February 7 will not begin until 10:30 giving time for those who wish to attend the groundbreaking ceremonies for the new addition to SEGCC. A tent will be set up on Vanderbeck Lane, just east of Umpqua, in that case. Governor Victor Atiyeh will be the main speaker at 10 am. He has also agreed to speak at the regular Coffee Hour scheduled for 10:30. The groundbreaking service teed-off with the Governor, Woodburn's Mayor Walt Lawson, Marion County Commissioner Pat McCarthy, and George Brice representing Estates Realty, breaking ground with a giant golf club. Also on hand were Woodburn Construction Company, State Senator Tony Meeker, and our President Earl Ellis. The SPECTRO Tones from our Woodburn High School provided the musical entertainment.

January 26, 1980 N&V – Pro’s Chatter – The pro shop has taken on a new look. Jim and Jeanie have redecorated the golf shop by painting, cleaning, and rearranging.

February 12, 1980 Board minutes announced the zone change of the Association that was formerly in the county has now been annexed to the city for city protection and services.

Membership chair Mr. Burgard announced that, in an attempt to eliminate as nearly as possible, the chance of a buyer into the SEGCC not being fully informed during the process of a sale, as to certain important rules and regulations. A Memorandum of Understanding is being prepared which the realtors are to read and explain to the new buyer. They will then witness the buyers' signature, to be sure that it is understood.

March 11, 1980 Board minutes President Ellis announced that our annexation to the city has been confirmed.

April 8, 1980 Board minutes the secretary read a letter of resignation from Harold Bacon after serving the Board well for more than two years. A motion was made to accept the resignation – motion was seconded and carried. The treasurer Harry Crawford announced a **GIFTS** account of \$24,000 deposited in savings and time deposits.

Membership Chair Mr. Burgard announced that a "Memorandum of Understanding" has been prepared for signing by purchasers of new homes and resale homes. This document has been distributed to realtors or owners when their "For Sale" sign appears on a property. The purpose of the Memorandum is to help with records in our office and it will also provide a better understanding for the new owner. We are asking that if you see a "For Sale" sign in your neighbor's yard, please call the club office so that we may get the proper material to the seller.

President Ellis announced that Arden Benthien be recommended as a replacement for Harold Bacon – motion made and carried.

May 13, 1980 Board minutes President Stan Liss stated that with the assets of our entire club being worth over 3 million, common sense would dictate that a new owner(s) moving in should be assessed a charge to qualify as a shareholding member. Present homeowners have been contributing to the club assets some for over 15 years and longer. The Board of Directors is considering a resolution of intent to change the Bylaws by creating a new category to be called "share rights" (**initiation fee**). This would be a one-time charge for new owners coming into this great community for the first time. This charge is necessary to meet the costs of operating and maintaining the corporate business. Some of the discussion pointed out that with the considerable turnover of resale houses each year, funds would be provided that would enable our annual assessment to be kept at \$100 and needed improvements to be made. Frank McCully, speaking from the floor, pointed out that the initial cost for joining a private golf club in Oregon varies from \$750 to \$35,000.

Golf chair Cecil Eckert said we are looking forward to the budgeted purchase and installation (by our crew) of fairway sprinklers on the eleven holes serviced by the well pump alongside of #7-tee. This is the first step toward a fully automatic system.

June 10, 1980 Board minutes President Ellis called for discussion or questions from the floor regarding the “initiation fee”. Many arguments both for and against the proposal for establishing an initiation fee were presented. When everyone who wished to speak had done so, Mr. Liss moved that the discussion be closed. Mr. Liss then said our attorney had written the suggested wording. President Ellis then called for the vote and the motion carried. Mr. Flowers moved that the initiation fee required of purchasers of re-sale property be set at \$1,000 per lot – motion carried. Mr. Burgard then moved that the beginning date of July 15, 1980 as the starting date for the initiation fee. This initiation fee will also be applicable to ownership acquire through transfer of title, with the fee payable within 30 days after transfer date. If not paid in this period it will begin to draw interest on the 31st day at a rate determined by the Board and if not paid at the end of one year, a lien will be placed against the property for both amounts, and a lien for the interest on the total accrued amounts each year thereafter – motion carried.

June 14, 1980 N&V new manager at our restaurant – our arrangement with Dennis Robinson for operation of our restaurant is still in effect, but his former partner, “Ick” has had to leave us. In his place is John Sorensen, whose English wife Hillary is helping too. They worked with Ick before he left, and are in partnership with Dennis, who also operates the Markum Inn.

July 8, 1980 Board minutes a letter was read, indicating the intent to collect the necessary 250 signatures to call for a special meeting to exercise our right to vote on the initiation fee.


Rules Chair Liss, to get a better understanding of the initiation fee, it is recommended that the Board vote to HOLD action until the next meeting of the Board – motion carried.

August 12, 1980 Board minutes Dillon Burgard made the motion: since the petition to place the issue on an initiation fee to a vote of the membership has received the number of signatures needed, I move that my entire motion of the June 10, 1980 meeting, relative to the July 15, 1980 implementation of the **initiation fee, be rescinded.** He then explained that the motion was so worded that

inheritances of property could have been included in the fee collection and this was not the intent of the Board. During the discussion of rescinding the motion it was pointed out that this did not rescind the original Bylaw change establishing the initiation fee – the motion carried.

August 23, 1980 N&V – funds donated for Gazebo – the Board gave approval provided that no corporate fund is used. The gazebo will be similar to some used by our state parks. It will be six sided, have a cement floor, asphalt shingles roof, supported by six posts and a center post. The cost of the construction is set at \$4,000 was donated by phone directory \$1,700, Bingo \$1,500 and Picnic of \$800. Note the picnic fund came from merchant donations, people who did not use them, and beer donations. 15 men have volunteered to build it, and the Women’s Golf Club donated \$335 for trees around the gazebo.

September 9, 1980 Board minutes a letter from the Postmaster General to Al Ullman announcing his decision that door delivery of mail will be provided for section 8 in explanation of the letter it was pointed out that a federal regulation provides that all new developments must provide curbside mailboxes. But in order for the new section to have the same type of mail delivery service that the rest of SEGCC has, a request had been made by President Ellis for a variance of this rule. It was turned down by the Woodburn Superintendent of Mails, the Portland District superintendent, the regional superintendent in California, and the Assistant Postmaster General of the US letters to Senators Hatfield and Packwood also were to no avail, but a personal request from Al Ullman to the Postmaster General finally made it possible.

September 13, 1980 N&V Construction on the Gazebo was being done by a group of dedicated volunteers under the supervision of Stanley Gustafson and Harold Lichty. The willing workers were Jens Jensen, Wayne Swaggert, Elmer Fisher, Ed Rupp, Ed Schilling, George Gogl, Pete Hammerquist, Wilbur Anderson, Dave Clancy, Lloyd Peppmeier, Clyde Doss, Ralph Harmony, Don Wright, Arden Benthien, Ray Larsen, Earl Ellis, Matt Thomas, Burt Burton and others.



September 23, 1980 Special Board minutes and the results of the **initiation fee** election – the results of the special election in regard to establishing initiation fee for purchasers of resale homes were 643 for and 299 against. This also included two exemptions to the fee.

September 27, 1980 N&V article was the Golf Pro, Jim White and his wife Jeanie will assume management of our clubhouse restaurant. The restaurant will be open from 8 to 8pm, except Monday from 8 to 2 pm. A full menu of breakfast, lunch and dinner is offered.

October 11, 1980 N&V – Valuable tax information – one pertained to rules of the IRS for maintaining non-profit status. All Bingo profits are to be kept separate from the general fund, according to IRS rules, Bingo profits can go only into the building fund or to charitable causes. Telephone profits from directory sales are also kept in a separate account, upon which we do pay federal income tax. P.F.O. maintains a lobbyist at each legislature session to watch for privacy, age, and concerns of Workmen’s Compensation and Industrial Indemnity regarding the required state accident insurance for employees.

October 14, 1980 Board minutes Rule Chair Liss made the motion that beginning Oct. 15, 1980, any purchased agreement entered by buyer and seller of a resale lot or property within SEGCC corporate area will place the buyer liable to pay an **Initiation Fee** to SEGCC within 30 days after closing date. If the Initiation Fee is not paid in this 30-day period it will begin to draw interest on the 31st day at a rate determined by the Board and, if not paid at the end of one year, a lien will be placed against the property for both amounts, and a lien for the interest on the total accrued amounts each year thereafter.

For purposes of clarification, it was pointed out that this motion established the effective date for the Initiation Fee, and that the amount of the fee had been established at \$1,000 in a separate motion at the June meeting, and that motion had never been rescinded.

Rule’s chair Liss made another motion in regard to Article XI section 2 (A) Associate membership will have all the same privileges equal to the regular members, with the exception of voting rights. (B) Members who have lived in the Senior Estates for 3 years or longer, who then sell or otherwise dispose of their home and move into an apartment or condominium, but who remain within the school district #103C, shall be granted Associate Membership. (C) Lessees of resident member’s homes may become Associate Members by paying the appropriate fees, providing they are at least 50 or older – motion carried.

Then Liss made another motion to establish the Initiation Fee for Associate Membership at \$1,000 – motion carried.

President Ellis announced that donations for the **GIFT** program are still coming into the office, to the point that we are now but \$6,600 short of the \$61,500 goal.

November 11, 1980 Board approved the 1981 assessment, dues, and fees. There were no minutes found for December 1980.

Just Hanging Around

60 Years of Women’s Golf (1961–2021): Part Nine

The 1971 Installation of Officers for both the Men's and Women’s Clubs was a formal affair held on December 6, 1970. Florence Stack and B. C. (Chuck) Kirkman were installed as presidents. The Senior Estates Orchestra played for the Dance Installation on December 16. One hundred fifty-eight members were present.

Meanwhile, the Woodburn Senior Estates Entertainers, a men’s vocal group started by Rev. Charles Addleman and accompanied by Mrs. Barney Moran was extremely popular. He was a travel group leader and director of the Senior Estates Golf and Country Club. The vocal group wore bright green jackets along with white shirts and black bow ties and sang at functions both in and out of the community, including golf events.¹

Sixty-Eight women teed off at 8:30 a.m. after the Continental Breakfast on March 17, the kick-off for 1971. They had a luncheon after play for 141 members, which was touted as a “great attendance”.

On March 24th, the scheduled annual meeting was planned for Senior Estates at the local high school. Five directors were to be elected at the meeting. 474 certified members were now part of the organization.²

The local restaurant, Senior Estates Fairway Manor changed managers again with Mt. Angel restaurant operators, Mr. and Mrs. Paul DeShaw, having run the Evergreen Chalet for many years in that town. A grand opening was planned on August 15th with French foods as a specialty. This was announced by George F. Brice III.³ Many of our golfers enjoyed group dinners and lunches at this site.

The golf event, Fun Day, use the theme - *Old Familiar Songs*, with costumes represented the popular songs of the year. On August 18th, there was a shot gun start with 160 women playing, and a luncheon followed. The attendance was so large that the group needed a larger hall to accommodate the crowd.

The ladies continued to play Bridge and Pinochle during inclement weather for the rest of the year.
