

# Meals-On-Wheels to Ponder

The other day, there was a knock on my door. There was a smiling lady with two delicious smelling packages of food in her hand. She cheerfully said: "Here are your Meals-on-Wheels". That was a total surprise to me as I wasn't enrolled in that program and those meals were really for my neighbor. However, it gave me an opportunity to ask questions. I then went down to the First Presbyterian Church to check out the action myself.

These meals are cooked in Salem and then brought to Woodburn the first thing in the morning. It usually arrives by 8:30 am and the hot food is put into the ovens. All food comes in large pans, and they portion it out.

Then the wonderful volunteers come in to help. They first portion out the salads and desserts and put them in the coolers. At 10:30 a.m., they start an assembly line for the hot items. Each day, there is a choice between two entrees. They send out menus in the middle of the month and people send in their choices for which they want.

There is an assortment of tasks performed by the different volunteers. In addition to those who help portion out the meals, there are those who come to drive and deliver. At the end, hopefully, there are some to help with the cleaning up. Before COVID, they worked with the Woodburn School district with a program called 'Bridges' that worked with students. They helped in the kitchen.

It is quite the operation. They serve hot meals Monday - Thursday. They also send out frozen foods for the weekends. This is all coordinated by the meal site coordinator, Beth. She has been working there for 17 years. A lot of her volunteers have been with her since she started but they are getting older and are needing more help.

One interesting little note. This service doesn't just supply meals. The drivers are trained to check for 'warning signs' as they deliver the meals. Little things to look for that might show that something is not quite right in the home, and they can call for help if needed.

To get the meals, one must be 60 years or older. Beth explained her criteria when someone expresses interest. She asks the following question: 'Can you go to the grocery store, put your groceries away, cook your meal and then do the dishes...all without taking three naps?' If not, then you qualify for the service. There is a suggested donation of \$3 per meal. They do not base this on income but rather on the ability to cook and clean. The purpose of the program is to allow folks to stay in their home and yet provide for care and a quick



Roll Call: All Officers Committee Chairmen/Representatives were present unless otherwise noted in this report. There were 24 members in attendance at

**New Members Present:** No new members present. Our new General Manager, Justin Bolen, introduced himself and answered questions regarding the new requirement for mask protocol.

President's Report: President Westphal welcomed the members and then stated that with the passing of Mark Jorgensen there is a need for a member to volunteer to be the new Treasurer.

Vice President's Report: Vice President Biddle had nothing to report.

Treasurer's Report: Russ Krussow presented the Treasurer's report. He indicated the 50/50 Raffle money needs to be placed in a separate account. Voucher Account as of 07-07-2021 was \$4253.00. Men's Golf Club checking account as of 08-04-2021 was \$3952.57. Russ then stated that we currently have 160 members in the Men's Golf Club.

**Secretary's Report:** Secretary Dave Schuur had nothing to report.

**Committee Reports-**

Handicap: Russ Krussow stated that this Thursday's Men's Golf Club Play will have a 6-6-6 format. There will be two \$50 KPs on hole numbers 5 and 14. Next Thursday's format will be an alternate shot. The Men's Golf Club Championship will be held on September 2, 3, and 4. Russ also indicated that Phil Balogh has been selected to be on the Handicap Committee.

Greens: Ken Bourne shared that a prayer for Mark Jorgensen and his loved ones was conducted at the beginning of the last Greens Committee Meeting. He then stated that our Maintenance Crew is marking ground under repair on our golf course. The Northwest Tree Service will be grinding tree stumps, a project that should be completed by mid-September. The safety netting between hole 1 and hole 9 has been completed. He briefly discussed the upcoming hiring of a new Pro Shop Manager. The speed of the greens was discussed in addition to discussion about needing more sand in the traps and the trimming of trees near the cart path. Ken also stated that new score cards are needed. Member Will Abshere commented on the arborvitae trees that are falling over on hole number 11.

President's Welcome: Good afternoon, I hope everyone is staying safe. I have some announcements to make today.

Getting to speak at a board meeting is a privilege not a right. It is only to address motions on the agenda or at open mike to give an opinion, not a lecture or discuss personal agendas or attack each other. The gavel will come down if you are out of order, if your time is up, you will be done speaking. The gavel will also come down for Board members for discussion time limit of 3 minutes. The meeting is to be short, informative, make decisions and go home.

The Senior Estates Park "dog park" is owned by the city of Woodburn. It is maintained by the city and follows city rules. It is NOT an off-leash dog park. The only off leash park is Centennial Park with designated areas for this. In September the Senior Estates Park will be patrolled and off leash dog owners will be fined \$125.00 for first offense, second offence, you lose park privileges for three months. Follow the posted rules and pick up after your dog. Cigarette butts have also been found on the ground, this is a fire hazard, this caused the Aware food bank fire, so please be careful. Everything is dry and easily flammable. We will bring our concerns for cleanup of the park and proper signage for the park to city council meetings. Karen Linton has been asked and accepted to represent WEG at city council meeting. She will bring our concerns forward and bring back information from the council and report to Justin.

To keep our community as safe as possible, we are asking that nonmembers not be invited in the building. We now must wear masks in the building. Things are different outside in the fresh smokey air. Try to schedule things outside as much as possible. I hope all this changes soon for us.

The art center will be displaying artwork from our members in the living room. The large picture will be removed, and they will use this wall to display pieces. We still need to design a method to keep everyone's art safe. Several years ago, we lost some paintings. We have lots of talent here in our community, lets show it to everyone.

We now have an emergency preparedness group. A survey will be coming out in the N&V soon to find out our level of need. We will get you information to keep you safe, however we need updated records for everyone with updated phone numbers, members of households, and mobility levels. Please return the survey in box at office. Thank you

Our new manager is Justin Bolen. His office is open for appointments, so come meet him and discuss your concerns or suggestions. We all have great ideas and yours just might stick.

Amazon is sending a Representative here on September 2 at 10 am in auditorium to answer questions about the new facility being built here. Now is the time to ask for a wall. Masks required and registered at the office because seating is limited. MEMBERS ONLY

If you have concerns or questions, please call me or the office.

Treasurer's report: Operating Fund Balance: \$396,760.33. The Reserve Fund Balance: \$967,698.90. The RV Lot Fund: \$29,674.34. The Cart Path Fund: \$45,945.22

July had high expenses due to termination payouts and seasonal expenses. Our Accounts Receivable is at \$65,243.91. We usually end the year at less than \$30,000. This means we are still in need of collecting about \$40,000 in HOA dues for the 2021 year. This is contributing to our projected year end deficit. Our projected Operating Fund year end deficit continues to grow. It looks like we will be as much as \$109,000 short. This means we will have to borrow funds from our Reserve account. Remember, that any funds borrowed from Reserve

Fund must have a reasonable repayment plan attached. I have prepared motions that will allow us to borrow the necessary funds in time. If we cannot borrow the funds we have to begin shut down of operations as soon as October to be able to retain minimal staff to make sure facilities do not deteriorate and required administration is performed, but there would not be enough staff to use the facilities or golf. There will be more discussion of steps we can take during the budget committee report. Approval Treasure's Report.

The office has received several complaints about dogs in the Senior Estates Park (commonly referred to as the Dog Park). Many people don't realize that the park is not a dog park, but one of the many parks owned by the City of Woodburn. Therefore, the rules governing the park are set by the City. There is a sign at the park stating the rules—one of which is that all dogs must be on a leash at all times except in designated areas, but there are no designated areas for dogs in this park. There is an actual park with a fenced off-leash area for dogs in Centennial Park. There are fines associated with breaking any of the rules in any City-owned Park. For dogs without a leash in a city park, the fine is \$125 for a Class 4 Infraction.

The City of Woodburn has now announced that starting in September a compliance officer will be monitoring the parks and issuing fines. For many seniors with dogs, Centennial Park is inconvenient. So, a group of concerned citizens have signed a petition to ask the City Council to approve a fence around an area on the Astor side of the park for an off-leash dog park. As any information is obtained from the City Parks Department or the City Council, it will be published in the N&V. Stay tuned!

In the meantime, at the park or walking your dog anywhere in the Woodburn Estates, please be courteous to your neighbors! Pick up after your pet and dispose of it properly. There are doggie bags and trash cans at the park for that purpose.



## **Board Minutes (cont.)**

Architectural RV Committee met on August 18 at 1:30 pm in the conference room #1.

Agenda topics:

- 1. RV park violations have been given over to Rules & Regs committee for resolution.
  - 2. RV Park Security.
- 3. Discussion of the updated Property Rules & Regs wording and renumbering in the Rules and Regs section of our HOA documents.

Architectural report. Since January 2021 WEG homeowners have turned in 172 Architectural Request forms and 60 home sales compliance certification forms. The Architectural Committee has approved a majority of those requests. Many required site visits and each completed request requires a site visit to verify correct project completion.

RV Lot Report Early in August the RV committee provided the WEG office clerk a current inventory of units in each space. Due to the high turn-over of our office personnel, RV lot record keeping had lapsed a bit.

RV Lot security has been improved by adding 3 internal bars to the I-5 side of the lot, which makes it harder for a person going through a cut fence to avoid the alarm system. Other reasons for security improvements are:

- 1. Notified members to be certain the gate is closed behind them and not letting others following them in or out. Each entrance should be made using a current RV lot entrance member card verified by the office software system.
- 2. Some members cards were being utilized by non-members; members have been notified not to allow non-members access.
- 3. Members who have given up rented space? The office verified that those member cards RV lot access had been removed.
- 4. A future item to complete: we need to change our motion sensor camera positions and improve recording access to real time.

Golf Director Ken Bourne: Golf Report. Again, this has been a busy period of time for the Golfing Committee. The course has received constant play throughout the month. Here is a snapshot of the month's play.

July 31- The Women's Horserace which was won by Sally Carter and Betty Yaws

August 9-13- Women's Club Championship won by Carol Bettandorff August 14- Mixed Golf Tournament with many winners.

Many more big events to be held later in the month after this report period.

Golf Director Ken Bourne: Green Committee Report. The Greens committee held their monthly meeting on August 16th. The meeting was chaired by Russ Krussow as I was feeling ill. I'm not totally sure what all was discussed, but the scorecards were one item that highlighted. A couple of examples were displayed. I want to thank Steve Krieg for the work he has done on this project.

I also want to Thank Dave Robinson and his golf maintenance staff for the job they have done cleaning up the trees and stumps left by the ice storm. Dave had a tree service cut down all stumps damaged on the front 9 holes. The course is looking great.

**House Director Larry Jones:** The House Committee was called to order at 2:30 pm in the conference room. All members were present. Guests included President Sharyn Cornett and GM Justin Bolin.

The first item on the agenda was a discussion regarding the condition of the

folding partitions in the auditorium and dining hall. Money has been budgeted to repair or replace the existing folding partitions. Walt VanRheen and Vincent Cantwell will inspect existing partitions and make their recommendations.

I have put together a Request to Bid sheet to review and get committee input to make certain we are on the same page. I hope to have a bid list for the kitchen remodel job.

We met with the new Maintenance Supervisor, Vincent Cantwell. He gave us a fairly detailed report of his concerns on the conditions of the mechanical systems that provide for the needs of our community.

The House Committee is committed to making sure we keep facilities at Woodburn Estates & Golf safe and operating for our members. We will be working to answer his concerns when we have an informed answer.

#### Membership Director Steve Krieg - No Report

**Marketing PC Director Sherman Lackey:** Marketing PC Committee met August 18, 2021. Various items were discussed, including the number of hits the WEG website gets in a month. Revisited some previous topics from previous meetings. Discussed the current marketing Profit and Loss as of June.

Action items:

Sherman to investigate Google corporate account for WEG with a view of devolving a method of sharing *News & Views* content that is not printed (we have a lot of content that does not make it into the *News & Views*).

Sherman to develop a response to the "do you provide an electronic version of the News and Views that can be pushed to the members."

Kim and Allan to investigate using mail Chimp to push surveys to our members that are signed up for Bugle Blast. Surveys can also be printed separately in *News & Views*.

**Rules & Regulations, VP Director Carol Bolton:** The rules committee met on August 3rd and August 10 to discuss motions presented at the July board meeting and to amend the bylaws to update this document based on the motions that have been passed to date. This motion will be presented at the August board meeting.

The rules committee received 8 complaints in the month of July. Of those, 7 have been closed.

Treasurer/Budget Director Phil Balogh: Budget Committee reviewed June results. We are still projecting a deficit by year end. Discussion on possible way to reduce that. It was suggested moving the cost of damaged tree removal from operating budget to paying with Reserve Funds. A motion is being brought to the board to move \$79,000 from Reserved Fund to pay for the tree damage mitigations. This will be a significant help in reducing our projected operating deficit. Discussed changing the Reserve Fund bylaw to create Capital Fund that would maintain Reserve Fund and finance future capital projects. The budget committee members want Phil to come back with language that would be explicit that future boards could not use these funds for operations. Will propose language next m



# Time for Furnace Inspection

It is that time of year for furnace inspections. A little frost on the pumpkin will call for some heat in the house. So, before the chill hits, inspect your furnace, especially if it burns fossil fuel. All appliances that burn propane, natural gas, wood, or heating oil, are potential sources of carbon monoxide (CO) leaks. CO, a colorless, odorless gas, is produced by incomplete combustion of fuel.

A qualified technician can check your heating system for these problems: A cracked heat exchanger, inadequate fresh air, blocked chimneys or flues, or blocked appliance vents. Carbon monoxide poisoning is a form of slow suffocation. The gas attaches itself to hemoglobin, the oxygen-carrying protein in blood. The blood carries less oxygen, and the body suffocates. CO poisoning symptoms begin with sluggishness and headache. Later, there is dizziness and loss of consciousness.

Although CO poisoning has been getting a lot of publicity lately, the fact is that CO poisoning leading to death is unusual. In fact, in the U.S. (with a population of more than 250 million), there are only 800 to 1,000 people who die from it each year, according to the Mayo Clinic Health Letter. Nonetheless, if you use any appliance that burns fossil fuel, a CO detector is a good idea. Be sure to buy an Underwriter Laboratories approved detector that has some of the following features:

- \* An audible alarm.
- \* Power-on light.
- \* A manual reset button to silence alarm briefly.
- \* Test button to verify that it works.

# Let's Bake!

#### **Blueberry Buckle**

A quick and easy anytime cake

This sweet, tender cake comes together in minutes and can be eaten for dessert, as a breakfast coffee cake, or even a sweet snack. Fresh blueberries are perfect, but you can also use frozen berries -- just bake for a few extra minutes to make sure the cake is done all the way through. The streusel topping adds some satisfying texture and contrast to the fluffy cake and soft blueberries.

For the cake:

1/4 cup butter, softened

3/4 cup white sugar

1 egg

1 teaspoon vanilla

2 teaspoons lemon zest, more if you prefer a stronger lemon flavor

1-1/2 cups flour

2 teaspoons baking powder

1/2 teaspoon salt

1/2 cup whole milk, plus a tablespoon

1 tablespoon flour

1-1/2 cups fresh or frozen blueberries

For the topping:

5 tablespoons salted butter

1/4 cup brown sugar

1/4 cup white sugar

1/3 cup flour

1/2 teaspoon cinnamon

Cream the butter, sugar, egg, vanilla, and lemon zest together until fluffy. In a separate bowl, combine the flour, baking powder, and salt. Alternate between adding the dry ingredients and the whole milk to the butter mixture until just combined. In a separate bowl, toss the blueberries with the tablespoon of flour until evenly coated before gently stirring the berries into the batter. Spread the batter into a greased 8x8 pan.

To make the topping, combine all ingredients and mash with a fork (using a sharp knife can also help) until it has a crumbly texture. Sprinkle the crumble over the batter in the pan and bake for 45 minutes at 350 degrees Fahrenheit, or until a toothpick or sharp knife comes out clean from the center of the cake.

# Tech Ti

When the pandemic forced most of us to turn almost exclusively to our devices for our day-to-day routines, seniors were no exception. A generation that has often been hesitant to try new tech suddenly found itself learning about new tools -- a trend that may have stuck.

AARP's Annual Technology survey reported, not surprisingly, that ownership of all devices is up across all age groups. Spending increased significantly from 2019 to 2020, with older adults spending an average of \$1,144 on tech compared to \$394 in 2019. The top three tech purchases were smartphones, smart TVs and Bluetooth headsets/earbuds.

Seniors reported feeling better about tech, too. Forty-four percent said they have more positive feelings about tech now than they did prior to the pandemic.

Adults 70-plus like tablets, with 53 percent owning one, up from 40 percent in 2019. Nearly 70 percent of respondents said they use their tablets daily. More than half of those in the 70-plus group also own a smart TV, and their viewing habits had changed dramatically. Thirty-eight percent of adults 50-plus said they primarily watched network and cable TV in 2020, a figure that was at 60 percent just a year prior.

Still, some discomfort remains regarding cost, how-to, and privacy. About 44 percent of older adults are not confident that what they do online remains private, and more than half are not confident the information they communicate with their smart home assistant (like Alexa) stays private. More than half also said they want to understand their devices better.

Get ready for Windows 11. Microsoft is going to rearrange its classic task bar If you're a PC user, you've probably grown comfortable with the consistent and predictable task bar navigation that the popular Windows operating system has utilized since the release of Windows 95. It's always located in the bottom left corner of your PC screen, upgrade after upgrade.

But that will change with the newest iteration, due out this fall. According to CNET, Windows 11 will feature a redesigned task bar that will default to the center of your display. If that's going to drive you crazy, don't worry -- there's a simple fix that will put the task bar back in its old location.

Not all devices are compatible with the Windows 11. To find out if your current PC can run Windows 11, you can download a free open-source app called WhyNotWin11, which will check your system and give you information about potential compatibility issues. Microsoft will also make its PC Health Check app available sometime this fall. If your PC is compatible and running the most current version of Windows 10, you'll be able to download Windows 11 for free, according to Microsoft.

Once Windows 11 is downloaded, moving the Start button back to the left is simple.

- 1. Open the Settings app. You can do this by either pressing the Windows key and the letter I at the same time, or click the Start button and the Settings gear icon in the Pinned apps section.
  - 2. Inside the Settings app, click on Personalization.
  - 3. Scroll down until you see the Taskbar option and click on it.
  - 4. Click Taskbar Alignment and use the drop-down menu to select Left.

# The Woman Behind **Grandparents Day**

The mover behind a National Grandparents Day was Marian McQuade, a housewife in Fayette County, West Virginia.

Her primary motivation was to champion the cause of lonely elderly people in nursing homes. She also hoped to persuade grandchildren to tap the wisdom and heritage their grandparents could provide.

President Jimmy Carter, in 1978, proclaimed that National Grandparents Day would be celebrated every year on the first Sunday after Labor Day. This year that is Sept. 17. He said:

'Grandparents are our continuing tie to the near past, to the events and beliefs that so strongly affect our lives and the world.

"Whether they are our own or surrogate grandparents who fill gaps in our nobile society, our senior generation also provides our society a link to our natio heritage and traditions.

"We all know grandparents whose values transcend passing fads and pressures, who possess the wisdom of distilled pain and joy. Because they are usually free to love and guide...they can often reach out past pride and fear of failure and close the space between generations."

#### **Grandparents by the numbers**

- \* The average age of a first-time grandparent is 50. Some can be as young as 38.
- \*On average, grandparents spend about 7.5 hours every week with grandchildren. If they live within 20 miles, they spend 12.6 hours per week.
- \* About a third of grandparents provide financial support for their grandchildren. The closer they live to their grandchildren, the more they provide.
- \* About 70 percent of grandparents plan to purchase something to help their grandchildren. Among the top purchases: car seats, cribs, chairs, and clothing.
- \* Grandparents are happy. About 3/4 of grandparents say they feel fulfilled in life.

# Landscaping To-Do List

Summer comes to a close this month, and that means that it's time to get back to work in the garden. With a little time and planning each fall, you can enjoy better landscaping year after year.

- Remove faded and droopy summer annuals and replace them with hardier flowers. Pansies can take a beating through a light frost and will provide a splash of color through the fall. Mums are also a great choice.
- Plant any new evergreens during September and keep them well-watered until the ground freezes.
- Plant any new deciduous trees and shrubs. Use root-stimulating fertilizer to encourage root growth.
- Divide any overgrown spring blooming perennials and water them thoroughly after re-planting. After a hard frost, cut the perennials to the ground. • Plant spring-blooming bulbs. Make sure to consider color and height, placing
- If you have a vegetable garden, pull out the plants as soon as they finish producing and begin to wither.

smaller bulbs toward the front of your garden where you'll be able to see them in

- If you have bare patches on your lawn, the cooler weather is a great time for re-seeding or patching with sod because of decreased weed competition.
- Potted plants that go outdoors during the warmer months should come back inside. Use this time to remove damaged stems and leaves with yellowing, holes, or spots.
- Plant the rosebush of your dreams. Fall is a good time to plant roses, just not hybrid tea-style roses, which will not establish sufficient roots before winter.
