

# Regarding Amazon

It's been both an honor and a pleasure to represent Woodburn Estates on the Woodburn City Council. I take my work on the City Council very seriously, especially when it comes to matters that have a direct impact on our seniors and the community as a whole. Recently, I have been asked about the current Amazon development, which is the large (3.86 million sq. ft.) building being constructed immediately south of Woodburn's 1-5 Interchange, on the west side of the highway. The building is massive and hard to miss. Specifically, I have been asked questions about property tax breaks and other incentives the City provided Amazon to locate in our community. So, I thought I would write this letter in the hopes of providing accurate information.

First, the City of Woodburn provided NO property tax incentives, tax exemptions, or tax incentives to Amazon. That's right, Amazon will be paying their "full-boat" property tax bill based on their tax-assessed value, just like the rest of us.

These taxes support our police, parks, library, and other important services. Amazon is also paying approximately \$7.1 million for their infrastructure impacts (so those costs are not passed along to us).

Here is a breakdown of what Amazon is paying to offset their impact on Woodburn:

- \$5.4 million in transportation fees
- \$250,000 in water fees
- \$900,000 in sewer fees
- \$275,000 in park fees
- Amazon is also picking up
- \$7.5 million in building permit and plan review fees
- \$300,000 for a transit bus to serve the employment centers west of I-5
- \$25,000 for transportation demand management programming
  \$17,500 for art/signage at the roundabout

In addition to paying taxes and fees, Amazon is paying (approximately \$15 million) to make physical improvements needed to support their project.


- Off-site improvements are at several Highway 219 Intersections
- Improving the Parr/Butteville Road Intersection
- Fixing the Butteville/Highway 219 Intersection with a new roundabout (something that has been needed for years)
  - Widening I-5 Highway Exit Ramps
  - Constructing Butteville Road improvements
  - Water/sewer line extensions needed on the west side of the city.

The city has indeed secured some state grants to address the needs of Highway 219 that existed before Amazon's arrival. These requirements have been imposed so that the community, Woodburn Estates included, do not have to bear the burden of this development.

Finally, I am excited about the partnership and jobs that Amazon will provide. These will be good jobs for many working families in our area. In fact, I have been told that Amazon's employee health insurance benefit package will help bolster the viability of our existing medical providers. Certainly, that would be another good outcome.

# Realtor Training Course

If you come around the clubhouse on April 15th, you might not be able to access the auditorium. There will be a Realtor Training Course taking place. We are happy to welcome all the different agencies that are coming in to learn more about our HOA and the requirements involved with each sales transaction. Even though the training course is not open to the community, it is a wonderful advantage to anyone here that is wanting to sell their home. The office reports that there are about 20 different brokers who have signed up for the course. Welcome to each of them!

Selling your home is a big endeavor that can also be very stressful. Working with a good realtor can make all the difference in having a smooth transaction and reducing your stress. There are many people involved in a real estate sale: buyers, sellers, realtors, lenders, escrow, and your Homeowners Association (HOA). It is the job of your realtor to work with all these people ensuring that each has the documents they need and does their part to close the sale on time.

There are generally 100-125 homes sold in Woodburn Estates each year. The HOA has seen an increase in problems with realtors who are listing homes within Woodburn Estates who are not familiar with the area and the HOA rules and requirements for the HOA to sign off on closing the sale. Local Realtors generally have this knowledge, but those from outside the area often do not. As homeowners always have the right to choose any realtor they want, the HOA is working to develop training for realtors so that transactions can be completed correctly for all.

The training will be two hours and include an overview of the development and the HOA. It will cover the steps and paperwork required by the HOA to approve a sale. Brokers will be shown how and where to find all the documents needed by buyers and their lenders. They will be introduced to staff who handle these transactions. At the conclusion of the training, brokers will be deemed 'Certified' by the HOA. The list of Certified Realtors will be included in the *News & Views* as well as being available at the HOA office. This list can be your guide in choosing a realtor who will know how to work with the HOA to close your sale smoothly. Watch for the list to be published soon.

Jeanie White of McCully Realty will present this training program. Jeanie and her husband Jim have owned McCully Realty since 2007. Jeanie has worked with the HOA staff to develop the training program and its presentation of it.

A special shout-out of support to all the local brokers in this area who work hard to represent us. They do a wonderful job of 'selling' the community and they support the publication of the *News & Views* and the Directory.



# N&V Recap

The following information was published by Bugle Blast and then posted on the N&V+ page of the website. After it appears in the *News & Views*, it will then be deleted. This is a recap:

#### Comcast working in the neighborhood

The time has come! Comcast is now working around the community and may be accessing your backyard. Please know that they do not need permission to do this.

February 8, 2022: I am the project manager with Comcast and am reaching out to you today to start the discussion around the construction we will be doing in your community.

Most of the lines will be placed on the existing PGE poles. There will be some locations where we will need to place conduits and pedestals in the public utility easements as well.

Most of this work will require Comcast contractors to access residents' backyards since this is where most of the utility easements are located. At this time, we will only be working in the utility easements, and will not be placing any lines to the residents' homes. Lines will only be placed to the home once the resident requests service.

The contractor that has placed these lines will be hanging a leaflet on doors, usually a week beforehand. I was hoping there would be additional means to get this message out since we will be needing access to the residents' backyards. Our leaflets are often mistaken as advertisements, and just thrown in the trash.

My hope is that we can make this as easy as possible for your residents since it can be a bit concerning when people show up to work in your yard. We're always available to walk out to discuss any concerns that there may be or answer any questions that may come up.

#### Covid-19 Test Kits are available

A large supply of test kits was made available to our community. They have been in the front office and recently, a supply was taken to the living room area by the library. Because they have an expiration date, any extras will be donated to some local churches.

#### **Covid-19 Prevention Strategy put in place**

After further research, there has been a consensus to put in place the following Covid-19 Prevention Strategy, based on CDC's guidelines and community tools:

The COVID-19 COMMUNITY LEVEL INDICATOR will be consulted every Thursday.

Depending on the level indicated, the following restrictions will apply.

#### When level is Low:

- · Get tested if you have symptoms
- Wear a mask if you have symptoms, a positive test, or exposure to someone with Covid-19
- You may choose to wear a mask at any time as an addition precaution to protect yourself and others.

#### When level is Medium:

Implementation of enhanced prevention methods

- For groups of 10 or more, masks required
- · Show proof of vaccination or negative Covid Test
- If you have symptoms, a positive test or exposure to someone with Covid-19, please do not come.

How to know if the IRS is really calling.

IRS scams are everywhere, bilking people out of thousands of dollars, and fraudulently obtaining their personal information.

Phone scams are big during tax season. The thing to remember is that the real IRS will never:

- \* Call to demand immediate payment using something like a prepaid debit card, gift card, or wire transfer. If the IRS wants money from you, they will send a letter first. It will not come as a surprise.
- Threaten you. The IRS will never say they are going to bring police or any other kind of law enforcement personnel to arrest you.
- \* Demand tax payments without offering you the opportunity to appeal or even ask for details about the demand. \* Call you about a tax refund. They might write to you, but they will not call
- If you receive such a call, note the number, and hang up. You can report the fraud at treasury.gov/tigta/reporterime misconduct.shtml

### **Easter Jellybeans Have** a Colorful History

They are as common as eggs at Easter, but no one really knows exactly where the colorful, lovable, jellybean came from.

According to the National Confectioners Association, the jellied center of the sweet bean probably came from a middle eastern candy known as Turkish Delight, which was famous even in Biblical times.

The most modern part of the bean is the shell that gives the jellybean its famous al dente bite. Today's jellybean is a descendent of a 17th century process used to make the candy coating for Jordan almonds in France. In a panning process, almonds were rocked around a large bowl filled with sugar and syrup until they were coated with a candy shell. Today, machines now do the rocking and rolling.

The shell and the jelly came together in America by 1861, when the earliest known advertisement for the candy appeared.

William Schrafft of Boston promoted the jellybean and advocated sending the beans to Union soldiers at Christmas during the Civil War. By the 1930s the jellybean had become a staple of Easter celebrations. In fact, about 16 billion beans are sold at Easter alone.

Jellybeans have also become part of the spicy candy trend that began around 2018, according to the Candy Store. In 2021, the favorite flavor of jellybean was cinnamon. The second favorite flavor was also the most intensely hated: Black licorice – you heard that right. Coming in third was buttered popcorn and fourth was cherry.


