

Balances:

Operating Funds: \$495,474

Working Capital Fund: \$277,745

Reserve Fund: \$876,117

Budget Committee met on July 19, 2022.

Reviewed Profit and Loss for June. June had a negative margin of \$73,861 versus a budgeted margin of negative \$107,907, so this is a positive result. Revenues were \$30,000 higher than budget and expenses were \$4,000 under budget. July's results will be critical to determining year-end performance.

Year to date we are negative \$28,517 to budget. However, if current trends continue, we should finish close to budget.

Cash flow trending positive for the year with a balance of \$40,000 projected. At this point, it is only a projection and with our small margin, we need to watch cash flow closely.

Working Capital fund grew \$42,877 due largely to home sales Working Capital Fees. We are working on funding portions of the Reserve Study projects and we have some roofing projects that need completion. We are still waiting on pool and spa costs to fund that project.

We are beginning 2023 budget process.

Budget committee schedule:

August 16- review operations team draft.

September 20- Make WEG board and other requested adjustments.

October 18-final draft budget preparation for membership submission.

November Board meeting- Board approval.

The 2021 audit has started.

HOUSE COMMITTEE

Summary of House Committee Report from BOD Meeting: Director Marilyn Sbardellati July 26, 2022

On July 6 Northwest Geotech, Inc. drilled two borings adjacent to the exterior north side of the pool and spa building. These borings will provide subsurface information for underpinning design parameters associated with re-support of the common spa/utility room foundation and monitoring of groundwater levels for use in pool maintenance and repair projects. A geotechnical report is forthcoming which will describe subsurface conditions and provide us with preliminary recommendations for use in future site planning, repair, and development of this building site.

Work on this project proceeded only after a utility location service cleared the drilling site. Unfortunately, their work was subpar, and a gas line was severed. This caused a shutdown of the pool and locker rooms for an extended period of time. The gas line is repaired, and recovery of that cost is pending.

While the pool and locker rooms were shut down, our maintenance crew rebuilt all the shower fixtures, thoroughly cleaned the floors, and completed smaller maintenance projects. Other plumbing repairs were also completed.

The exhaust fan for the pool failed and is scheduled to be repaired or replaced. Until that happens, the doors need to remain propped open to allow for air circulation and to reduce humidity in the space. Members will need to be patient with the doors being open and repair crews present as they work to repair the exhaust fans and install wiring for ceiling fans in the locker rooms as there will be no air conditioning in that space this summer. The exhaust fan is now repaired.

While the water was shut off, testing continued to determine the cause of the loss of water to the pool.

Repairs to piping in the pump room will need to take place soon. Expect a one-to-two-day pool shutdown in the near future for this to take place.

Once the geotechnical report is presented, the House Committee will convene to determine our next step.

ARCHITECTURAL/RV

Summary of Architectural/RV Report from BOD Meeting: Director Gene Nemish July 26, 2022

ARCH-RV Committee met on July 20, 2022. We had 4 committee members attending, also attending were our Facilities Manager and the Sales Manager of Integrated Solutions.

Item 1 – Marty, the Integrated Solution Sales Manager provided detailed information about the operation and capabilities of the RV lot Security. The video system, which was installed this month to replace the existing security camera system, had failed.

Item 2 – The committee decided that the yearly inventory of the RV lot spaces will be done in August. All documentation will be provided to the office for verification of existing RV lot space usage records.

Item 3 – As the new video system can serve 32 cameras, we will take bids to add more video security coverage of the lot, the added cameras will provide additional security. The bid request will also add RV lot video coverage reports to the existing WEG HOA alarm system.

Currently, RV lot security is an Ademco Vista Series beam system that provides an interruptible laser red beam around the fences, if the beam is interrupted the system sends notification to another alarm monitoring company.

Item 4 – Architectural Requests are going strong again this year, we are making site visits and calls to verify that all home changes and work is done properly following our HOA guidelines.

Summary of Marketing PC Committee Report from BOD Meeting: Director Sherman Lackey July 26, 2022

The Marketing/PC Committee met and discussed:

- The current income level for Communications and *News & Views*.

- Up grading the electronic reader boards with a service that supplies proper screens and can have up to 4 different people administer.

Many complaints were regarding illegally parked RV/motor homes and the lack of yard maintenance. The Rules Committee closed out all but a handful of complaints. Less than 5 remain pending. There was only 1 complaint since July 8th.

The Rules Committee wants to thank all the WEG members that take the time to file a complaint. Also, we would like to thank the Woodburn Code Enforcement team.

TREASURER/BUDGET REPORT

Summary of Treasurer and Budget Report from BOD Meeting: Director Phil Balogh July 26, 2022

Balances:

Operating Funds: \$495,474 Working Capital Fund: \$277,745 Reserve Fund: \$876,117

Budget Committee met on July 19, 2022.

Reviewed Profit and Loss for June. June had a negative margin of \$73,861 versus a budgeted margin of negative \$107,907, so this is a positive result. Revenues were \$30,000 higher than budgeted, and expenses were \$4,000 under budget. July's results will be critical to determining year-end performance.

Year to date we are negative \$28,517 to budget. However, if current trends continue, we should finish close to budget.

Cash Flow trending positive for the year with a balance of \$40,000 projected. At this point, it is only a projection and with our small margin, we need to watch cash flow closely.

Working Capital fund grew \$42,877 due largely to home sale Working Capital Fees. We are working on funding portions of the Reserve Study projects and we have some roofing projects that need completion. We are still waiting on Pool and Spa costs to fund that project.

We are beginning 2023 budget process.

September 20- make WEG board and other requested adjustments

October 18- final draft budget preparation for membership submission.

November Board meeting- Board approval.

The 2021 audit has started.
