NEVER SHARE YOUR CARD NUMBERS, PASSWORDS, OR VERIFICATION CODES

To Prevent Fraud and Theft

Never give your account numbers, passwords, social security number, verification codes, etc. to anyone, especially over the phone. Social Security and the IRS NEVER call you; they always send letters. Never send anyone cash EVER or a cashier's check without verifying that person/company is legitimate.

If someone calls collecting a debt you owe, contact the company involved before sending money. All legitimate companies accept your personal check or the checks your bank sends if you bank online. Be suspicious of anything sounding "off" or strange of if something sounds too good to be true.

If someone comes door-to-door attempting to sell something, ask if they have a City of Woodburn license to do so. Most do not and will go away because you have asked to see it and they can't produce it. Then call the non-

emergency number for the police. 503-982-2345. Unless you have called the person or company to come to your house, NEVER let anyone into your property.

Also, if you are going to be away for awhile, never advertise that on Facebook or anywhere else. Make sure you stop your mail and/or newspaper so that they don't pile up, making it appear no one is home. Get timers for two or three lights/lamps and set them to go on and off at different times of day or night. Have your neighbor check on your property and if they can, park a vehicle in your driveway a few times while you are gone. Make sure your yard is mowed.

Unfortunately, there are crooks who prey on the older population, so we need to protect ourselves and our loved ones from them. Better to be safe than sorry is not just a platitude, it's how we need to live our lives safely.

Preparation and scheduling for plugging and sanding of the fairways and greens for the upcoming busy season has also been delayed by the wet weather. House Committee Director Marilyn Sbardellati.

The House Committee met twice during the month of March. The pool's pump rebuild project is complete and the pool is now open. We now have two pumps and four sand filters filtering the pool, providing improved filtration. There is now all new plumbing from approximately 2 feet below the floor's surface on up. I want to thank Ron Nelson, James Taylor, Charlie Brown, Carl Conser, and Shawntae Lonergan, for their hard work and extra hours put in towards completing the project. I also want to thank Jeff Kosten of Done Right Plumbing, Northside Electric and CJ Hanson for their professional assistance.

The pool sub-committee is coming together. We are beginning with four members; their first meeting will be this Thursday the 30th. We can still use a few more members, anyone interested in joining can email house@woodburnestatesgolf. com.

A month-to-month lease agreement with Country Cottage, voted on by the board at last month's meeting, was not secured. A long-term

lease will still take some time and the month-tomonth agreement is still a necessity. An inventory of WEG assets in the restaurant is needed, as it is part of any long-term agreement. The only time an inventory can take place is on Sundays after 3 pm, unless we are to work late into the night. We, I and two House Committee members, will begin the inventory process this Sunday, April 2nd. If not completed, we will continue on the 16th.

There are three projects pending, fire suppression work, roof repair/replacement, and an HVAC project. Details, pricing, and scheduling to be determined.

- The News & Views opt-out is progressing, and we have 20 members that have opted out of the paper edition in favor of the digital edition. We will print 1,600 paper editions for March 24, which is down 150 copies from last year.
- The newly acquired display rack will contain informational brochures for the community. Like reminders to have smoke detector batteries checked or information from CERT, plus new advertising guidelines.
 - We are developing new advertising guidelines.
- We ran only 120.00 dollars short of breaking even on the first edition in March. We still need more paid advertising.
- Decided that all free, and in-house ads, will be 5" wide by 4" high or 3" wide by 5" high.

We also looked at the number of ads that we publish that are free. Looking at the financial bottom line for Publications of News & Views for Woodburn Estates & Golf clubs and activities, we know that we have recognized, but not reported the revenue value for any group for this service. This practice will continue, with no charge to any Woodburn Estates & Golf recognized clubs or events. Going forward that service amount will be reported as the potential income if the space used was charged at normal rates. Greens Report Dave Robinson GC Superintendent March 2023.

Hello everyone,

March has been a productive month despite the rainy and frosty conditions we've had. Our two big projects for the winter have been to raise greenside irrigation heads, and limbing up trees.

The greenside sprinkler heads on the front 9 have been raised, and two holes on the back 9 are finished. There are not as many on the back 9 to be raised because many of them are already up to grade. We should finish in the next few weeks,

We still need to finish liming up trees on #'s

7,8,9 on the front 9, and the back 9 to complete. I don't know if we will be able to complete the back 9 before we get busy with the seasonal maintenance routine

We have 4 greens that have damming issues holding water in the front of the greens. These greens need to have the sod removed on the approach side and then grade down the fronts of these approaches so the water will dissipate out onto the approach rather than holding water on the greens causing damage.

The irrigation system is getting a long overdue tune up. I have scheduled to have the green irrigation boxes cleaned out thoroughly of spider webs, insects, and bug nests that have created connectivity issues in the wiring in these boxes.

The irrigation computer is being tuned also. Right now, an average night watering program in June or July runs from a start time of 9:30pm until 8am. That's terribly inefficient. The water to irrigate with isn't a big cost. The electricity that runs the pumps is what adds up to the cost. When the computer has had the nightly watering programs balanced out to a much more efficient flow it will be done watering the golf course around 4or 4:30am. That will add up to about a 20% savings on that electric bill to run those pumps.

We'll be applying fertilizers and broad leaf weed applications in April. Last spring, we had a record setting rain fall in the months of April, May, and June. That had a big impact on the Crabgrass problem we had last year. The chemical treatment for Crabgrass must be applied in the spring which was too wet to apply those chemicals.

We got back on the seasonal topdressing program of sanding the fairways this week. That went very well thanks to Pacific Sports Turf. Under very wet conditions they did a great job avoiding our wet areas leaving a minimal footprint after they left. They were done in a day and a half. Money well spent. Being short staffed it would have taken me better than a week to complete. When we are done with all the aerifying of greens, tees, and approaches we will spread the remaining sand to problem wet areas on the course. Areas like the rough at the beginning of #3 fairway, left side rough of #3 rough, and exit area of #18 rough up on the right side near the green.

I have a requested bid for cart path repairs on 11/17 near 11 ladies' tee where the cart path is being pushed up from tree roots underneath. From our maintenance area going north towards 17 green where it connects with 17 cart path, #8 cart path where the tree fell during ice storm and widening the corner by the enclosed patio next to the Cottage restaurant. That bid came to \$28,790 dollars. I have also reached out to Bernhards construction to get a bid for rebuilding number 5, 7, and 17 tees.

Last golf season we were half of the staff from in the previous seasons, and with no mechanic which are all needed to properly maintain the golf course at Woodburn Estates. A full staff is what Tim ran the golf course on to keep it maintained up to the clubs' standards. A full staff for a season should be myself, a mechanic, 4 year-round employees, and two seasonal workers. Currently it's myself, my mechanic and two year-round employees. On that note we have a great new mechanic named Mike Kessler. I am at less staff than that going into the upcoming season. This is going to be, I expect, another similar situation as that we had last season. Outside of the regular mowing schedule is going to be very difficult to maintain the details. Maintaining weeds in tree wells, landscape beds, and applying chemicals is going to be difficult. The entire country is facing a big problem with getting the work force to return after the stimulus checks, and the shutdowns from Covid. Places like McDonalds and Burger King are offering a starting wage of \$15.50 to \$16 dollars an hour with benefits to start. Amazon will be opening soon offering 18 dollars an hour to start with benefits. A competitive wage offered I believe is the only thing that is going to solve this situation on our property. My department has had the highest turnover of employees on the property for probably the last 2 years. I will train someone with a skill set, and after 3 to 6 months after that they move onto another property making more money. We do and will always put our best foot forward to offer the best playing conditions collectively inside of our abilities. Thank you very much. Dave Robinson Golf Course Superintendent


