Rules and Regulations Report – Director Jaime Rodriguez

The Rules Committee met twice on August 5th and again just yesterday on Aug 18th. We reviewed the 9 complaints that come into the office and a formal complaint was filed. An email to a BOD or phone call to the office is not a formal complaint. We did instruct the office and management team to send several letters of violations and possible fines. Most of the 9 complaints should be rather simple as they are illegally parked RV/Motors/Vans on street or driveway. Rules violations 12.1 and 12.2.

We do have two continuing violators from the Spring. Non occupied owners who are living in their mother's member homes. 1 has a family with school children who were given to the end of school year and now we are about to start a new school year. The second has a history of police activity over the least 24 months and is a nuisance to neighbors. In both cases the renters do not meet age requirements for WEG. Legal action is being pursued.

Thanks to committee members and management team for their time and coordinated efforts to keep a safe and beautiful WEG.

The 5-member committee met on July 8th and 22nd to review and close out complaints for the first part of the year.

Big thanks to the management team for attending the July 8th meeting and assisting with closing out some months-old complaints. There were nearly 50 official complaints that dated back to February. These were formal complaints that were submitted to WEG office. There were dozens more complaints that were rejected for lack of info. Things like dog excrement, barking issues, cats running across members yards, or motorcycles too loud, are not vital complaints

that the Rules Committee can do anything about without proper info. Many complaints were regarding illegally parked RV/Motor homes and the lack of yard maintenance. The Rules committee closed out all but a handful of complaints. Less than 5 remain pending. There was only 1 complaint since July 8th.

The Rules Committee wishes to thank all the WEG members that take time to file a complaint. Also, would like to thank the Woodburn Code Enforcement team.

June 28, 2022

Summary of Rules and Regulations Committee Report from BOD Meeting: Director Jaime Rodriguez

June 28, 2022

The Rules committee met on June 10th and 17th to catch up on some complaints submitted from May 24th to June 10th.

Several letters have been sent regarding street parking and non-owner occupancy which has been causing multiple disturbances and calls to police for activities past 10pm.

The Rule continues to receive multiple complaints regarding unkept yard maintenance of Vacant Homes whose sales are pending and /or abandoned.

The Rule committee will be meeting 2x a month to get complaints resolved sooner starting in July and the Rules committee wishes urgent Exec Session meeting due to some Rules needing BOD approval before sending out letters as a first warning prior to sending 1st fines.

Also, the committees is asking for more guidance from GM and BOD President in vetting and resolving some complaints involving WEG owned property.

Rules and Regulations committee did meet on April 15th. All five members were present, and we reviewed the complaints that came in for the last 30 days. There are some issues regarding yard maintenance. Two formal complaints and several phone calls that came to me. Some members see other yards that are immaculately maintained, and they called wanting referrals. I had two calls from members who were out of state. As I come to being here at the WEG a year and a half, I realize that while not everyone goes south for the winter, there are several members that do leave, sometimes for months at a time. I had a member call me yesterday, as they are in Arizona and expect to be there for several more months. They received a call from their neighbors saying regarding their yard needed mowing and weeds pulled. He called me and I gave him three lawn listings. He found one and that was great. We want to maintain our yards the best that we can. I received two complaints of vacant homes whose yards are out of control. I assumed that the company has responsibility to maintain those yards while the homes is being sold. Weeds have no time off. Our next meeting will be held in a few weeks. I believe May 15th. Regarding the two vacant homes. It is difficult to follow through when there are no owners. I can go and knock-on door but if no one answers, it is difficult. I do my best. I do know that yard maintenance at this time of year is very important.

The Rules Committee meet last week on March 11 with 4 of 5 members in person in the News and Views Office

We discussed and decided to have Chair write letter to #1182 for a second offense on bringing Hard Liquor to a WEG facility.

Second offense since Dec in which a letter and fine of \$100.00 was paid. This time the fine was increased to \$200.00

Stan Hiller has started a spreadsheet of complaints. The Rules Chair and committee is starting to catchup from Dec 2021 and Jan/Feb 2022. 22 complaints received and as of March 17th another 6.
