

# Woodburn Estates & Golf Men's Golf Club Monthly Meeting ~ October 4, 2023

The Men's Golf Club of Woodburn Estates & Golf met for its monthly meeting on October 4, 2023 at 10:00AM in the WEG Dining Room.

President Fred Bourne CALLED THE MEETING TO ORDER at 10:02AM, followed by the PLEDGE OF ALLEGIANCE. All officers and committee chairmen/ representatives were present unless otherwise noted. There were 32 members in attendance. **PRESIDENT'S REPORT:** Fred Bourne reported that nominations for Men's Golf Club officers will be on the agenda for the November meeting.

VICE-PRESIDENT'S REPORT: Mike Archer reported on an idea on how to bring the golfing community together with the community at large through fundraising tournaments next year for area non-profit organizations. He will have more details at our next meeting.

- **TREASURER'S REPORT:** Treasurer Dean Cullison gave a report for the past two months since the club did not meet in August and no report was given in September.
- Checking account: Beginning balance on August 1 of \$3,388.77 with an ending balance of \$1,947.50 on September 30 (\$1,900 went out for the Turkey Shoot tournament and several plaques were updated in the golf lounge).
- Voucher account: Beginning balance of \$6,554.40 on August 1 with an ending balance of \$9,649.22 on September 30.
- The Treasurer reported 136 current members.

A reminder was made that all voucher funds need to be spent by the end of the year with no carryover going into the new year. Purchases can be made with any of the pro shop's vendors, including Amazon. 2024 golf trail stickers for golf carts can also be purchased with the funds. Contact the pro shop for more details. OGA dues next year are still to be determined, though voucher funds cannot be used for payment of dues per OGA regulations.

SECRETARY'S REPORT: No report by Steve Kufeldt.

- **GREENS COMMITTEE REPORT:** No report by Ken Bourne. Fred reported that the course will be closed Wednesday, October 11 for aerating and sanding of the greens. There are some small trees growing on the course that will be transplanted along the wall on hole #2. A question raised noted the number of trees that are being taken down and whether there is a plan to plant new trees. It will be investigated.
- HANDICAP COMMITTEE REPORT: No report by Marty Smith.
- **MIXED TOURNAMENT COMMITTEE REPORT:** Fred Bourne reported that the schedule for next year's tournaments has been formulated and will be presented to the WEG board for approval.

- While putting on the green and your ball strikes another ball on the green, it is a twostroke penalty and the opponent's ball must be replaced in its original spot.
- If chipping onto the green and a ball is struck, there is no penalty. The ball that is hit must be replaced in its original spot.
- If the ball comes to rest on or near a movable object, like a rake, and the ball moves while moving the object, the ball must be replaced in its original spot and there is no penalty.
- If a ball on the green is putted and runs through the green and unintentionally strikes another player's club or equipment, there is no penalty and the ball is played where it ends up.


