## WOODBURN ESTATES & GOLF - MEN'S GOLF CLUB MONTHLY MEETING | November 1, 2023

The Men's Golf Club of Woodburn Estates & Golf met for its monthly meeting on November 1, 2023 at 10:00AM in the WEG Dining Room.

President Fred Bourne CALLED THE MEETING TO ORDER at 10:02AM, followed by the PLEDGE OF ALLEGIANCE. All officers and committee chairmen/representatives were present unless otherwise noted. There were 32 members in attendance.

**PRESIDENT'S REPORT:** Fred Bourne made a motion (seconded by Stan Hiller) that the current officers of the Men's Golf Club (Fred Bourne, President; Mike Archer, Vice-President; and Dean Cullison, Treasurer) be re-elected by acclamation. The motion passed unanimously. Other positions are appointed.

**VICE-PRESIDENT'S REPORT:** Mike Archer was not present.

**TREASURER'S REPORT:** Treasurer Dean Cullison reported on the end of October balances:

- Checking account: Ending balance of \$1,066.29 (including \$788 in 50-50 funds)
- Voucher account: Ending balance of \$7,807.63
- The Treasurer reported 136 current members.

**SECRETARY'S REPORT:** No report by Steve Kufeldt.

**GREENS COMMITTEE REPORT:** Ken Bourne was not present.

**HANDICAP COMMITTEE REPORT:** Marty Smith reported that scores still must be posted until November 30. All members will be deactivated at the end of December and will be reinstated in January after 2024 dues are paid.

**RULES COMMITTEE REPORT:** Dave Schuur reported on a couple of rules...

- Lift, Clean and Place, when allowed, can be done "through the green," but not in hazards. Our club uses a "clean ball rule," which means a ball can be lifted and cleaned and placed within six inches of its original location (except in a hazard). Such rules, when in use, are noted on the information board in the pro shop.
- Interesting rule: A golfer that has back issues can ask someone to mark their ball for them, if desired, but must ask every time that it is done.

**SUNSHINE COMMITTEE REPORT:** Chuck Johnson reported that he sent a card to his wife, Marlene Johnson. He also reported that this year, over 70 people participated in the Monday "Sundowners" league this year.

**OGA COMMITTEE REPORT:** Dave Rushton reported on OGA dues, which will be raised next year by \$6 per person. He also reported on the Oregon Junior Golf Fund, which is supported by the OGA.

**UNFINISHED BUSINESS/NEW BUSINESS:** Fred Bourne made a motion (seconded by Stan Hiller) to increase next year's Men's Club annual dues to \$55 (if paid by December 31st) and \$60 (if paid on or after January 1st). The motion passed unanimously.

**FOR THE GOOD OF THE ORDER:** None.

**50-50 RAFFLE:** A total of \$70 in tickets were sold and Marty Smith won (\$35).

It was duly moved and seconded to ADJOURN the meeting at 10:27AM.
